

# Arrest made in convenience store burglary, investigation continues into two other cases

Miguel Luna, 18, of Eldorado, was arrested Tuesday morning in connection with a "smash and grab" burglary this weekend at the Shell Star Stop convenience store at 202 N. Divide in Eldorado.

Deputy John Conner responded at 1:56 a.m. Saturday morning to a report that a witness had seen a suspect shatter the glass on the front door of the store. The subject reportedly entered the building through the broken door and emerged with a case of beer. At that time, the witness yelled at the suspect, causing him to flee the scene.

Deputy Conner and Chief Deputy George Arispe investigated the incident and a tip soon led them to an local residence where a subject reportedly delivered beer to a party shortly after the time of the break-in.

Luna, an Eldorado High School student, was brought in for questioning and a warrant was obtained for his arrest. He was charged with Burglary of a Building and booked into the Schleicher County Jail where he remained in custody at press time.

Sheriff David Doran said he was pleased that the

burglary could be cleared up so quickly. He praised the work of his officers and credited the quick thinking of a witness who wasn't afraid to get involved.

The Sheriff noted two other cases that are currently under investigation and asked for the public's help in rounding up the culprits. The first involves a series of home burglaries in which wide screen television sets have been stolen. The second involves the theft of several golf carts this past weekend.

The latter incident reportedly occurred early Sunday morning when a number of golf carts were taken without permission from the Eldorado Golf Club. The carts, belonging to a number of club members, were found abandoned at various spots around town. At least one of the carts was severely damaged.

The Sheriff said he believes two or more youths were involved and that they took the carts in order to go joyriding.

Eldorado High School's Mighty Eagle Band was clearly one of the best bands on the field Saturday as it claimed its 26th consecutive Division "1" rating at the Region VII Marching Contest.

The win advances the Eagle Band to the Area Contest in Groesbeck on Saturday where the young musicians continue their drive toward a state title.

Entry to the courtroom will be through the double doors facing the courthouse. Authorities have been busy this week setting up security for the trial which could take over a week. earned Eldorado one of six Division "1" ratings from among the 14 Class A schools in competition. 

# State's unemployment rate inches higher in month of September

AUSTIN - Texas' seasonally adjusted unemployment rate rose to 8.2 percent in September, meaning 44,700 nonagricultural jobs were lost for the month. The state's unemployment rate was 8.0 percent at the end of August.

Tom Pauken, chairman of the state Workforce Commission said, "While unemployment in Texas remains well below the national rate of 9.8 percent, this serious national recession continues to affect us adversely in Texas."

The leisure and hospitality industry took the biggest hit in September, losing 16,900 jobs, followed by professional and business services, down 16,500 jobs. Trade, transportation and utilities lost 13,000 positions.

The unemployment news was somewhat tempered by widely broadcast reports that the economies of Austin-Round Rock, Brownsville-

Harlingen, Dallas-Plano-Irving, El Paso, Lubbock, McAllen-Edinburg-Pharr and San Antonio areas are among the first in the nation to move from recession into recovery, indicating that their economies have grown over the past six months.

**Interest reemerges over Willingham** It's been more than five years since the execution of Cameron Todd Willingham in 2004, but interest in the Corsicana man's 1992 arson/murder conviction and 2004 execution has increased over the past few weeks.

An article published in The New Yorker magazine in August quoting fire scientists raised questions about evidence prosecutors used to demonstrate that Willingham intentionally started a fire in his home that caused the deaths of his three daughters.

Willingham told officials he was innocent but some of his family members and associates say he confessed.

The story took on another dimension when Gov. Rick Perry appointed replacements to fill two seats on the state's nine-member Forensic Science Commission shortly before the commission was to review the Willingham arson investigation.

Williamson County District Attorney John Bradley, one of the two appointees, is the new chair of the commission. He told The Dallas Morning News he would take time as necessary to get acquainted with the commission and its procedures before proceeding with an investigation.

**Storied jurist W.W. Justice dies** Senior U.S. District Judge William Wayne Justice, 89, died Oct. 13 in Austin.

The Athens native, widely regarded as a civil rights champion of minorities and the poor, was appointed to the federal bench by President Lyndon B. Johnson in 1968.

In presiding over many landmark cases, Justice rendered rulings bringing about the desegregation of public schools and housing, and improving prison conditions.

#### Energy agency promotes propane

The Railroad Commission is promoting propane as a desirable alternative fuel in its 2009 "Breathe Easy Tour." The tour, which visited some state agencies and central Texas school districts last week, features a variety of currently available vehicles, and carries the message that "propane is a cleaner, cheaper, Texas-produced

fuel for school buses and other fleet vehicles."

Railroad Commission staff described a new grant proposal that the Commission will submit this month. The proposal seeks to fund additional propane vehicles and upgrade more propane fueling stations. Based on miles

### **Obama deserves** the Nobel Prize

President Barack Obama deserved the Nobel Peace Prize. That's an indictment, not a compliment. Rather than living up to the honor, it should be Obama's mission to show he's thoroughly unworthy of it.

The Nobel Peace Prize comes in three flavors. It is sometimes awarded to statesmen for accomplishments. Think Theodore Roosevelt brokering peace between Russia and Japan



after their 1905 war, or Woodrow Wilson personally negotiating the Treaty of Versailles. It is awarded to human-rights activists resisting repressive regimes. Dissi-

dents Shirin Ebadi (Iran) and Aung San Suu Kyi (Burma) exemplify this standard. Lastly, it is given to "citizens of the world" who seek to throttle American power.


Even Obama's supporters concede he doesn't belong in the first category of diplomatic giants (yet). And even by the self-pitying standards of Michelle Obama, Barack Obama isn't a victim of persecution. That leaves the third category, putting him in league with such highly politicized recent recipients of the prize as Kofi Annan, Jimmy Carter and Mohamed ElBaradei. He should recoil from this woeful company.

Annan won jointly with the U.N. in 2001. The organization was reeling from episodes of deadly fecklessness in Bosnia and Rwanda, where it established a peace of the grave for Bosnia's Muslims and for hundreds of thousands of Tutsis. But so what? The prize had a transparently political point: to bolster the U.N. so President George W. Bush would feel constrained by it when responding to the Sept. 11 attacks. Carter? Yes, he has the Camp David Accords and decades of good works. But when he won in 2002, his main appeal was as a scourge of Bush the warmonger. ElBaradei and his International Atomic Energy Agency jointly won the prize in 2005 on similar grounds. For the five Norwegian parliamentarians who make up the Nobel Committee, Obama is a godsend. They look at him and see a version of themselves -- a self-consciously sophisticated internationalist appalled by America for much of this decade and committed to constraining its power in a net of international organizations. Except Obama happens to be the president of the United States. This is a near miracle, and one the committee couldn't ignore. Given this context, Obama should be insulted, not "humbled," by the prize. If the Nobel Committee is right about Obama, he will force Israel into an unsustainable peace, or throw it overboard; he will reach an accommodation with a nuclear Iran; he will let Afghanistan slide back into chaos (perhaps with the cover of a notional deal with the Taliban); and he will give China and Russia a veto over all significant American international actions in the U.N. Security Council. On the domestic front, he will bring a European-style welfare state to U.S. shores, and watch as the dominance of the dollar fades, another artifact of an era of post-World War II American pre-eminence that he implicitly declares over. This is the promise the Nobel Committee sees in Obama, and why -- if he is to succeed as an American president as opposed to a crowd-pleasing citizen of the world -- he must prove it wrong.



# No cost of living adjustment slated for Social Security in 2010

With consumer prices down over the past year, monthly Social Security and Supplemental Security Income benefits for more than 57 million Americans will not automatically increase in 2010. This will be the first year without an automatic Cost-of-Living Adjustment (COLA) since they went into effect in 1975.

"Social Security is doing its job helping Americans maintain their standard of living." Michael J. Astrue, Commissioner of Social Security said. "Last year when consumer prices spiked, largely as a result of higher gas prices, beneficiaries received a 5.8 percent COLA, the largest increase since 1982."

The Social Security Act provides that Social Security and Supplemental Security Income benefits increase automatically

This year there was no increase in the CPI-W from the third quarter of 2008 to the third quarter of 2009. In addition, because there was no increase in the CPI-W this year, under the law the starting point for determinations regarding a possible 2011 COLA will remain the third quarter of 2008.

Some other changes that would normally take effect in January 2010 based on the increase in average wages also will not take effect, even though average wages did increase. Since there is no COLA, the statute prohibits an increase in the maximum amount of earnings subject to the Social Security tax as well as the retirement earnings test exempt amounts. These amounts will remain unchanged in 2010. The attached fact sheet provides more information on 2010 Social Security changes. Information about Medi-



ranking in his class.


"Wes is a really good football player," Coach Danny Wilhelm said this week.

A tick-borne disease known as equine piroplasmosis has been confirmed on a ranch in South Texas. Additional testing is being conducted to determine the extent of infection. Horses on the ranch are quarantined to their premises, and a thorough disease investigation is underway.

Equine piroplasmosis can affect horses, donkeys, mules or zebras and cause clinical signs common to many diseases, including poor appetite and weight loss. Death losses can occur. Some infected equine animals may exhibit few or no signs of disease. Those animals that survive the acute phase of infection may continue to carry the parasite, which has been identified as Theileria equi (formerly known as Babesia equi), for long periods of time.

"Although equine piroplasmosis is not

considered to be endemic in the U.S., cases have been detected on occasion," said Dr. Bob Hillman, Texas' state veterinarian and head of the Texas Animal Health Commission, the state's livestock and poultry health regulatory agency. "In June, equine piroplasmosis was detected in Missouri, with a related case found in Kansas. In 2008, the infection was detected in Florida. These cases have been closed."

"As many as 15 tick species are capable of carrying and transmitting the blood parasite responsible for causing equine piroplasmosis," Dr. Hillman explained. "At this time, we do not know which species of tick is responsible for transmitting infection on the South Texas ranch. Additional blood and tick samples are being collected and will be submitted for analysis to the National Veterinary Services

Laboratory (NVSL) in Ames, Iowa."

Dr. Hillman said there is no vaccine for equine piroplasmosis, and treatment generally is not effective against this tickborne infection. To avoid spread of the disease, it is important to eliminate contact with ticks and to prevent the transfer of blood from one equine animal to another.

"Equine owners may want to consult with their veterinarians for recommendations on preventing tick infestation," said Dr. Hillman. "If equine animals exhibit signs of illness, a veterinarian should be contacted, so appropriate samples may be collected for laboratory testing. Currently, we have no indication that this tick transmitted disease has occurred at other sites in Texas, but maintaining vigilance for this blood parasite is necessary in determining the extent of this disease situation."



### Texas unemployment rate well below national rate

AUSTIN - The Texas seasonally adjusted unemployment rate rose slightly to 8.2 percent in September, up from 8.0 percent a month ago, and continued to trend well below the U.S. seasonally adjusted unemployment rate of 9.8 percent.

The Texas Civilian Labor Force continued to increase remaining above the mark of 12 million workers for the third consecutive month. Total nonagricultural employment in Texas fell by 44,700 positions in September.

"The Texas job market continued to tighten as most industries experienced job losses in September," said Texas Workforce Commission (TWC)

Chairman Tom Pauken. "While unemployment in Texas remains well below the national rate of 9.8 percent, this serious national recession continues to affect us adversely in Texas."

Other Services, which include automotive, electronic, and commercial repair and maintenance, had the largest over-the-month gain adding 8,800 jobs. A total of 9,400 jobs have been added to the payrolls of Other Services since September 2008. Mining and Logging posted a gain for the first time this year, adding 2,100 jobs. Education and Health Services employment growth remained positive in September with the addition of 2,700 jobs.

Information employment grew by 800 jobs last month.

"The Texas labor force is growing as more people enter the job market, but job seekers are hampered by fewer jobs." said TWC Commissioner Representing Labor Ronny Congleton. "TWC and our workforce boards located around the state remain committed to helping out-ofwork Texans acquire skills and find jobs."

The largest job losses occurred in the Leisure and Hospitality industry which was down 16,900 positions, followed by

Professional and Business Services, down 16,500 jobs. Trade, Transportation and Utilities lost 13,000 positions in September.

"Job gains in Mining and Logging, Education and Health Services, and Other Services were offset by losses in most industries in September," said TWC Commissioner Representing the Public Andres Alcantar. "To help connect workers with available jobs, staff at more than 240 workforce centers across the state is available to provide job-search assistance and other services."



### **AgriLife Extension offers small-acreage landowner series**

SAN ANGELO — The Texas AgriLife Extension Service office in Tom Green County will conduct a series of four seminars for new small-tract landowners during October and November at the Tom Green County 4-H Building.

"The group we are targeting are mainly city dwellers who have purchased rural property for retirement, an alternative source of income or a lifestyle change," said Steve Sturtz, AgriLife Extension agent in Tom Green County. "Most don't have an agricultural background, so once they've bought the property, they wonder what to do with it.'

Sturtz said the series curriculum is based on landowners' requests to his office on those particular topics.

The various seminar sessions are:

 Session I - Resource Inventory: tips for small or new ranchers, rural law, agriculture/wildlife exemption, and financing options, 6:00-9:00 p.m. October 27.

· Session II - Small Acreage Landowner Horticulture: water quality, rainwater harvesting and solar and wind energy, 7:00-9:00 p.m. November 3.

 Session III: Livestock Enterprises for Small Acreage Landowners, livestock options, range weed and brush control and

pesticide applicator requirements, 6:00-9:00 p.m. November 10.

• Session IV: Pasture Management, small crop production, fertilization and weed control in forages and small grains, 6:00-9:00 p.m. November 17.

"To glean the most benefit from the program, participants should plan to attend the entire series," Sturtz said.



### DPS re-aligns services at Driver License offices

Beginning October 29 and 30, citizens who need to re-instate their driver license or get a copy of their driver record must submit their required documentation online or via federal mail. rather than at DPS offices. With this change, DPS employees will be able to focus on reducing wait times in Driver License offices.

Driver license re-instatement is necessary if a driver has had their license suspended or revoked, which may occur due to a number of reasons, such as receiving a DWI conviction, driving without liability insurance or failure to pay child support.

Customers who need to reinstate their licenses or receive their driver record for court dates must go to http://www.texasonline.com, the DPS Web site or conduct their business via the federal mail.

The elimination of these services at Driver License offices will not change the processing time for driver records or driver license re-instatement, which will remain at seven to 10 business days. However, customers should submit their paperwork in a timely fashion and keep a copy of

Those offices, in Garland, Houston (on Gessner) and San Antonio (at Universal City) will no longer conduct these services beginning October 30. The fourth office in Austin (on Denson) will cease providing driver records and reinstating driver licenses on October 29.

#### **Commercial Drivers**

The Austin Denson office will re-open on November 2, serving as a commercial driver license written and practical testing facility only. Commercial driver testing currently administered in Austin (North Lamar, South Congress and Northwest), San Marcos and Georgetown will be conducted at the Austin Denson office.



# **Woman's Club tours Eldorado Fire Department**

The Eldorado Woman's Club met Tuesday, October 13, 2009 at 2:30 p.m. at the Eldorado Fire Department / EMS building.

Theme for the meeting was Fire Department / EMS. There is a drawing in our yearbook showing a red fire truck that looks just like one of the trucks at the station.

President Myrt Williams welcomed everyone to this very special meeting. She introduced us to Fire Chief Jerry Jones. Jerry has been with the fire department for 36 years, ever since 1974. Chief Jones has held the position as chief for 25 years. His son Joey is 1st assistant, Fire Marshall. T.J. Rodriguez is second assistant. Tammy Fish firefighter, and Melissa Rodriguez is the EMS coordinator and is at the fire hall daily. Melissa told us something about the duties of our fire fighters. There are a number of people who are regularly



connected with the department. The department also consists of 2 ambulances as well as the fire trucks. Schleicher county is a volunteer fire fighting group where the volunteers show up only when needed. T.J. told us fires and other emergencies are usually called in to the 911 or 419 emergencies. The 419 calls are handled out of the San Angelo area. A loud alarm rings for quite some time to let everyone know there is a fire or other emergency as most everyone who is a volunteer has a job.

T.J. gave us a very informative talk about the duties of our fire dept. telling us the department has one new ambulance and soon to get another. T.J. also told us all about the new ambulance and why they are built so special and that they are equipped with all that is needed to start treating a person that is being transported to the hospital.

T.J. said a caller needs to tell who ever answers just where the fire is located. Schleicher County is divided into different areas (zones) for identification and numbers are issued and the number is to be posted where the fire fighters can easily see them. The 911 call is picked up locally and the 915 call goes to San Angelo. The caller needs to stay on the phone until the call is clearly identified. T.J. Rodriguez suited up to show all the gear they wear. The suit is very heavy. He said budget money comes from city and county funds and from special fund drives. I have donated yearly for many years to the department. T.J. said the fuel as well as the fire fighting suits are very expensive and every fireman has a full suit.

to the fire. they have training sessions but each fire is individual.

What we learned about our loved fire fighters and their trucks and ambulances today was one of the most interesting and informative programs we have ever had. We all know how very important the volunteer fire fighting department is but it takes a meeting with the people who spoke to us that day to really bring home just how much they do. We give a very big thanks for the superior department we have here in Schleicher County. I personally can never say enough thanks as I once had their help.

T.J. told us the fire trucks have to be very specialized. He took us on a tour of the building and also explained why the fire trucks and ambulances are built to suit the needs of Schleicher County. T.J. said that on Friday, October 30th the fire department would be having a fish fry from 5:00 p.m. until they run out of food. The proceeds will help to pay for a new fire truck and equipment. He said help financially comes from several sources. Three of these are the fire department, fish fry, the Salvation Army and individual contributions. I have tried every year to send a contribution. Currently the fire department has 4 grass trucks with solid sides plus the 2 new ambulances. I entered one of the ambulances and was awed with what was inside. We need to say a big thanks to those who are responsible, Schleicher County folks have this up to date equipment. Thank you Jerry, T.J., Tammy and Melissa for our great meeting. After our very special meeting president Myrt Williams continued with our regular

meeting.
