

County Court Adopts Rules For Memorial Building Use

A new set of rules for the use of the Memorial Building has been adopted by the county Commissioners Court during their meeting Monday. The rules were adopted because of repeated vandalism in the building, especially in the restrooms.

The rules are as follows:

1. Leave the building as clean as you found it with all trash carried out to the trash barrels. No food particles to be left in the building overnight.
2. Respect all facilities as you would your own. No tacks or nails on walls or floors. No tacks, staples, nails, scotch tape or anything attached to ceiling. Masking tape and scotch tape permitted on walls and floors, but not on ceiling. All tacks, staples and tape attached to wood scallops on upper wall must be removed after the banquet.
3. Protect table tops with newspaper when working with paint, glue, glitter, etc. Keep folding tables folded when not in use at a

meeting or any function. Do not sit on any tables at any time.

4. Fluorescent fixtures are not to be removed or tampered with. Spotlights may be changed for color schemes.

5. Adult couple must sponsor all parties. All activities (including decorating) sponsored by responsible adults.

6. No vehicles are to drive on yard at any time.

7. All restrooms and plumbing fixtures to be checked before leaving the Building. Close and lock all doors including back door.

8. A \$25 deposit is required for all parties and dances. The building and grounds must be left clean of all trash. If building and grounds are left clean, deposit will be returned.

9. The building is to be used by county residents only. No individual is to use the facilities for profitable purposes.

Anyone sponsoring activities except for regular club meetings is required to fill out a form at the

county judge's office and sign.

The form states that the person or persons booking the building are assuming responsibility for the building and its contents and will be held responsible for any expense in replacing anything damaged or broken.

Also during their meeting Monday, commissioners agreed to advertise for bids on repairs at the airport which needs a new seal coat. The action was taken after commissioners agreed that the airport would be ruined permanently if the repairs were not done shortly.

Commissioners also discussed a problem at the Jimmy Doyle property where people were dumping trash instead of dumping it at the city dump. The court plans to contact county health officer Dr. J.B. Brame about the problem.

The meeting lasted only three hours.

Sheriff And Tax Departments Becoming More Complicated

Everything these days is getting more and more complicated, with more paper work, more red tape and more people to deal with. The same

is true with being the county tax assessor-collector, especially when you are the sheriff, also.

According to state law, once a county reaches the 10,000 mark in population, the two offices are automatically separated. However, if the population is below that mark, the voters have the option to separate the two.

Schleicher County is one among a handful of smaller counties that still has the two combined. However, on September 11, the voters will be faced with that decision.

The man who has held both offices for years, Orval Edmiston, is personally recommending the separation of the two offices, for three reasons.

First of all, the two offices are not alike in nature, with the tax assessor-collector assessing property and collecting taxes and the sheriff handling law enforcement. This is a frequent source of conflicts.

Secondly, there will be a complete change in the state's tax structure within the next two years, because of House Bill 1060 and Senate Bill 621. Part of these changes will be implemented in 1980 and the rest in 1981, creating more paper work in the tax department.

The third reason is because both

offices now need a full-time person, because of increased traffic in both. The tax office is now not only assessing and collecting personal taxes, but is also collecting car registration, voter registration and boat registration, all three of which are full-time, around-the-year jobs. Also, Edmiston feels a full-time tax

assessor-collector could do a better and more efficient job, collecting a larger number of money for the county. With the new growth in population, business in the sheriff's department has also increased, keeping not only the sheriff but also two deputies busy.

Edmiston is urging the separation of the offices primarily for efficiency in the two jobs, and says he will be happy to answer any questions about the election and if the townspeople want to, he will hold a town meeting on the subject to explain the details.

City Has Problems Collecting For Utilities

Everyone needs and uses utilities and appreciates them, even if we don't like what they cost. But even though they are the mainstay of our lives and our economy, the City of Eldorado has been having quite a bit of trouble collecting for utilities it provides residents in the city limits.

Carolyn Mayo, city secretary, explained that residents are billed from the 15th of the month to the 15th and bills go out by the first. Residents have until the 20th to pay their bills. If they don't, delinquent notices are sent out. But by then, it is time to send out next month's bills, making people two months behind.

Mrs. Mayo said the city has been disconnecting utilities to those who are frequently on the delinquent list first and then start with the rest.

She said the city office has sent out 94 delinquent notices for last month, just a sample of the trouble her office has been having with bill collections.

Residents are asked to put up a \$20 deposit on their water and a \$40 deposit on their gas. If they cut off, a five dollar reconnection fee is charged.

Therefore, even if utility bills seem high, it is probably well worth it in the long run to pay for those essential utilities on time.

Art Club Is Being Formed


The Booster Club meets at 7 p.m. each Monday in the band hall classroom.



Oil Production Helping County

The sale of crude oil and natural gas from Schleicher County wells in 1978 boosted the county economy and accounted for \$28.9-million of the \$17.1-billion value placed on Texas production last year, according to Texas Mid-Continent Oil & Gas Association.

In a report on the economic impact of oil and gas industry operations in the top producing counties of Texas, the Dallas-based Association said the county ranked 112th among the 202 counties having marketed production valued at \$100,000 or more, not

including the sale of natural gas liquids. The county's wells produced 947,000 barrels of crude oil, valued at \$8.8-million, and 19.9-million as their share of the output, the association said.

"Considering the shortfall in total U.S. petroleum production relative to our nation's energy needs, production from every Texas county is more vitally important today than ever before," said the association's president, H.B. (Hank) Harkins of Alice, an independent producer and drilling contractor.

In addition to paying local, county, and state property taxes, producers in the county also supported state government through production tax payments estimated at \$1.9-million, according to the association. Crude oil taxes amounted to \$405,000, while natural gas levies totalled \$1.5-million.

Based on Texas Employment Commission figures, some 169 oil and gas industry employees in the county received wages of about \$2.9-million in 1978.

In the search for new petroleum reserves in the county, oil and gas operators spent a reported \$14.6-million in the drilling of 87 wells, including 25 wildcat, or exploratory wells. This effort resulted in the completion of 16 oil wells and 46 gas wells, although some \$3-million was lost in the drilling of 25 dry holes.

Petroleum processing also contributed to the county economy, with four natural gasoline plants, having a total daily capacity of 111.5 million cubic feet of natural gas, in operation.

Sonora Test Begins Soon

Agricultural scientists at Sonora will begin next month performance-testing finewool rams and Angora bucks.

The data in the annual test, said supervisor Dr. Maurice Shelton, will be gathered at the Texas A&M University Agricultural Research Station at Sonora. For the first time the scientists will performance-test Angoras.

The first phase of the test will begin September 12 with Rambouillet and other finewool rams and the Angora bucks.

The Sonora program, initiated by producers in 1948, is aimed at improving the sheep and goat industries through the selection of animals whose performance and progeny have been tested.

Information about the test as well as entry forms are available at the San Angelo Center (telephone 653-4576) and at Sonora (387-3168 or 387-3237).

The finewool rams and Angoras are due at the Sonora Station by September 11, and the blackface rams by October 9.

Family, Food, 4-H

How safe are mayonnaise and salad dressing?

With family groups taking part in summer camps, picnics and other outings, many homemakers are concerned about the general safety of mayonnaise or salad dressing in sandwiches and salads.

Mayonnaise is of special interest because salads made with that ingredient have been implicated in food poisoning outbreaks in the past.

Commercially prepared mayonnaise and salad dressing are safer than most people believe.

These products will not support the growth of pathogenic bacteria. In fact they are resistant to most microbial spoilage. Consequently, they should be of little public health concern.

Some Misconceptions

The misconceptions about mayonnaise may result from reported food poisoning cases in Europe or from homemade mayonnaise.

In these cases, the acidity of the product has not been as high as in similar products in the United States.

While the exact origin of the word "mayonnaise" is obscure, it may stem from the French word "moyonnaise" with "moyeu" meaning egg yolks.

Mayonnaise is-by government identity standards a semi-solid emulsion of edible vegetable oil, egg yolk or whole egg, vinegar or lemon juice, usually with salt and condiments.

Salad dressing, a more recent derivative of mayonnaise, was first prepared in the early 1930s as a low-cost substitute for it.

It is essentially a cooked starch dressing mixed with mayonnaise.

Key Ingredients

Ingredients such as acetic (vinegar) and/or citric (lemon or lime) acid are responsible for the acidic nature of mayonnaise and salad dressing.

These products lower the unit of measure (ph) that indicates the acidity or alkalinity of a product to 3.0 or 4.0, with 7.0 considered neutral for most food products.

Since common spoilage and food poisoning bacteria prefer the neutral level of most foods, the lower unit of measure in salad dressing and mayonnaise will reduce or inhibit the growth of these bacteria.

This is obvious in that both are shelf stable in the food market or home refrigerator after opening.

Refrigerate After Opening

It's necessary to refrigerate mayonnaise after opening to combat contamination from household utensils previously used on raw food.

Salads in which the products are normally used also contain many ingredients that are subject to contamination, such as chopped meat products, eggs, potatoes, raw vegetables and spices.

Additionally, other culprits may be unclean hands of food handlers, utensils and chopping boards.

Safety Steps

Consumers should consider these safety steps suggested by the Food Quality and Safety Committee:

1. Avoid cross-contamination between raw and cooked products during salad preparation and properly wash cutting boards, utensils and raw vegetables before use.
2. Add mayonnaise or salad dressing to a salad dish as soon as possible; then insure protection from contamination by covering the dish and refrigerate.

Cleaning Marble Will Keep It Pretty

Keep marble beautiful by keeping it clean, says Sue Young, a housing and home furnishings specialist with the Texas Agricultural Extension Service, The Texas A&M University System.

Just through use in the home, marble may become dull in appearance and may lose some of its brightness and luster, but this situation is easily remedied.

Cleaning

Wash marble with clean cloths and fresh luke-warm water.

Twice a year, wash it with a mild detergent as an additional safeguard--this will remove any residue dirt which might become ingrained.

Scratches

Marble will, just through use, lose some of its polish and acquire an occasional scratch.

Buff away fine scratches and repolish the entire surface whenever necessary with putty powder applied on a damp cloth. Polish by hand or with an

electric polisher.

Stain Removal

Most stains will require the application of a poultice made of white blotting paper, white paper napkins, white cleansing tissue or commercial whiting.

Soak the poultice in the required solution and keep it from drying out while it is one the marble. Cover the poultice with a piece of glass or a sheet of plastic (a vegetable bag will do) to keep moisture from evaporating while the stain is being drawn out of the marble.

This process may take from one to 48 hours, depending on how old the stain is.

Once the stain is removed, the area may require polishing with putty powder applied on a damp cloth.

Keep the putty powder while polishing, and rub the area persistently rather vigorously for about a minute. Remove the putty powder with a dampened cloth, folding and refolding the cloth to fresh dampen areas until the marble is clean and the surface shines.

Organic Stains

Organic stains are caused by such substances as tea, coffee, wet bark, flowers and leached colors from paper or textile. These usually take the shape of the staining object and will often
