

Texas Cattle Raisers request Tax drop

Texas and Southwestern Cattle Raisers Association has requested the U.S. Treasury Department to drop a tax regulation proposal that would impose burdensome and unnecessary record-keeping requirements on owners and operators of farm vehicles for business.

The proposed regulation, which went into effect Jan. 1, 1985, would require farmers and ranchers to keep continuous records or logs on the use of essentially all farm vehicles, including automobiles, pickup trucks and other farm trucks. The log or journal must include the date, operator, purpose and mileage of all business uses of the vehicle. The IRS proposal - brought about by passafe of the Tax Reduction Act of 1984 - would be used to substantiate deductions for both personal and business purposes

Further, the log is impractical given the frequency that cattlemen use their vehicles in their operations. Therefore Texas cattlemen oppose the record-keeping regulations as onerous and burdensome to all businesses, he said

TSCRA has also called on Texas Congressmen, all farmers and ranchers as well as small businesses to support legislation that may be introduced this week by Senators Llovd Bentsen, D-TX: David Boren, D-OK, and others that would repeal the record-keeping requirements for all business vehicles

TSCRA told Texas Congressmen that cattlemen use their business vehicles extensively on a daily basis to haul feed and livestock, transport equipment and farm laborers. These business uses often include numerous trips by different operators to and from farms and separate pas tures as well as to town for parts and repairs. The extensive, proposed record-keeping regulations would go far beyond present IRS requirements for substantiating business behicle expenses and would now require records on virtually every mi traveled. This extra burden is u necessary and hurts food and fiber producers while offering little significant benefit to IRS

A dense infestation of weeds will significantly reduce production of desirable forage on rangeland, notes Welch. In addition to loss in forage production, some weedy plants are poisonous and cause considerable livestock losses.

found throughout the state, some of the most serious problems occur in the Trans-Pecos region of Texas. Poisonous plants are more abundant this year because of the weather drought followed by rains.

Most weeds can be controlled with herbicides, a practice that will produce substantial returns, Welch points out. Results from research and weed control result demonstrations have shown that grass production will increase substantially when unwanted broadleaf plants are controlled. In most cases, a pound of grass has been produced for every pound of weeds controlled. Also, control of poisonous plants will reduce livestock losses.

If a weed problem is identified early in the season, herbicides can be applied when control will be most efficent and economical. Thus, ranchers should check their ranges

Herbicide mixtures are available for plants that are more difficult to control, including many poisonous plants. These mixtures are available annuals already have germinated as the commercial formulations Weedmaster (1:3 mixture of dicamba and 2,4-D) and Grazon PtD (1:4 mixture of picloram and 2,4-D). 2,4-D If ranchers are concerned about having weed seeds as food for wildlife, they can use herbicides Although poisonous plants are with this objective in mind. An early application of 2,4-D will control early germinating annuals such as annual broomweed but will allow later germinating croton and snow-on-the-mountain to survive. Also, ranchers may want to apply herbicides so as to leave untreated strips, adds Welch.



RRC approves gas rate reduction

The Railroad Commission recently approved natural gas contract changes between Delhi Gas Pipeline Corp. and Lone Star Gas Co. which will reduce rates to Lone Star and its customers by some \$23 million annually. The new rates are effective as of January 1

Customers of Lone Star will benefit from lower gas costs under the contract changes since the company must pass the reduced costs directly to customers using previously approved automatic adustment clauses.

wo separate rate reductions are

included in the contract changes. First, the rate charged by Delhi for the gas itself will be reduced from approximately \$6.36 per MMBtu to \$3.30 per MMBtu. (There are approximately one million Btus of energy in a thousand cubic feet of natural gas.) Annual savings to Lone Star from this change are estimated at \$23,059,895.

Second, Lone Star agreed not to charge Delhi any transportation fees for gas transported under three agreements between the companies. Estimated annual savings to Delhi

are \$292.000

Motorists/Service Station Dealers Can Be Assessed Fine For Misfueling

who pump leaded gasoline in an automobile designed for unleaded products have two problems in Texas: They are damaging their cars and violating the law.

Motorists guilty of this infraction may be assessed a \$1,000 fine under a ruling by the Texas Air Control Board. Penalties of up to \$10,000 a day can be levied by the Environmental Protection Agency against the owner of the station where the violation occurs.

The practice, called "misfueling," has been illegal under federal law for a number of years, according to Homer McGinnis, president of the Texas Oil Marketers Association and Pride of Texas Distributing Company in Arlington. The Environmental Protection Agency, concerned about a nationwide increase in misfueling, is now beginning to put teeth into that old law

"A gasoline seller would have to be crazy to risk a \$10,000 fine to make a \$10 sale of regular McGinnis notes. gas." "Therefore, many people who have been filling their cars with leaded gasoline shouldn't be surprised if the dealer now comes out to the pump and says 'no.' "

As a result of EPA enforcement of the law and the new TACB rule, service station owners are schooling their employees on the types of automobiles that require unleaded gasoline and instructing them not to pump or allow the customer to pump leaded gasoline into these vehicles. McGinnis notes that vehicles built before 1975 can legally use leaded gasoline; most vehicles built after 1975 require unleaded, and all vehicles built after 1979 require unleaded fuel.

Unleaded gasoline was introduced in the early 1970s when federal regulations reguired catalytic converters to be

gasoline will clog the converters, which were designed to clean up exhaust emissions and reduce smog in the air. There have also been conten-

tions that lead is a health threat when released in the atmosphere as a part of automobile exhaust. EPA has already reduced the allowable levels of lead manufacturers can add to gasoline, and in 1984 the agen-/ cy proposed plans to cut the allowable lead content back drastically, to less than 10 percent of current levels by 1986.

"EPA is serious about reducing lead emissions," McGinnis says. They can't ban it altogether yet, because older vehicles actually require some lead in the gas they burn. But they're going to do everything they can to keep the people who shouldn't be using it from doing so. They've said that they might require marketers to sell leaded gas at full-serve pumps only, or even require them to raise the price higher than unleaded."

Some large cities, such as Chicago, are now trying to totally ban leaded gasoline. Significant health problems among children have surfaced there; the problems are more frequent and more serious in housing areas adjacent to busy freeways and lessen proportionately in areas farther away from the freeways.

"Not only does unnecessary use of leaded gasoline create environmental problems as a result of increased pollution," McGinnis says, "but it costs the misfueler more money in the long run than is actually saved. An average driver might save \$25 to \$50 a year by filling up at the leaded pump. But it will cost much more than that in spark plugs, tune-ups and engine wear. Also, misfueling can void most new car warranties," McGinnis adds. Texas became the first state in

AUSTIN, Texas - Motorists installed on new cars. Lead in the nation to make the consumer liable for misfueling. The agency implemented a rule that prohibits the owner of a vehicle from making inoperable any system or device used to control emissions from a motor vehicle.

TACB rules make it illegal to remove the part in an automobile tank fill pipe that prevents an unleaded nozzle from entering it, to disconnect the catalytic converter, to sell an automobile on which an emission system is not properly operating, to pump leaded product into a car designed for unleaded or to sell a device that will circumvent emission control devices. Violators are subject to a penalty of up to \$1,000. The TACB rule is statewide, but warning signs are only required in Harris County.

The agency has also developed an annual automobile inspection and maintenance program in Harris County that requires cars to have emission checks to determine if leaded product has been used in unleaded vehicles. These rules were necessary to help Harris County and the state reduce pollution levels established by the FPA

"TACB is to be commended for its efforts in the misfueling area," McGinnis notes. "The rules should result in the reduction of emission of hydrocarbons and other pollutants because of the large number of emissions control systems operating properly.

The market value of property in Texas school districts totaled \$745.5 billion in 1983, according to a study just completed by the State Property Tax Board (SPTB)

Ron Patterson, SPTB's executive directore, said property values have increased by 21 percent since 1981, the date of the last study.

The study estimates that \$636.5 billion of the total value was actually taxable by the state's 1,070 school districts. Taxable value is calculated by deducting from market value the value of state-mandated homestead and veterans' exemption and value lost because of productivity appraisal for rural acreage, the school tax ceiling for over-65 homeowners, and the portion of appraised values unavailable for taxation within reinvestment zones.

Patterson explained that the study of the local school district property tax base is required by the Texas Education Code. "A school district's taxable value estimate is one of several factors used by the Texas Education Agency to determine the district's share of state education aid for the 1984-85 school year," said Patterson.

SPTB's report shows a total market value for each school district a breakdown of the total by property category and the deductions made in calculating the district's taxable value

Statewide, the total market value of Texas school districts increased by \$129.6 billion, or 21 percent, over the value determined in SPTB's 1981 study. Values on the school district's own tax rolls totaled \$590.3 billion

Overall, the study estimates that about 15 percent of 1983 market

(AT&T Communications) gives notice to all of its Texas customers that a new procedure for long distance billing was made effective on an interim basis on August 6, 1984 in Docket No. 5800.

The procedure referred to is "Rate Period Specific Billing" and it applies to all message telephone service (AT&T Long Distance calls) including non-REACH OUT Texas calls within the State of Texas. This new procedure effects all AT&T Long Distance customers. All intraLATA long distance calls and all interstate long distance calls are currently billed using this procedure.

Under this procedure, customers are billed a specific charge for long distance calls according to the rate or rates in effect throughout the time of each call. If a call begins in one rate period and extends into a different rate period, the customer will be charged whatever rate is in effect for each portion of the call.


For example, if a customer places a call at 4:58 p.m. on a weekday and talks for ten minutes, the first two minutes of the call would be charged at the full weekday rate which extends from 8:00 a.m. to 5:00 p.m. The remaining eight minutes of the call would be billed at the evening rate which extends from 5:00 p.m. to 11:00 p.m. and includes a 25% discount. If Rate Period Specific Billing were not in effect, the entire call would have been billed at the higher day rate. Calls which extend from the evening rate period (25% discount) to the night and weekend rate period (40% discount) or from the night and weekend rate period (40% discount) to the day rate period (no discount) would also be billed according to the actual minutes of use during each rate period.

AT&T Communications anticipates a minimal increase of approximately .02% in its revenues or approximately \$250,000 annually

A complete copy of the "Rate Period Specific Billing" tariff is on file with the Texas Public Utility Commission.




