# Bob Lester wins honors

Transwestern Pipeline Company shift foreman Bob Lester manages to stop by Eldorado City Hall for at least 20 minutes every day. A social visit? No, he's mayor of this small West Texas community, the home of approximately 2,100 residents.

"If you live in a small town, the chances are excellent you'll get involved in community service," stated Bob.

Lester was recently named as one of Enron Corporation's 10 outstanding employees for 1986. The winners were selected among hundreds of employees on the basis of community involvement.

Lester's own life bears out this statement, having been active as a community volunteer since 1972. His activities currently run the

gamut from serving as town mayor and treasurer for his church to assisting his wife with 4-H program activities and serving on the Schleicher County Rodeo Association which sponsors little league baseball and an annual rodeo. He's also a member of the Eldorado Progress Council.

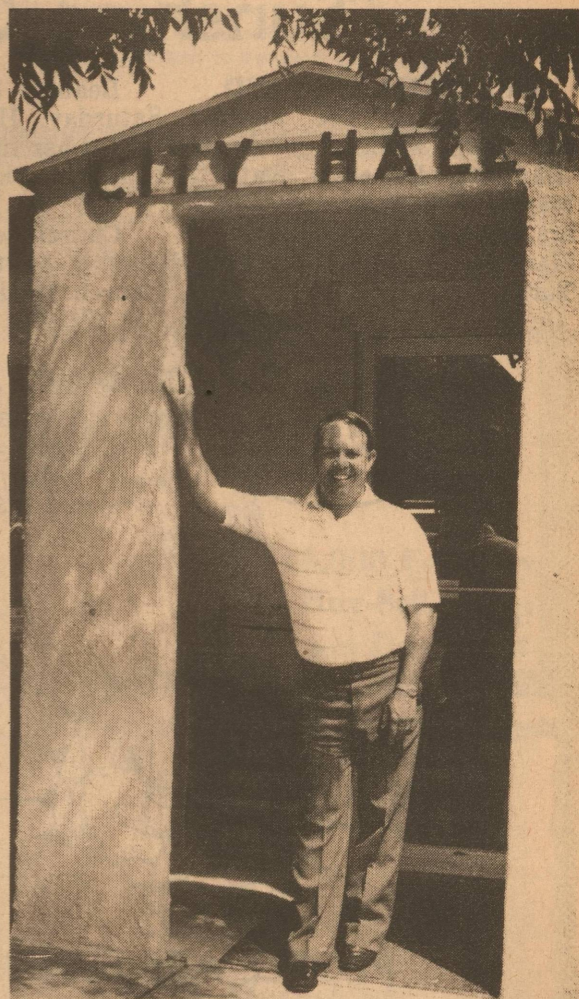
Prior to these diverse activities, he served on the city council from 1980-82, was a municipal court judge from 1984-85, and acted as an emergency care attendant with the town's ambulance service from 1972-1983.

"I wish I could still do it all, but being mayor takes up most of my volunteer time now," Bob stated. He's held that post since 1982 and his record of achievements includes successfully

securing grant funds to help construct a new sewer plant, to serve a section of town that had never had sewer service before.

Each outstanding employee received a commemorative plaque and \$1,000 to donate to the community organizations of their choice. Bob had no trouble choosing an organization. "We didn't have anything in Eldorado that fit the criteria, but some of our local people have received physical therapy at the West Texas Rehabilitation Center in San Angelo, so I knew they did good work."

"I've lived here since I was four years old, and I do all of this for the satisfaction of being able to give back to the community a little of what it has given to me and my family."

## Schleicher invasion set

Schleicher County is one of 16 Central and West Texas counties which will be invaded early next year when thousands of Fort Hood soldiers from a number of military units conduct maneuvers in the area.

Labeled "Roadrunner 87", the military exercise will begin January 23 and close January 30, according to the Fort Hood Public Information Office.

More than 4,000 soldiers and 500 vehicles will participate in the massive exercise, designed to replicate actual distances for communications, movement and supply activities that can be expected during an actual combat situation.

U.S. Army personnel representing Fort Hood's III Corps are currently coordinating with private land owners and governmental agencies for assistance and permission to use their land.

Counties involved in the military exercise, in addition to Schleicher, include Bell, Lampasas, Burnet, Hamilton, Llano, San Saba, Mills, Brown, Coleman, McCulloch, Mason, Menard, Concho, Runnels and Tom Green.

"Various numbers of men and field vehicles will be scattered around the rural areas of each county throughout the exercise," said Capt. Michael Monnett. "Some communities may see

## Newspaper sale told

In a joint announcement Friday, Debbie Bratcher of Bowie and Terry B. Neill of Eldorado announced the sale of the Schleicher County Leader-Success by Mrs. Bratcher to Neill.

Neill, a veteran newsman at 34, has been operating the paper for the past three and one-half months under a lease-purchase agreement with Ms. Bratcher, wife of former publisher the late Finis Bratcher.

The Leader-Success will be operated by t.b. Publishing Company, of which Neill is the sole owner. Ms. Bratcher has returned to her native Bowie, where she is employed at city hall.

"I would like to thank everyone in Eldorado for their kindness and consideration. We miss everyone, but think that the sale of the newspaper has been and will be in the best

interest of Schleicher County. Thanks to all," Ms. Bratcher said Friday.

Neill, a native of Fort Stockton, began his newspaper career at the Fort Stockton Pioneer at 16 and purchased his first newspaper at 21. He has owned newspapers in Stanton, Van Horn and Eldorado, owning the Leader in 1978 for one year.

His Stanton newspaper racked up more awards in a six-year span, both regionally and state-wide, than any other newspaper of its size, including three West Texas Press Association general excellence awards.

Neill is also the youngest president in the history of the West Texas Press Association, the world's largest regional press association and is a former vice-president of Texas Press

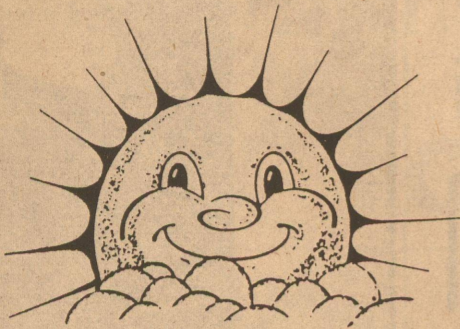

## Fruit bars low-calorie

Frozen fruit bars have become the latest dieter's delight. But are they actually a "low-calorie" alternative to regular frozen fruit-flavored bars?

According to a Texas A&M University Agricultural Extension Service nutritionist, the answer is "No".

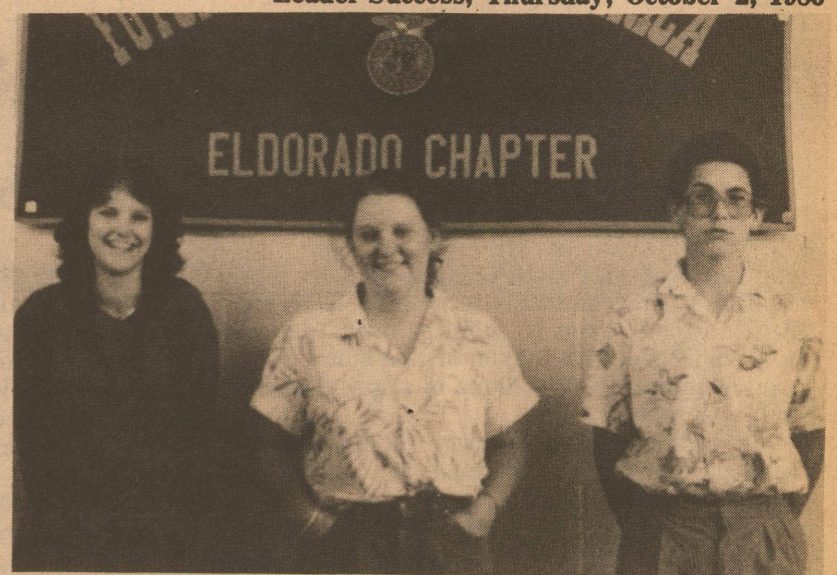
Dr. Alice Hunt points out that national brand frozen fruit bars contain from 50-80 calories per 2 1/2 ounce bar. The regular frozen fruit confections contain about 60 calories per 2 1/2 ounce bar.

"Frozen fruit bars contain up to 30 percent fruit juice, which improves their nutritional content over frozen confections," she says. "But they are also no lower in calories than real fruit."

The frozen fruit bars, like frozen confections, also contain added sugars or corn-sweeteners.

If calorie-conscious people use frozen fruit bars to replace higher calorie snacks, such as ice cream bars, they could be cutting back on their total calories, Hunt notes.

"For someone on a serious weight-loss diet, however, fresh fruit will still provide more nutrients and fiber for fewer calories than frozen fruit bars," says the nutritionist.

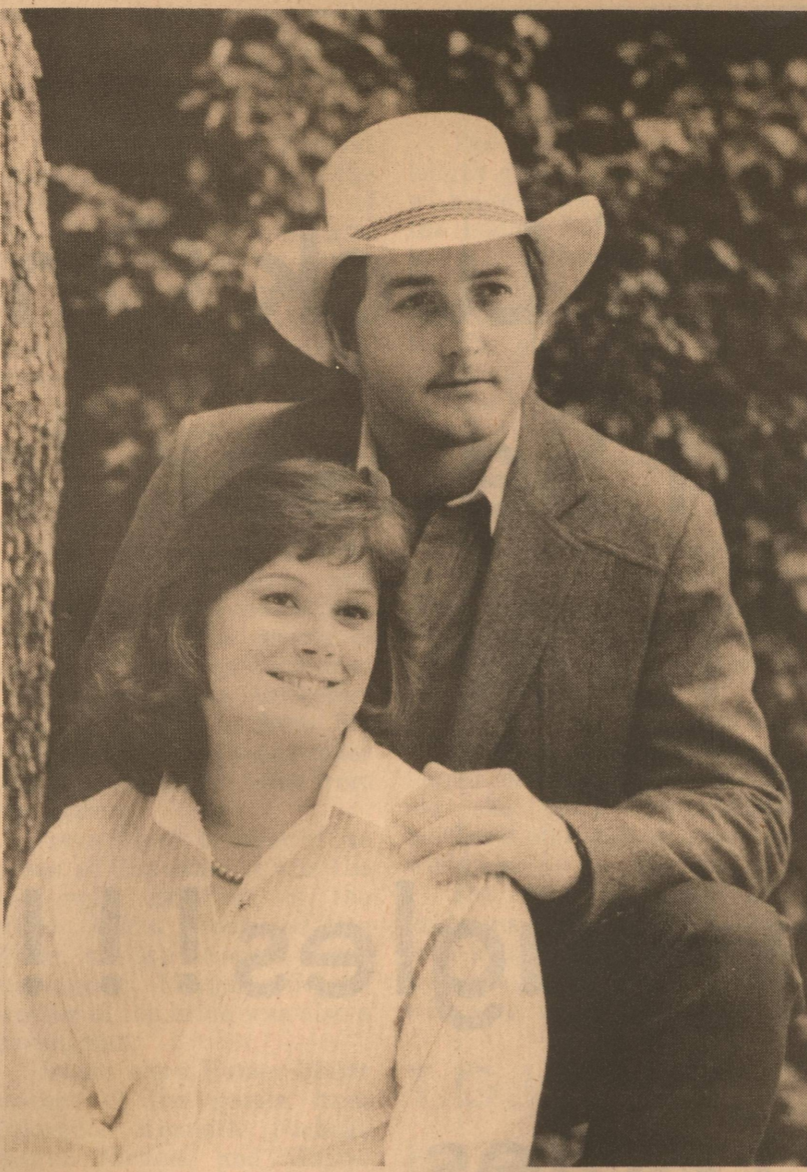



She died in Kerrville hospital on September 17 after a lengthy illness. She was born October 1, 1898.

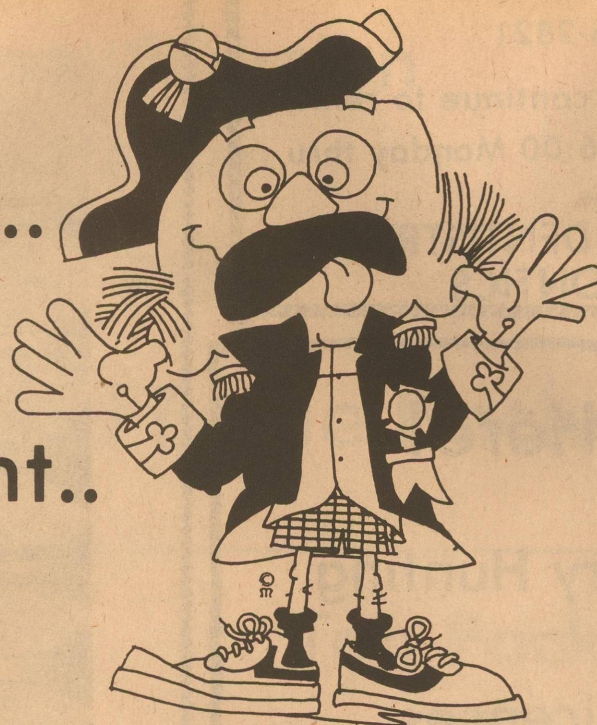
