Campfire church services at different environments, he was a professional athlete and during high school he was active in wrestling and football, but he was considered too small to play pro ball. Paul was disappointed, but this didn't stop him. At age 23 he obtained his PRCA card. His goal was to become 1978 Rookie of the Year in steer wrestling. Like most cowboys, Paul believed that to be a cowboy and to be a winner, he had to drink and party. But as Paul drank and partied, he watched his goal slip away. The more he drank the more depressed he got, and the less he won. His winnings totaled \$1200 and he was broke. His chances for becoming Steer Wrestler of the Year looked dim, and so did making a living at rodeo. Paul decided to go to work for a contractor. By August he had saved up enough to enter three or four rodeos. He didn't win much but he did place.

A change took place in Paul's life, a heavenly change: "I became a born again Christian! A friend of mine, Jim Bode Scott, lead me to the Lord. He had been saved about six months. I knew he had changed, but I didn't know why or how. He just

seemed so satisfied."

After becoming a Christian everything didn't turn to roses, but Paul turned to Jesus and depended on Him no matter how bad or how depressed he got. For the first time the world didn't seem like it was against him, now he had hope and someone to lean

Paul started reading the Bible and hoped to finish reading the New Testament before the fall run was over. This helped because he really wanted to make being a Christian the center of his life and not get off into the things of the world. "I knew my relationship to Christ was what I had been missing and needed to make my life full."

While working the labor list

at the '78 Finals, Paul met Larry Smith, a rodeo circuit preacher. As they got to talking, Larry asked if Paul was saved and Paul noticed that Larry was always happy even after working 10 performances. Paul could hardly believe that there was someone else on the rodeo trail that knew the Lord. Larry told Paul all about the Cowboy Chapter, FCA and about Glenn Smith. TO BOOST GAS PRESSURE IN WESTERN ELDORADO

City okays gas vessel idea

western and northwestern Eldorado suffer from low gas pressure. Meeting in regular monthly session Tuesday night the Eldorado City Council voted to take steps that will hopefully correct that problem.

Neal Howard, a consultant for Basic Controls of Odessa, met with the council at the request of superintendent Clay Long. Howard suggested the installation of two volume chamber vessels.

"The vessels would store

periods some gas customers in times when it is needed in the west and northwest sections of the city, and would be the cheapest way to solve the problem," Howard told the

Members of the council voted unanimously to get price estimates on installing the two vessels and each councilman noted the importance of getting gas to gas customers when it is needed.

"It is our responsibility to make sure our gas customers

> The volume chambers will be hooked into the city's existing gas lines, above ground. Long was also instructed to find possible sites for the chambers.

> The council met with Ray Lewis Ballew, local appraisal district chief. Ballew told the council that several steps have been taken in his office to keep a recurrence of last month's breakin and theft at his office from

happening again.

In the theft, \$1,335.90 in city and school funds were stolen after thieves gained entry to the appraisal office through the front door. The money represented tax receipts from the city, \$776.87; and school district, \$494.09. Petty cash funds in the amount of

\$65 were also taken. Ballew told the council that the district's usual deposit schedule was not followed the week of the break-in because of computer installation the week before and a heavy workload that week.

Ballew outlined several changes in operating procedures which the district appraisal board has decided on, including more lights, locks, etc.

Ballew, active in the Schleicher County Emergency Services also presented the EMS report for 1987. A total of 116 runs were reported, with 46 terminating at the local hospital, and 54 at San Angelo hospitals.

"I made my settlement on section --- in Schleicher Co, Tx, in good faith for a good home in 1902. I went upon said land in a heavy, two horse, long buggy.

"I took with me three or four quilts, and a pair of blankets, skillets, frying pans and coffee pot, provisions consisting of flour, bacon, beans, potatoes, and tarp, or heavy wagon sheet.

"I cut some forks with which to stretch my tent, put up the forks and connected them with a ridge pole. I stretched my wagon sheet over said ridge pole, and fastened the ends of said sheet to the fround on each side by

"Just got back from a cuttin" horse trainer who had him 120 days..." (The trainer used him to pull the manure spreader.)


"That big ankle don't bother him none..." (As long as you remember to give him daily doses of bute.)

Now the message is getting tougher: Ibero-America will not stand by the United States in this

MEDICATIONS Common acne medications will do more than clear up blemishes; they'll also remove color from clothes and other textiles. Acne preparations containing benzoyl peroxide will remove color from fabrics, bedspreads, towels, sweaters or carpets. It causes change accelerated by moisture and heat. Spot removal and dry celaning will not remove discoloration from benzoyl peroxide on clothing, although some fabrics can be dyed a darker color to cover it up. Teenagers should know that acne treatments have the potential for permanently spotting their clothes, so they can try to avoid contact between the medication and the fabrics.



From June 1st until the Cow Palace in November he had won almost \$18,000 and ended up in the 15th hole at the NFR. "It was a miracle to me that I could win that much money in that amount of time. 



"I ate my dinner there and then put my bedding and provisions in the tent I had made. I put my provisions in a towsack and tied it up so that nothing could get them, and hung it up in my

"I then started back to Eldorado to file my application, got there about two or three o'clock in the morning of 1902, and filed my application with the county clerk of Schleicher County.

After I filed my application, I went back to my settlement, and stayed there two or three days, and went to San Angelo, and bought me a wall tent and more provisions. I went right back to my home on section ---, and stretched my tent, and have been living there ever since. I built a wire fence around my tent for a yard fence and have drilled a well on my land. It is not completed.

"About a week ago, the well was about 120 ft.; have timber at my place to build a house 16 feet square; have had timber about a Continued from Page 1.

month. I am living there now. Was gone from my place about six weeks at one time, carried a bunch of horses to San Angelo and shipped them to East Tx. and sold them.

"I am a single man; was over 21 yrs. old when I filed on the land and have never bought any school or asylum lands. The additional lands filed on by me are ajoining lands to my home section, and with in a radius of five miles of my home section."



Tuesday I went ahead and voted in the runoff election for the State Board of Education, District One position. To be honest with you, I don't know if there is a Republican candidate, although I think there is. Our only hope of salvation is that this Board has very little power and can do very little damage to the State's educational system.

I hear over and over complaints about people who are able to buy elections in these statewide elections. It appears to me that the winner of these School Board positions will be selected by chance. Gambling is supposed to be against the law in Texas. It is, except in our State's Educational system.!
