## Arrests clear up two dozen burglaries

*Suspects charged with burglaries of 3 homes, 3 businesses and 18 autos*

A lengthy investigation into a series of burglaries resulted in the arrests of three individuals recently and cleared up a total of twenty-four home and auto burglaries.

James Michael Lowe, 19, of Eldorado and Sean Michael Gonzalez, 20, of San Angelo each face three charges of burglary of a habitation, three charges of burglary of a building and thirteen charges of burglary of a vehicle. Bonds totaling \$280,000 were set for each of the men. At press time, Lowe and Gonzalez remain in the Schleicher County Jail.

A third suspect, Duwayne Lloyd Gonzalez, 17, also of San Angelo, and brother of suspect Sean Michael Gonzalez, was charged with misdemeanor theft. He was released on a \$1,000 surety bond.

Authorities first became aware of the thefts in August of 2003 when reports began coming into the Schleicher County Sheriff's office about vehicles being broken into. What lawmen at first hoped were only a few unrelated incidents soon grew in scope with homes and businesses being burglarized. By November of

2003 the cases involved three home, three business and eighteen auto burglaries.

Investigators got their first solid lead when phone records from a cellular phone taken in one of the burglaries revealed that someone had been placing calls from the phone. The investigation soon pointed to Duwayne Lloyd Gonzalez and he was brought in for questioning. A series of interviews followed with officers questioning Lowe and the both Gonzalez brothers, as well as witnesses who reportedly had knowledge of the crimes.

"We were pretty sure we were on the right trail," Sheriff David Doran told the Success. "As soon as we got the tip about the cell phone and started asking questions, the burglaries stopped."

In time, the officers developed enough information to obtain arrest warrants for the three suspects. They also began calling on pawn shops in San Angelo where some of the stolen merchandise was recovered. Other stolen goods were recovered when the three were taken into custody. Interestingly some of the loot came from homes and businesses whose owners were not even aware they had been victimized.

James Michael Lowe, 19, was taken into custody on Dec. 16, 2003. Sean Michael Gonzalez and Duwayne Lloyd Gonzalez were arrested on Dec. 24, 2003.

Lowe and Sean Michael Gonzalez will face felony charges State District Court in the three home burglaries and the three business burglaries. They will face misdemeanor charges in County Court in the thirteen vehicle burglaries. Duwayne Lloyd Gonzalez faces misdemeanor theft charges in County Court.

"This has been a long and tedious investigation," Sheriff Doran said after the arrests were made public. "I want to give credit to my officers on this case, for their persistence and their investigative skills."

Doran said that Deputy Jason Chatham was the lead investigator on the case and was assisted by Chief Deputy George Arispe.

Sheriff Doran noted that a separate investigation into a burglary of the Richardson home on Lee Avenue continues. "At this time I don't believe the Richardson burglary is connected to this case," Doran stated. "However, it remains under active investigation."

The Richardson home was burglarized shortly after Kenneth and Betty Richardson were killed in the First Baptist Church Bus wreck on August 13, 2003. Sheriff Doran said that solving crime remains a priority and he asks that anyone with information about the case please contact his office at 853-2737.

## San Angelo fire claims life of Mitzi Sessom

Mitzi Sessom, 20, of Eldorado died Monday, January 5, 2004, in University Medical Center in Lubbock. She suffered severe smoke inhalation during a fire at a home in San Angelo during the early morning hours on January 1, 2004. Sessom, who was unconscious when she was pulled from the home, reportedly never regained consciousness.

Sessom's death is the second in her immediate family in the last six weeks. Her grandfather, Billy Frank Blaylock, died on Nov. 17, 2003 from injuries suffered in the First Baptist Church bus wreck on Oct. 13, 2003.

Sessom was a student at Texas Tech University and was a 2002 graduate of Eldorado High School. She was the daughter of Steve and Eva Jo Sessom of Eldorado and Rocky Milby of Midland, Kentucky.

## David Doran seeks reelection as Sheriff

My wife, Lenette, and I have two children, Krista, 24, who lives at home,

and David Ray, 19, who is currently serving in the Army as an Airborne Military Police Officer. He is completing training in Ft. Benning and will soon be deployed to South Korea.




**Insurance bills could help small businesses**

AUSTIN — Whether you keep your appointments on an old-fashioned paper calendar, a leather-bound organizer or a state-of-the-art Personal Digital Assistant, here's a date to remember if you're a small business owner worried about the cost of health insurance: Feb. 6.

On that day, the Texas Department of Insurance will hold public hearings on proposed rules that could make health insurance coverage less expensive for both businesses and individuals. The rules, which will be acted on by the insurance commissioner after public input, will implement Senate Bills 10 and 541, passed during the last regular legislative session.

SB 10 allows small businesses to create what the legislation calls "Health Group Cooperatives" to improve buying power in shopping for group insurance benefits. These co-ops must have at least 10 different employers, a term which includes small businesses, associations, chambers of commerce or other organizations.

SB 541 authorizes Health Maintenance Organizations and insurance companies to offer an assortment of health plans at reasonable prices. Known as "Consumer Choice Plans," they provide

consumers more choices on extent of coverage rather than traditional "one size fits all" policies. The bills are law, but the hearings on the proposed set-up rules will be at 9:30 a.m. Feb. 6 for SB 541 and at 1:30 p.m. that day for SB 10. Written comments on either measure can be received through 5 p.m. on Feb. 9.

report that flu is still widespread in Texas.

TDH reached its conclusion on the prevalence of influenza based on the fact that the virus was reported in six of 11 of the state's public health regions. Types A/Panama and A/Fujian (and various varieties described as "Panama-like" and "Fujian-like") are making the rounds. A form of Type B flu also has been confirmed, though the strain has not yet been identified.

Knowledge being power, it's interesting to note in TDH news releases on flu in Texas that doctors and hospitals in Texas are not mandated by law to report flu cases to the health department. The agency is forced to get its information from a network of voluntary surveillance sites instead.

"Therefore," as the department said last week, "TDH does not have statewide flu case or flu death numbers." That last part was printed in bold.

The department apparently is not encumbered in regard to the reporting of West Nile virus cases, which accounted for 35 deaths in 2003 in Angelina, Burnet, Cameron, Castro, Cherokee, Crosby, Dallas (3), Denton, Ellis, El Paso (3), Hale, Harris (3), Hidalgo (2), Floyd, Lubbock (2), Montgomery, Parmer, Potter, Randall (2), San Patricio, Smith, Taylor, Travis, Wharton and Wichita (2) counties. In all, 408 human cases have been reported in 82 Texas counties.

Bottom line: Cover your mouth when you cough, wash your hands even when you don't think you need to and watch out for mosquitoes.







## Cable provider announces rate increase for Eldorado

Cebridge Connections, formerly known as Classic Cable, announced a 3.137 percent rate increase for its Eldorado customers who subscribe to Expanded Basic cable service. The new rate will be \$24 per month, as compared to the old rate of \$23.27.

Cebridge formally notified the

City of Eldorado of its intent to raise rates by letter in late December. The city, which grants franchise rights to cable, electric and telephone companies, has seen much of its authority to regulate rates eroded in recent years by deregulation. City Administrator Randy Mankin noted that the city

no longer has the authority to approve or deny rate increases by cable TV providers.

Cebridge Connections is the new name chosen by the former Classic Cable company after it emerged from bankruptcy protection in 2003.

A press release from the company explained, "We remain conscious of the tough economic times many of our customers face and have thus done everything possible to minimize these adjustments. Effective with the customer invoices for the February billing cycle, monthly rates will be adjusted as follows: Expanded Basic, from \$23.27 to \$24.00"

The company notes that it has embarked on a company-wide capital improvement program saying that it looks to build on the momentum it created in 2003 by taking steps to improve the service it provides to its customers.

The company explains that the price adjustment applies to residential service and that taxes and

fees will also be adjusted to reflect current taxing and fee assessment rates. It said it would be giving its customers a 30-day notice of the rate increase on their monthly invoice in January, 2004.

Cebridge notes that it is working hard to hold the line on future rate adjustments but explains that one of its major expenses is the rate it pays to cable television networks it carries on its system.

"Those rates have been increasing steadily, and in some cases dramatically, especially for sports programming. We also know that small-system operators like Cebridge are typically charged a higher price than large-system operators for the same programming. That's unfair and unjustified, and it directly penalizes the citizens of smaller cities and towns," Cebridge states.

The company says it is considering taking its case to Washington, D.C. and asking federal authorities to level the playing field so that the cable customers in smaller cities and towns are treated fairly.

## Four criminal cases disposed

Judge Barbara Walther's court disposed of four criminal cases Tuesday December 23, 2003. Among those cases were:

- Ruben Arispe Gonzales, 60, pled guilty to Aggravated Sexual Assault of a Child. He was sentenced to 20 years in the Texas Department of Criminal Justice.
- Crystal Belia Reza Borrego, 23, pled guilty to Unauthorized Use of a Motor Vehicle. Charge was reduced to Class A Misdemeanor and received 2 years probation and pay restitution in the amount of \$3,630.00.
- Marcelo Iglesias Romo, 17, pled guilty to Organized Crime. Received two years probation and pay \$633.45 in restitution and a \$500 fine.
- Walter Odell Wagner, 25, pled guilty to 3rd Degree Felony - Organized Crime. Received 180 days in the Texas Department Criminal Justice

## Four myths of parent involvement in schools

Not all parent involvement activities are created equal. The National Center for Family and Community Connections with Schools at the Southwest Educational Development Laboratory (SEDL) has combed through research to learn how parents can help improve their children's achievement. Based on this research, SEDL responds to four misconceptions of parent involvement in schools. "The Center focuses on finding and sharing research-based information people need to design initiatives and take action to make connections among schools, families, and communities," says Catherine Jordan, director of the Center.

**Myth #1:** As a parent, the best way to get involved in my child's education is by joining the local parents' organization.

Parents who are dues-paying members of their children's school PTA are supporting the oldest and largest child advocacy organization in the United States. But being a member alone doesn't ensure effective involvement in a child's learning. To support achievement, research suggests the most effective parental involvement focuses on learning activities—reading to

children, letting them figure prices at the grocery store or setting aside time and space to do homework and projects. There are benefits in joining an organization like the PTA or PTO, such as the opportunity to share experiences and information with other parents and access to PTA resources. Just the same, parents can provide the support needed at home for their children to be successful in school without joining a local parent organization.

**Myth #2:** The teacher is the sole expert in educating a child, so a parent should never question a teacher or staff on school-related issues.

Teachers and parents or family caregivers play different roles in a child's education. And a good relationship between a teacher and a parent, based on mutual respect and trust, benefits students. At times, parents may need to ask a teacher or school staff member for clarification about a specific issue or information. Parents should contact their children's teachers or other school staff when they have questions about their children's education. Most school staff members begin to see parents as partners when they know they will ask questions when information is unclear.

**Myth #3:** The influence of parent involvement on school achievement depends on the parents' income, level of education, and employment status.

A large body of research confirms that family involvement in children's school experiences has a positive effect on children's attitudes toward achievement in school, regardless of how much money parents have or how many years of school they completed. More important is the parents' attitude toward learning. Working parents may not have much time to be involved at their children's schools, but they can show how much they value education and take an active interest in what their children are learning.

**Myth #4:** The key actors in parent involvement are the teacher, parents or family, and the student.

Meaningful and successful parent involvement is not limited to partnerships between parents and teachers. Parents and family caregivers should think of the following educators and decision makers as participants in their children's education—teachers, the principal, the school board, the superintendent, and public officials. Parents can influence school board members and public officials by participating in meetings, voting, and engaging in discussions of education matters and child advocacy issues.
