# Welcome Mias Amigas!

It was on July 12, 1931, that Mrs. J.E (Josephine Murchison) Hill, Mrs. Wallace (Ruby Jones) Dameron, Mrs. J.L. (Ida Conner) Neill and Mrs. E.W. (LaVita Christian) Brooks met at the Experiment Station at Sonora, Texas, in Ruby Jones Dameron's home to make plans for ex-students to reunite and keep alive that old school spirit. Thus the Mias Amigas Club was organized so that those who attended the school during the teens of the century might keep that school day friendship alive.

The charter members of this unusual club were Ruby Jones Dameron, Josephine Murchison Hill, LaVita Christian Brooks, Ida Conner Neill, Lucile Hill Walker, Lula May Evans

Perner, Mary Ellen Tisdale Hughes, Gladie McKnight Davis, Sulena Halber Bird, Lummie Pelt Whitten, Olga Benton Meador and Elsie Berry Reagan.

In 1938 the Club decided to really organize and draw up a constitution. Section I stated that "the object of this organization shall be to preserve through the crowding years the love and sentiment of our school days". Article III, Section I, provided that "the persons eligible for membership in this club shall be graduates of Eldorado High School or those who would have been eligible for graduation between the years 1907 and 1919 inclusive. Article IV, Section I stated that "regular meetings Smith, Mattie Whitten Royster, shall be held annually the last

To commemorate the spirit of their school days, the Mias Amigas Club placed a plaque on the foundation along with the school bell from the old school house. This was erected in 1940.

Until 1954 the highlight of the meeting was the hayride that everyone enjoyed, but it was decided that the hayride would be dispensed with and instead all would meet on the courthouse lawn and ring the old school bell and sing the Mias Amigas song before the meeting began in the Memorial Building.

The Mias Amigas Club has done many worthwhile things since it has been organized. The club has donated many books to the Eldorado Library, had a marker put at the grave of a former schoolmate, Gladys Patton, who was buried in San Antonio, helped buy floor covering for the kitchen and rest room in the Memorial Building and was the first to donate money for the establishment of the Schleicher County Museum.

In 1966 the members amended Section I of the Constitution by including school years 1920 through 1929 to the

membership. Then again in 1973 the motion was made that classes be eligible for membership twenty years after graduation.

The Mias Amigas song was written by Lucile Hill Walker, one of the charter members. Following are the words, sung to the tune of "Believe Me If All Those Endearing Young Charms":

My Mias Amigas, the glad time has come

To recall golden days ever dear: Pledge again our devotion, Renew friendship's vow

As our happy hearts laugh at the years.

Then join in the fun,

Make merry each one, Precious moments are fleeting away;

Clasp a hand, say "I love you, I'm glad you could come"

Help up celebrate friendship's bright day.

The original Mias Amigas Club has grown in such proportions since it was voted to take in one new class a year that it has really turned into a big reunion where old friends get together with joy and laughter, tears and regrets. Joy at sight of familiar faces, laughter at remembering past events, tears at parting and regrets for those who are absent.



QUALITY HEALTH CARE: Will it be there when you need it?

Although the United States has the finest health care in the world, the system is in jeopardy, according to the Texas. Hospital Association, the Austinbased trade association representing the Texas hospital industry.

Hospitals are facing increased costs and decreased income. Unless dramatic changes in health care financing are made, health care as we know it will soon become a thing of the past, according to Terry Townsend, president of the hospital association.

Advancements in medical treatment in the last 10 years have contributed to increased costs. "A few years ago, cataract surgery required several days of hospitalization; now, thanks to the YAG laser, most cataracts are removed on an out-patient basis," Townsend notes.

An aging population is placing greater demand on the health care system, too. Older patients tend to suffer from chronic illnesses and multiple problems that make their treatments complex, lengthy and more expensive, association statistics reveal.

In Texas, 16.5 percent of the population has no health insurance. Uncompensated care represents more than 10 percent of the average hospital's case load,

according to DataPulse, the association's information collection and reporting program.

Medicare and Medicaid programs, which represent more than 50 percent of the average hospital's patient load, pay hospitals less than what it costs to deliver services. "As hospitals are forced to spread the unpaid costs among their paying patients, a 'hidden tax' is created, and every employer and employee pays it, in addition to taxes paid to support Medicare and Medicaid,", Townsend said.

The result of current government health care financing policies has been hospital closures. For the past four years, Texas has led the nation in the number of hospital closings. Combined with the 53 counties with no hospital, these closures have placed access to hospital services in jeopardy in parts of the state, the association reports. "We are convinced that

unless government policies regarding health care financing change, the high quality medical care we all expect simply won't be available," Townsend said. Some have suggested adopting socialized medicine models similar to those in place in Great Britain and Canada. Townsend noted that rationing of care and delays in receiving needed treatment are routing in these countries. "Is this the future of health care in America?" Townsend queries.

The association is urging Texans to communicate with federal and state elected officials demanding the development of a national health policy that maintains both quality of care and access to basic health services.



# -Unofficial Minutes of City Council Meeting-

A Special Meeting of the Eldorado City Council was held Tuesday, June 19, 1990 at 7:30 P.M. at the City Hall with all Councilmen in attendance. Also present were Maria Gauna and Ronnie Sauer, who represented the Schleicher County Chamber of Commerce. Meeting was called to order by Mayor Preston.

**TCDP** Hearing

A Public Hearing was opened to discuss proposed 1990 Texas Community Development Program Urgent Need Application. Purpose of the hearing was to solicit views and comments concerning the possible uses of grant funds should they be obtained. Attendance Sheet was circulated for those persons

attending. Program materials were distributed. Following discussion, motion was made by John Callison and seconded by Dora Bosmans that the Resolution be approved authorizing submission of an application to TCDP, endorsing activities, setting application amount and designating the Mayor as the City's Executive Officer and authorized representative. Motion carried

#### **Update On TCDP Projects**

The Secretary reported that final designs were being prepared for approval on the 1987 Amendment Project by Todd Engineering. Preliminary work is ongoing on the 1989


six of her 44 hits went for extra bases.

The Secretary passed along request from Trooper McIntyre with the Department of Public Safety - Drivers License Testing Division - who had requested a waiver from the Council of the Truck Ordinance for purposes of his testing applicant drivers for commercial licenses. Reportedly, this would involve perhaps one or two drivers on Thursday, and the officer would be in the truck with the applicant. The proposed route was circulated for the Council's review. Motion was made by John Nikolauk and seconded by Barbara Jackson that the waiver be allowed. Motion carried.

Mayor Preston emphasized need of the Council to be considering future of the

have not been published as yet, but Jack Dean reported that he had been in contact with Adam Hernandez with the Texas Department of Health (Solid Wast Division) and Mr. Hernandez had agreed to meet with the Council if a meeting could be arranged.

The Council discussed the transfer station alternative briefly and Mr. Dean stated that he was going to dig another pit as soon as possible as the 1988 pit was filling up.

#### Wastewater Plant Update"

Mr. Dean reported on sampling results for the past week which continued to show a good improvement toward compliance. He reported estimate of expense for used irrigation equipment (pump, piping for one mile, 40 horse motor, sprinklers, etc.) for Kellogg pastureland irrigation of 200' diameter of \$22,000 +. John Callison reported that Charles Kellogg was still agreeable to the arangement with stipulation that water was not to puddle and that tailwater would be contained. Pros and cons were discussed with the Secretary reporting on progress with the Railroad to either lease or purchase the Railroad Right-Of-Way property between the plant and the Kellogg property. The need for the irrigation permit was discussed with Mr. Dean to proceed as far as possible and Todd available for input as necessary. The Secretary also reported that she had contacted the Hanover office in Midland and that she had been referred to Walter Donaldson to obtain guidance with regard to the Hanover high pressure gas transmission line. No further contact has been had with the Christian family

The figures as provided

by Ray Lewis Ballew were reviewed with the supplied 1989 figures and 1990 budget figures for comparison. After discussion, no official action was taken to file opposition to the presentation.

#### Billings

Billings received since the last meeting of the Council were reviewed, and motion was made by Barbara Jackson and seconded by Dora Bosmans that they be approved as presented. Motion carried.

#### **Equipment Report**

Mr. Dean reproted that the County dumptruck had a rod bearing out and that metal was reported in the engine. Repair estimate was given by International representative showing approximately \$2528.00 to \$3000.00 needed. It was reported that the truck had been given to the City by the County; however, the title has not been transferred. Motion was made by John Callison that the repairs not be made until the title was received. Motion was seconded by John Nikolauk. Motion carried. The source for the necessary funds for the repairs was discussed with Amendment #5 to the budget proposed to transfer funds within the General Fund; however, no official action was taken.

#### Law Enforcement

The Council discussed letter sent to Sheriff Norris on June 10 in which the Council had stated that the \$1500/month payment from the City to the County was in jeopardy due to failure of the Law Enforcement Personnel to provide the agreed

upon nightwatch and ordinance enforcement services since January, 1989. No response has been received by the Council to the letter. It was the unanimous decision that another letter be drafted but directed to the Commissioners' Court stating that the July payment would be held due to Sheriff Norris' failure to respond as requested.

#### Sewer Line Request

Mr. Dean reported that a customer had requested services in Block 42, O.T. for water, gas and sewer services. All tap fees had been paid as well as deposits. The water and gas services were not a problem; however, the sewer service was approximately 200' away which would require digging in the alley to connect. The City's Utility. Ordinance has provided for 100' extension by the City with the customer to provide anything in excess of the 100'. Mr. Dean asked the Council to consider the City extending the line the additional 100'. After discussion, the request was denied due to a variance from the established policy; however, discussion was held and the Council emphasized the need for the plumber making estension to provide the sufficient bonding to protect the City and adjacent property owners from damages which might occur. This customer will need private sewer lift pump.

Southwestern Bell Telephone Company has instituted a Class Action Lawsuit seeking judicial approval of a settlement reached in Docket No. 7297, an inquiry of General Counsel of the Public Utility Commission of Texas into possible overcharges which occurred between September, 1976, and February, 1987, due to rounding practices, on bills of intrastate WATS/800 customers sent by Southwestern Bell and other telephone companies which concur in Southwestern Bell's tariff. The suit is styled "Southwestern Bell Telephone Company, Plaintiff, vs. MCI Telecommunications Corporation, A Member of the Class of Texas Intrastate WATS and 800 Service Customers Who Paid Overtime Charges From September 1976 Through February 1987, Defendant," and identified as Cause No. 471,460 in the 126th Judicial District Court of Travis County, Texas.

Pursuant to the settlement, while not admitting liability, Southwestern Bell, the other local exchange telephone companies in Texas, and AT&T Communications of the Southwest, Inc. have agreed to pay refunds to those WATS/800 customers who paid overtime charges attributable to the rounding practices for intrastate WATS/800 services at any time between September, 1976, and February, 1987. The refunds will be based upon either the actual or estimated amount of overtime charges attributable to such rounding practices. An exact refund will be determined for customers able to produce copies of their WATS/800 service bills. For customers who do not have copies of their WATS/800 service bills to establish actual overtime charges paid, an average refund of \$4.53 to \$5.95 per WATS/800 service line per month will be applied. All claims will be subject to verification. The refunds will also include interest at the rate of 7.80% per annum.

The WATS Refund Information Package will contain further information regarding the lawsuit and eligibility for a refund, a description of documentation required to support a customer's claim for refund, and a refund claim form to be filled out and submitted requesting a refund.
