

Life Among The Fishes

I have read and reread Mr. Enochs' letter and I can not figure out how he feels that there was some sort of direct slap or insult to him and all other law abiding NRA members. With the possible exception of using the adjective "all" before the term Automatic weapons owners I cannot see how that makes it appear that I think all NRA members want our young men and women over there. But since that letter was Mr. Enochs' thoughts, then I guess he is as entitled as anyone to make such an inference.

But then Mr Enochs presumes to speak for me which creates for me an opportunity to be offended if I were a person who was easily offended. I would never presume to infer that Mr. Enochs is a war monger, but he belongs to an organization which

has taken a clause in the Constitution's Bill of Rights that seems to infer that we citizens can arm ourselves to deter aggressors and made it's existence revolves around the need to hinder, stop and reverse any reasonable legislation aimed at limiting the kind, type and firepower of guns that any U.S. Citizen can own. The point of my article was that the NRA, which. I assume represents its members, advocates (not merely allows by indifference) the ownership of any and all types of weapons, many of which have no other purpose than the destruction of human life. If, of course, this is untrue, than I stand corrected. But let's look at the record of the NRA. It was the NRA, after the killing of children in a school yard by a man using an "Assault rifle", that tried to stop the State of

California from banning the Sale of Assault rifles. It was the NRA that has bottled up in a congressional subcommittee a law limit the amount of ammunition for any semi automatic weapon to seven rounds. I know I am not an avid hunter but I cannot for the life of me (And that is what worries me!) imagine any American civilian, sportsman or otherwise, who would need a weapon that held more than seven rounds of ammunition.

I want to hear an explanation of just how limiting munitions clips to seven rounds or less infringes in any way on my Constitutional right to bear arms? There are no Constitutional rights that are absolute, at least none that I know about. Why should the right to bear arms be the exception? Are we so afraid of

own government, the government that is us, that we need to have in our homes the firepower of today's infantryman?

I submit that Mr Enochs is right, I know very little about NRA members, I only know what I read in that fair free press he speaks about. It mentions what the NRA fights for in Congress and it appears to me to be the unrestricted ownership of whatever kind of gun any citizen wants to own.

If NRA members do not want the NRA to fight for this then I suggest they change the leadership of the club or change clubs. If, on the other hand, NRA members believe that they should be able to own weapons with munitions clips that hold 10 to 20 rounds, that are not designed for hunting but for assault, then the NRA members should keep the present leadership.

GOLD FLOWER (Marigolds) PROBLEMS

We are having a little problem with marigolds around Eldorado. Spider mites are the culprits. If you will look very closely, there is a fine web on the flowers with little red specks running around it. If you will take the flower and it on a white

piece of paper, you can see the spider mite much easier. The dead and dried spotted leaves are being caused by the little mite. SCISD Update

Eldorado high school and middle school teachers and principals have been receiving questions and occasionally complaints about the longer lunch periods this year. The reason for the lengthened lunch period is instructionally based. The hour-long lunch is actually a 30 minute lunch time and a 30 minute Eagle Period. The Eagle Period will be used for tutorials, club meetings, UIL practice, G/T in middle School, pep rallys, etc. Students who are not required to be at tutorials or some other activity will have an hour-long lunch period. The district wanted a time to tutor and/or otherwise work with students during the school day rather than before or after school. Tutorials before or after school hurt those students who ride buses and cause inconvenience for all concerned. By tutoring students during the middle of the day, the district can require students who have not shown mastery in some area to show up and get help. The students who need help most are often the ones who will skip tutorials if the period is not part of the school day. Thus, the district, is insisting on helping those students.

given at the beginning of school the TAAS test, replacing the old TEAMS test, is a test of highlevel skills and is much more difficult than TEAMS. Most students have shown a need for extensive help in preparing for this test. It may seem as if the district has become totally test oriented, and sometimes we feel that way, too. In truth, Texas now has a test-driven curriculum. The recently passed Senate Bill 1 has tied state funding to test scores. Districts are to be given a grade based on their test results. District grades, based on a caparison of 100 school districts of equal size, wealth, etc., will be published in the news media. Historically, Schleicher Co. ISD has done well in comparison to other districts. We want to continue that tradition, but there is a more serious issue involved. Students must pass the TAAS test before they can graduate from high school. Because of the increasing difficulty at each grade level, students passing at lower grade levels is critical to future success. Our teachers are working hard to ensure that students have the basic foundation they need at all levels for the test that will be administered in October. 
