Jericho, Israel

PLO Chairman, Yasser Arafat made a triumphant entry into Jericho this week. After 25+ years of exile, the Palestinian returned to set up a semi-autonomous Palestinian state on the west bank of the Jordan River. The move was made possible by the recent Israeli-Palestinian peace accords.

Charlotte, North Carolina

A US Air DC-9 crashed at Charlotte-Douglas International Airport Sunday, killing 37. The accident, the worst ever at the Charlotte facility occurred during a violent thunderstorm. 17 remain hospitalized 3 others were treated and released. Authorities report that a "wind shear" warning had been issued by air traffic controllers "only minutes prior to the crash." The pilot had reportedly aborted a landing attempt moments before the accident.

Washington, D.C.

Clinton administration spokesmen, this week announced another in a series of policy changes regarding Hatian refugees. Following a July 4th weekend which saw over 9,000 refugees being intercepted on the open sea. The new policy enunciated Tuesday will allow for those Hatians requesting political asylum in the United States to do so by applying at the U.S. embassy in Port-Au-Prince. Any of the refugees requesting political asylum on the open sea will be taken for a hearing at a base in Panama. All others will be returned to Haiti.

In a show of force, four more war ships have been ordered to the area. The move bolsters the United Nations embargo around the Carribean nation and ratchets up the tension between the U.S. and military government of Haiti.

Washington, D.C.

Spokesmen for President Clinton announced this week the establishment of a Legal Defense Fund for the President and First Lady. Recent allegations of sexual misconduct by the President while he was Governor of Arkansas as well as charges of wrong-doing related to the "Whitewater" matter prompted the formation of the fund. "Donations are currently being accepted to help offset the skyrocketing legal bills," said one presidential spokesman

Over The Back Fence

I've been hearing a lot lately about the legal defense fund our President and First Lady have established for themselves. It seems that some of the recent accusations against the President are destined to turn up in court and the Clintons are asking for donations to help defray the cost of their legal bills. Pitchmen are making the rounds of talk shows and sunday morning news shows soliciting donations and advertising a 1-800 number. It's not exactly a new idea, I suppose. 

Everything that God has provided, promised and prepared for us, He has written and put in the form of a Covenant for us to operate in. This based on a relationship that demands fellowship with Him. (John 15: 7)

In Numbers 13: 1-3, we note that God had already promised the land of Canaan to the nation of Israel, yet here in verses 1-3, God reluctantly approves the decision of the people to go in and spy out the land in order to see if what God said was true! (Deut. 1: 19). This was allowed again despite what was said by God in describing the land and what He had for them. There are two things in us as believers that keep us from going into the fullness of what God has in Jesus Christ our Lord. These two needing development are our power of choice and our understanding of God's word.

We see the Sovereignty of God in this book by His stepping aside and letting the Israelites choose to do it their way. This endeavor was done at the time of the harvesting of grapes, signifying "abundance". Thus taking them "forty" days to see that God was telling the truth, in verses 26-27 words like "surely", also confirm God's word, The words "nevertheless" and "saw" are not words of faith, but words of doubt and unbelief which cause the people to look at the natural and not the spiritual. They saw the Giants and not the grapes; thus causing them to forget that they were a covenant people, faith people, holy nation and a people of God.

Out of the twelve, two saw the promise, provision and providence of God in the mission, They chose to pick the grapes and to kill the giants. Their report was one of faith and victory. The other ten chose to deliver a "slanderous" report of fear, doubt and unbelief. The consequence of choosing to bring this type of report and not believing what God had said is recorded in Numbers 14: 37!

So we have a choice: to believe what God has said in His word, or to believe what we see and hear in the natural as believers. In romans 8: 1-2 we have a choice to operate in the flesh or in the Spirit; to operate in the law of life or in the law of sin and



Gov. Richards Seeks Protection For Lamb Producers

Texas Governor Ann Richards announced Friday, June 24th that she has asked U.S. Trade Representative Mickey Kantor to protect Texas lamb producers from unfair foreigh competition.

In a letter to Ambassador Kantor, the Governor asked that imported lamb be included under tariff provisions of the existing Meat Import Law and that language to implement the provision be included in the General Agreement on Tariffs and Trade

"The Meat Import Law is the only import measure that will help this industry," Richards said.

Because lamb imports from New Zealand and Australia are unrestridted, lamb imports from these countries have increased 46 percent between 1992 and 1993.

"The unrestricted market access by foreighn competitors, combined with the three-year phaseout of the National Wool Act, delivers a knock-out blow to Texas lamb producers," said

Texas is the nation's largest sheep and goat producer. Many West Texas counties depend on the sheep and goat industry for their economic well-being.
