# Schooley murder trial gets under way in San Angelo

Cliff Schooley, Jr. went on trial for murder Monday, April 19, 2004, in the San Angelo courtroom of District Judge Barbara Walther. The first two and a half days brought a flurry of conflicting testimony as witnesses for the prosecution and defense told very different stories to the 10-woman 2-man jury.

District Attorney Stephen Lupton told the jurors in his opening statement that the trial would unveil a road map of evidence. "What that evidence will show you," he said, "is a disagreement over

Long, who spent the most time on the stand, and Bob Henderson, a blood splatter expert from Canyon.

Long testified that evidence found at the crime scene on Feb. 12, 2003, indicated that Clifford Schooley, Sr. had been shot twice, first in the back of the head while he was standing, facing away from the defendant, his son Cliff Schooley, Jr., and a second time in the face, after the elder Schooley had fallen to the ground.

Long also asserted that Cliff Schooley had planted a loaded and cocked gun in upside down in his hand had, no such splatter or tissue.

Long then demonstrated for the jury how he thought blood from the second wound sprayed up and under the bumper of the elder Schocley's pickup truck when the victim was shot the second time.

As for motive, Lupton based his case on greed. Through a series of witnesses the D.A. introduced evidence that Clifford Schooley, Sr. had worked as a contract pumper for an oil company, receiving some \$1,700.00 per month. After his daughter, Cynthia Powell, suffered a tragic and debilitating setback during a surgical procedure, the elder Schooley hired his son to take care of the oil wells while he spent time with his daughter at University Medical Center in Lubbock Lupton went on to assert that Cliff Schooley, Jr. was not happy with the \$700 per month his father was paying him and that he arranged to take the work away from his father in order to get the entire \$1,700.00 monthly. That set in motion a chain of events that led to a confrontation between father and son on Feb. 12, 2003, on the family ranch...a confrontation that left the elder Schooley dead and the son on trial for murder, Lupton said. Lupton methodically laid out his case, calling local deputies to the stand to testify about the chain of custody of several pieces of evidence and asking tow truck driver Joe Key to testify regarding the disposition of the elder Schooley's pickup truck. DPS trooper Mike Haley, a crime scene reconstruction specialist and forensic map specialist, provided a map of the crime scene, complete with tags showing where various bits of evidence were recovered. Dr. Sridhar Natarajan, Chief Medical Examiner at the University Medical Center in Lubbock, testified that the elder Schooley had been killed by a gunshot wound to the head. He noted that a shot to the back of the head left a small entry wound behind the right ear and a large exit wound in the upper left forehead. The other shot entered the front of the head beside the victim's nose and severed the brain stem before lodging just under the skin on the back of the neck. When pressed by defense attorney Hawkins, Natarajan said he couldn't say which shot came first. DPS Crime Lab specialists Lindsey Smith and Maurice Padilla provided testimony regarding the handling of DNA CONTINUED ON PAGE 6

# **Attorney says YFZ Ranch** connected to FLDS church State environmental inspectors visit YFZ

Salt Lake City attorney Rodney Parker told the Success on Tuesday that the buildings going up on the YFZ Ranch are "clearly connected" to the Fundamentalist Church of Latter Day Saints. Parker, who has represented the FLDS on a number of occasions, said he was unsure why the group chose to build near Eldorado and that he has no idea what the FLDS has planned for the property.

Parker said that he only knows what he has read about the YFZ Ranch but noted that photos of the buildings, plus information he has gleaned about individuals connected with the property convinced him of an FLDS connection.

Parker represented Colorado City, AZ police officer Rodney Holm last year when the State of Utah brought charges of bigamy and unlawful sexual conduct with a 16- or 17-year old child. Holm, who is a was eventually convicted in the case, is an

FLDS member who polygamy.

"Polygamy is the faith," Parker said of the FLDS. "They are very committed to the practice."

On the other hand, Parker says, members of the FLDS are honest, hard working people who just want to be left alone. He speculated that some of them may have chosen to relocate to Eldorado in order to escape the intense media attention they are now getting in Colorado City, AZ and Hildale, UT.

Parker couldn't say, however, exactly how many people would be living on the

Finch told the Success later that the investigation is ongoing and that he expects to make a return trip to the ranch sometime later this week or early next week.

Among the issues the state is investigating are air quality standards associated with a bulk cement plant located near the construction site. Also, storm water discharge precautions, water system capacity, sewer/septic system capability and methods of solid waste (garbage) disposal.

Ricky Anderson, TCEQ Region 8 Director, told the Success in a telephone interview on Tuesday that the State of

Texas has rules governing a number of vironmental quality in and around developments like the one on the YFZ Ranch. He said that subdivisions, and other

large-scale developments outside the city limits have to follow many of the same rules as the City of Eldorado.

Anderson noted that his agency began looking into environmental concerns on the property as soon as they were made aware. "I want people to know that we are on top of this and that we continue to look into it," Anderson said.

# **Duckwall's not associated with** Allco company of Hildale, Utah

Duckwall's/Alco officials announced this week that their company is not affiliated with any Allco businesses, located in Hildale, UT and Colorado City, AZ.

Duckwall's Variety Stores, including the one located here in Eldorado, and Alco Discount Stores, including the one in Sonora, are owned by Duckwall Alco Stores, Inc., a Kansas based corporation, named after its founder A.L. Duckwall. Shares in the company are publicly traded on the NASDAQ stock exchange.

Confusion about the company's ownership apparently resulted from a news article that appeared in the Salt Lake City Tribune, and on its website. The story, picked up by a number of other publications, linked David Allred, the Utah man who organized YFZ Land L.L.C., and bought 1,691 acres north of Eldorado, to an Alco Company in the twin cities.

Flora Jessop, a child's rights activist from Phoenix, AZ, captured national media attention last month when she alleged that David Allred and the YFZ Ranch are affiliated with the Fundamentalist Latter Day Saints Church (FLDS) located primarily in Hildale, UT and Colorado City, AZ.

Jessop further claimed that members of the FLDS, a splinter sect of the Mormon Church, continues to practice polygamy, plural marriages, and that underage girls in the church are forced to marry older men. She reinforced her claims by saying that she had grown up in the church and had been forced into marriage at age 16. She later fled the group and the twin towns of Colorado City and Hildale.

Dawn Fay, manager of the local Duckwall's variety store, told the Success this week that a recent spate of rumors that her store is connected with the FLDS has led to a dramatic downturn in business.

Jim Schoenbeck, Senior Vice President of Store Operations for Duckwall Alco told the Success, "Our company is in no way connected to Allco companies in Hildale, Utah or Colorado City, Arizona.

"We are based in Abilene, Kansas, the town where our founder, A.L. Duckwall, opened his first store," Schoenbeck explained.



DNA is far from elementary, but it is helping to solve more and more crimes in Texas, according to the grounds, is that of the nation's 10 Department of Public Safety.

The national FBI DNA database, known as CODIS for Combined DNA Index System, led to arrests in 16 homicides, 66 sexual assaults and 34 burglaries.

That is the good news from the DPS perspective. The bad news is that the House General Investigating Committee was scheduled to hear testimony Tuesday concerning allegations of problems at DNA laboratories run by the DPS.

Time to think about West Nile ... The bluebonnets are out, but so

are the mosquitoes.

The Texas Department of Health is reminding Texans to use insect repellent as the first line of defense against mosquito-borne pathogens, particularly the West Nile virus.

Texas had more cases of West Nile illness last year than were reported in 2002, the department said. And of those who contracted the more serious forms of the disease, 77 percent had not used insect repellent before venturing outdoors.

Last year, TDH logged 434 human cases of West Nile in 86 of the state's 254 counties. Of those cases, 36 proved fatal.

# School board asked for more **Elementary teachers next year**

board of trustees met Monday evening, April 19, 2004, and among other business, heard from a group of about 20 Elementary teachers and parents regarding staffing levels on the Elementary campus.

Speaking on behalf of the group, Debby Griffin addressed rumors that the number of teaching positions in the Elementary school will be frozen at current levels for the next school year.
