## AZ charges Chatwin with trespass at his own home

Ross Chatwin, the man who stood up to FLDS Prophet Warren Jeffs and went to court to win the right to stay in his Colorado City, Arizona home, was arrested last week, shortly after returning to his home following a trip to Eldorado. Interestingly, Chatwin was charged with trespassing at his own home, the very home awarded to him by Arizona Superior Court Judge James Chavez.

Chatwin was released a day later, shortly after Mohave County, Arizona, Deputy Attorney James J. Zack, Sr. reviewed the charges against him, as well as Judge Chavez's order giving Chatwin Chatwin released on his own recognizance. A hearing is slated for Sept. 24th in Mohave County Superior Court in Kingman, Arizona.

Chatwin told the Success in a telephone interview that he looks forward to getting his day in court..

Ross Chatwin won the right to live in the home when Judge Chavez ruled on May 20th of this year that the United Effort Plan, a financial trust controlled by the Fundamentalist Church of Jesus Christ of Latter Day Saints, didn't have the right to evict Chatwin from the home, following his excommunication from the church, even though the home was built on UEP property. It was noted in trial that the UEP charter had been amended in 1998, allowing UEP trustees to evict people from their homes, but the amendment took effect after Chatwin had built a home on UEP land at 425 Uzona Street in Colorado City. Court documents indicate that the construction cost Chatwin spent some \$130,000 in material and labor. In 2001, UEP officials allowed Chatwin to exchange his Uzona St. home for another house located at 245 N. Willow Street. He and his family were allowed to move into the basement living quarters. The upper floor of the home was to be used by Chatwin for storage. But, shortly after Chatwin's excommunication from the church in late 2003, CONTINUED ON PAGE 5

## City raises water, sewer & gas rates, imposes new fee at landfill

City water, gas and sewer customers will be seeing higher rates soon, following Monday night's vote of the Eldorado City Council to approve previously proposed increases. The minimum monthly charge for water goes up a dollar with customers paying \$10 for the first three thousand gallons. Each subsequent thousand gallons will be billed at \$2, that's up from \$1.50 per thousand gallons.

Gas rates, which already fluctuate up and down with the market price of gas will go up slightly with the city's markup being increased from \$2 to \$2.25 per thousand cubic feet.

Meanwhile, sewer rates will increase by a dollar per month.

Council members spent little time discussing the proposed rate increases. Instead, they devoted much of their discussion to the adoption of a new fee for trash that is dumped at the landfill. After much give and take on the issue, the council reached a consensus that the average person who hauls a small load of household trash should not be charged and they amended the proposed fee downward. Ultimately the panel voted to approve a landfill fee schedule that doesn't charge for loads of 500 lbs or less, so long as the waste originates in Eldorado or Schleicher County. Any waste weighing in excess of 500 lbs. will be charged at the rate of \$1 per 100 lbs., or \$20 per ton.

The city already charges contract haulers who bring waste in from surrounding towns at a rate well in excess of the new "local rate."

Before the final vote on the rate increases, Jan Barton, asked if the council to consider not increasing the sewer rate and find another place to raise the money. Fire Chief Jerry Jones, who was present for other business, asked if the water discount given to volunteer firefighters would remain intact. He was told that the current policy of providing 50,000 gallons of water to firemen for the minimum charge would be continued. mously for the rate increases, and the new fees at the landfill.

The meeting was the council's regular monthly session and was called to order at 6:04 p.m. by Mayor John Nikolauk with council members Bill McCutcheon, Toni Sudduth, Dora Bosmans, Tommy Minor, Richard Mendez and Juaquin Rojas in attendance.

City Staff present for the meeting included City Administrator Randy Mankin, City Secretary Carolyn Mayo and Utility Superintendent Floyd Fay.

In other business, the council heard from Fire Chief Jones about a Hazard Mitigation Plan that has been prepared for the thirteen counties and various cities that make up the Concho Valley Council of Governments. Jones explained that in order for city to qualify for federal disaster relief it must adopt an approved hazard mitigation plan. He noted that the CVCOG had received a grant to prepare an area-wide plan and that a consulting firm had produced a draft plan for the council's consideration. At that point Randy Mankin passed around the 700+ page document. After a brief discussion, the council voted to unanimously approve the draft plan and authorize a resolution of support.

Discussion then turned to new overtime rules that went into effect recently. Dick Baggett, representing RGB Human Resource Solutions of San Angelo told the council that he had met with City Administrator Randy Mankin and City Secretary Carolyn Mayo to review the way the new rules might effect the city's administrative employees. He noted that the City Administrator and Utility Superintendent positions are exempt from overtime requirements while the position of City Secretary might not be. Baggett said that more study of the job's duties would be needed before he could make a determination.

Attorney James Kosub was also in attendance and had provided Mayor Nikolauk with a written opinion on the matter. He advised the council that he believed the City Secretary position was also exempt from overtime pay.

Following a lengthy discussion the council voted to schedule executive sessions for the upcoming meeting for the discussion of job descriptions and the duties of the three top positions.

In other business, the council heard from Utility Superintendent Floyd Fay who updated them on work in the various city departments he oversees. City Secretary Carolyn Mayo also updated the group on the city's financial position and advised them that the city's annual audit is underway. She said that the audit report would be available to the council later in the year.

City Administrator Randy Mankin then advised the council on his conversations with representatives of Cebridge CONTINUED ON PAGE 6

Chatwin had reportedly entered the upstairs apartment occupied by his brother, Stephen, and was changing the locks in hopes of keeping the man and his family out of the home, when C-City police officers Helaman Barlow and Fred Barlow were called to the scene. The officers reportedly told Chatwin they were not aware of Judge Chavez's ruling. They then arrested Chatwin as his wife, Lori, videotaped the incident.

Chatwin was taken to the Purgatory Correctional Facility at Hurricane, Utah, where he was held overnight before being transported the next morning to the town of Moccasin, Arizona where he appeared before a Justice of the Peace. At that time, a cash bond of \$2,000 was set in Chatwin's case. But, before any of his friends or family could post bond, the Mohave County prosecutor ordered

### Authorities eye Social Security payments in Fred Jessop case

Sheriff David Doran told the Success this week that he remains skeptical that the man he had a phone conversation with recently is "Uncle Fred" Jessop, the missing 94-yearold patriarch of the Fundamentalist Church of Jesus Christ of Latter Day Saints.

Authorities in the Beehive State also have their doubts that the man who refuses to meet with Doran, or any other law enforcement official, is Fred Jessop.

So, officials in Utah and Texas have decided to try a fresh approach in the case, by looking into Social Security payments, made to Fred Jessop, as well as any Medicare claims, or other government documents that may have been filed on his behalf.

"We know someone has been cashing the Social Security checks," Doran says. "Who that may be, is another matter."

Doran said that the elder Jessop could clear everything up by meeting with him or with Washington County, Utah Sheriff Kirk Smith. "If he's alive and well then there's nothing to worry about," Doran said. "If not, then we have lots of questions." PHOTO BY STACI KEY

### **County adopts \$2.7 million budget**

Schleicher County Commissioners met Monday, Sept. 13, 2004 and approved a \$2,715,207.00 budget for 2005. Commissioners Johnny Mayo, Kirk Grififn and Matt Brown voted in favor of the budget with Commissioner Bill Clark voting against.

As part of the budget discussion, County Clerk Peggy Williams asked that her concerns that electronic voting machinery mandated by the State of Texas was not included in the budget. Judge Griffin noted her concern and suggested that the item be placed on a future agenda so that the commissioners could vote on the item.

In order to balance the 2005 budget, a proposed tax rate of 73.2 cents per \$100 valuation was proposed. That amount of tax will generate some \$1.68 million. The remainder of the budget will be funded by fees. A public hearing on the proposed tax rate is slated for 10:00 a.m. Friday, Sept. 17, 2004 in the Commissioners Court Room.


The meeting was called to order by Judge Griffin and the meeting commenced with the reading of the minutes from the Aug. 23, 2004 meeting. The judge asked for corrections or omissions in the minutes but no vote was taken to approve the minutes.


Among those in attendance at the meeting were County Treasurer Karen Henderson, Road Superintendent Clay Burleson, Fire Chief Jerry Jones, Sheriff David Doran and Chief Jailer Lesa Martinez.

The issue of a tax freeze question on the General Election ballot then came up. It was explained that the Secretary of State had ruled that the Commissioners don't have the authority to place the item on the ballot without a petition asking for the action. The men indicated their intention to rescind their earlier decision to place the item on the ballot at a future meeting.

In other business the men voted to approve a resolution accepting a Hazard Mitigation Plan presented by Fire Chief Jerry Jones. The plan, prepared by the Concho Valley Council of Governments, is required if the county is ever to receive federal disaster funds.





The state spends a lot of money each year contracting with private vendors for everything from highways to building security.

Responding to a request from Lt. Gov. David Dewhurst, Senate Finance Committee Chairman Steve Ogden (R-Bryan) has appointed an interim subcommittee to make sure taxpayers get the most bang for the buck when the state contracts for services.

"Texas needs to do a better job negotiating and executing its contracts with private vendors," Ogden said. "State agencies and state contractors owe nothing less than their mutual best efforts and complete transparency in serving the citizens of Texas."

Sen. Judith Zaffirini (D-Laredo) will chair the subcommittee.


### **Project ChildSafe...**

In addition to their handcuffs, Texas game wardens are carrying another form of mechanical restraints these days --- gun locks.

The Texas Parks and Wildlife Department is giving away 80,000 gunlocks to Texas hunters. Part of the national Project ChildSafe initiative, TPWD will give a free gunlock to each student taking the required hunter safety course.

The department also will hand locks to hunters drawing the privilege to hunt in state parks and wildlife areas and others routinely encountered by game wardens.
