



Warren Jeffs arrested in NV

Warren Jeffs, the fugitive leader of the Fundamentalist Church of Jesus Christ of Latter Day Saints is a fugitive no longer. He was arrested Monday evening near Las Vegas, NV after a routine traffic stop on Interstate 15.

Jeffs, wearing typical tourist garb (Tshirt, shorts and tennis shoes) was riding as a passenger in a red 2007 Cadillac Escalade driven by his brother, Isaac Jeffs. One of Jeffs' polygamous wives, Naomi Jessop Jeffs, was also a passenger in the car.

Nevada Department of Public Safety trooper Eddie Dutchover reportedly pulled the Escalade over shortly before 9:00 p.m. Nevada time because its license plate, a dealer tag from Colorado, was not legible. At that time, Isaac Jeffs handed the trooper a Utah driver's license and a vehicle registration in another name.

Warren Jeffs reportedly offered a contact lens receipt from Florida in the name of John Findley as his identification. All that was more than enough to trigger Trooper Dutchover's law enforcement instincts. He called for backup and asked for permission to search the Cadillac.

What the officers found, including unopened letters addressed to President Warren Jeffs, convinced them that they not only had a person of interest in custody, but that they were face-to-face with one of the FBI's Ten Most Wanted

Fugitives

FBI agents were summoned from Las Vegas. Upon further questioning at the scene Jeffs admitted to his identity. He would not elaborate, however, on his previous whereabouts, saying only that he is a victim of religious persecution.

Jeffs, his brother Isaac, and wife Naomi, were taken into custody and transported to Las Vegas for questioning. Isaac Jeffs and Naomi Jessop Jeffs were later released.

Interestingly, Naomi Jessop Jeffs is the daughter of Merril Jessop, the current overseer at the YFZ Ranch near Eldorado.

Warren Jeffs underwent several hours of interrogation before being booked into the Clark County Detention Center. At the same time, the contents of the 2007 Cadillac Escalade were being inventoried. Police found more than \$67,000 in cash, a large quantity of prepaid gift cards, 14 cellular telephones, mobile radios and police scanners, laptop computers with global positioning sensors, a quantity of knives, three female wigs, and a duffle bag of unopened mail, some of it addressed to President Warren Jeffs.

At press time, Jeffs remains in the **Clark County Detention Center awaiting** a preliminary extradition hearing. He is currently wanted in Utah on felony charges of Rape as an Accomplice and **Conspiracy to Commit Sexual Conduct** with a Child. The charges stem from his involvement in arranging, ordering and

performing marriages between his older male followers and underaged girls.

Jeffs is wanted in Arizona on similar charges. It remains to be seen if he will fight extradition to either of the states, or will waive extradition and head back home to stand trial.

There is much speculation about the possibility of Jeffs being released on bond by Utah and/or Arizona. Authorities there say Jeffs is a flight risk, as proven by the length of time he remained at large. They are prepared to argue that Jeffs should be held without bail pending trial.

Still, the issue of bail remains in the hands of the courts. In and of themselves. the state charges against Jeffs, are not serious enough to automatically disqualify him for bail.

State authorities in Utah and Arizona have hinted that other charges may be filed against Jeffs once they have him in custody. There is also a great deal of speculation that additional federal charges may be filed under organized crime statutes.

Jeffs first rose to prominence when he succeeded his father as President of the FLDS Church. The church's adherence to fundamental Mormonism, particularly the practice of polygamy or plural marriage, have placed it at odds with state and federal law for a number of years. Warren Jeffs forced those long simmering problems to the surface when he began assigning under aged girls as SEE JEFFS ON PAGE 3

School board adopts 6.26 million budget

The Schleicher County ISD board of trustees met Monday and adopted a 2006-2007 budget and tax rate.

The meeting was called to order at 6:04 p.m. with all members of the board present.

A public hearing to receive comments on the 2006-2007 budget and tax rate was on the agenda, but no members of the public were present to comment.

The board moved straight into discussion about the budget. Finance Director Ray Ballew outlined the new budget for the board.

The trustees voted to adopt a \$6,261,736.00 budget for the 2006-2007 school year.

The next item on the agenda was the 2006-2007 proposed tax rate of \$1.37.

The tax rate passed unanimously.

Before entering into their executive session, the board approved the budget amendments and teacher salary schedule.

The executive session lasted from 6:47 p.m. and was recessed at 7:39 p.m.

No action was taken upon return to regular session.

Head-on collision kills two SA women

Two San Angelo women were killed Sunday in a violent head-on collision 4 miles south of Eldorado on U.S. 277. Melanie Cox, 64, and her sister, Charlotte Reynolds, 70, died at the scene. Cox's husband, Leslie Alan Cox, 64, was freed from the twisted wreckage of the 2003 Oldsmobile Silhouette van he was driving by emergency personnel from Eldorado and Sonora. He was taken by EMS ambulance to Schleicher County Medical Center. He was later transferred to a San Angelo hospital.

Antonio Esparza, 57, of Eldorado, was the lone occupant in the second vehicle, a 1995 Lincoln Continental. He, too, was pulled from the mangled remnants of his car by emergency personnel using the Jaws of Life. Esparza was taken by ambulance to Hudspeth Hospital in Sonora. He was later transported by aircraft to Brooks Army Medical Center in San Antonio.

DPS Trooper Norbert Ortiz investigated the accident. He reports that the Oldsmobile van was headed southbound with a caravan of vehicles headed to a church function in Sonora.

Esparza was traveling northbound when he reportedly fell asleep and veered into the path of the oncoming van.

Apparently neither driver had time to react to the impending collision since no skid marks were noted at the scene. Ortiz said both vehicles where traveling at relatively equal speeds when the impact occurred. The vehicles came to rest facing in the opposite directions they had been traveling.

Units of the Schleicher County Sheriff's Department and Eldorado Volunteer Fire Department were dispatched to the wreck. So was an ambulance from Schleicher County EMS. However, since the ambulance service's backup unit was out of the county on a basic transfer, two additional ambulances were called from Sonora. Also responding to the scene was Dr. Gordy Day from Schleicher County Medical Center as well as three DPS troopers and three officers from Sutton County.

The two women were pronounced dead at the scene by Schleicher County Justice of the Peace James C. Doyle.

Security issues get top billing at border conference

AUSTIN - Texas hosted the 24th annual Border Governors Conference, Aug. 24-25.

Officials from the Lone Star State, New Mexico, Arizona and California met at the state Capitol with governors and officials from the northernmost Mexican states.

Border security was the main topic, and Homeland Security chief Michael Chertoff spoke. Other topics included commerce and security. Meetings were held

behind closed doors.

Gov. Rick Perry told reporters that commerce and immigration are concerns that come after security in his book, and that he doesn't plan to wait for the federal government to tighten up the border.

Outside, immigration policy protesters and counterprotesters expressed their opinions in 100-plus degree heat.

In El Paso a couple of days before the Austin conference, Perry said increased joint law enforcement in the borderlands has helped lower the crime rate in some communities.

"When you increase patrols, you decrease crime," he said.

Governors capped the border conference by co-signing a letter to congressional leaders, urging lawmakers in Washington D.C., to pass legislation enhancing border security and controlling immigration.

In mid-August, the state of Texas supplied El Paso County more than \$2 million to work with federal, state and local law enforcement agencies to disrupt organized criminal groups involved in violent crime, gangs, human trafficking, money laundering and

good old days immigrants had "No need to march through the streets demanding that others accept the Germans, the French, the Irish."


The most insightfully astute observations came from a reader in Texas:

The narrow, winding roads of the Big Island

We'll go back to the Big Island of Hawaii. We did a lot in the week we were there, but there are so many more things we want to see and do. Like malasadas. Portugese donuts. We never had any. They are hot items on the BI. When we went to a bakery to get some, they were sold out.

I also want to spend more time at Polulu, one of the most scenic spots. I want to perhaps stay at Waimea, voted one of the top places to live in the US. I want to visit the seahorse farm between Kona's airport and harbor.

We had visited Oahu and Kawai before and fell in love with both of those islands, but the Big Island seems to be more diverse. The beautiful flowers and trees are there for sure. At intersections of main streets in Kona, acres of pink and white bougainvillea drape the hillsides.

We visited coffee and macadamia plantations; saw bananas, papayas and mangos ripening on trees. We saw fan palms and coconut palms. Coconuts fall from trees without much notice and some people get hurt every year when a coconut bonks them on



their heads.

We went to the Sheraton nearly every night to watch the Manta Rays feed on plankton. The hotel has a big overlook and shines bright li hts into the water so visitors can see the huge sea creatures maneuver along the rocky shoreline. They have a wingspan of 16 feet and their movements are mesmerizing.

We drove along the island's perimeter, stopping occasionally to visit a waterfall, intriguing valley, or botanical garden. Most roads are only two lanes and if you can drive 40 MPH you're doing well. We watched Pilot Whales accompany us when we took a boat ride in the Pacific. We watched giant sea turtles come ashore to lay eggs. We lunched at a beachside restaurant and saw people of all ages play in the surf with boogie boards. We stood at high overlooks and looked

down at places where the water meets the land. The Pacific water is warm and near the shore it displays at least half a dozen colors, from deep blue to a light turquoise.

We went to the place where the Hawaiian Islands were first formed by tons of lava shot into the air from a volcano. We walked through clouds of steam coming from deep inside the earth. We had a picnic while watching boiling lava hit the sea.

Perhaps our greatest adventure was watching a sunset from the top of Mauna Kea, the tallest volcano on the island (elevation 13,792 feet). From sea floor to summit it towers more than 5.6 miles. The summit is covered with observatories, which attract astronomers from all over the world. Big Island residents ski and snow board on the summit in the winter when it is covered with snow. We wore heavy parkas and big gloves when we were there in late July. The temperature was 32 degrees, quite different from the 100-degree weather along the coast.

The Big Island is 120 miles North to South, 100 miles East to West.

More park funding, chairman says Texas law devotes \$32 million a year from the state sporting goods tax to maintain the state parks system. But the parks are only getting a fraction of the revenue.

Result: the parks aren't doing so well. In fact, there's a whole lot of crumbling going on. It's no wonder, with some 10 million people visiting each year.

On Aug. 24 the Texas Parks & Wildlife Commission met with its 17member Parks & Wildlife Advisory Committee.

Former state Sen. John Montford, chairman of the committee, suggested using the entire state sporting goods sales tax for parks to increase funding by about \$85 million per year, with the Legislature's approval.

"Virtually every major Texas newspaper in recent months has devoted either editorial or column space to supporting our state parks. The time for action is now," Montford said.

Whooping cough initiative begins

The Texas Department of State Health Services launched a whooping cough education campaign Aug. 21.

The agency is spreading the word about new vaccines that can protect people ages 10 to 64 against whooping () cough, or pertussis.

Last year the health agency reported more than 2,000 whooping cough cases with nine deaths. Eight of those who died were infants.

Symptoms include runny nose, sneezing and a cough similar to a cold, severe coughing fits and coughing spells lasting more than six weeks.

He and Texas Ranger Brooks Long traveled to Colorado three weeks ago to interview a confidential source. It was then that they learned that Warren Jeffs brother Isaac Jeffs was the man in charge of transporting the FLDS prophet from place to place.

That information proved to be correct Monday and Doran says he feels more than a bit vindicated, especially after taking heat from Arizona Attorney General Terry Goddard several months ago.

"It was easy for them to point fingers and say that we weren't doing anything here in Texas," Doran says. "It's just that we weren't playing the thing out in the media the way the politicians in Arizona and Utah are accustomed to doing."

Even though the afternoon temperature might still be pushing triple digits, hunting season begins anew on Sept 1. "Opening day" of dove season is a celebration of sorts for Texas hunters; a time to get afield and made new friends and rekindle old friendships. While bagging a limit of doves is high on our list of "to do's", just "being there" with family and friends and celebrating the hunt is what keeps us returning to the dove fields on opening day each year. Hopefully, you can still find the time to shoot a few clay targets before the season clay targets thrown with an expensive hand thrower before your hunt will work wonder on your percentages. A trip to a sporting clays range or a round or two of skeet or trap is even better.

with cut over grain fields and dead vegetation as is common in late summer. Dove have well defined flight paths and learning where to set up to intercept birds is the name opens. Practice with case or two of the game for a successful dove shoot. I like to spend a little time looking over a field I plan to hunt and pattern the birds. Once I note the route they are using from roost trees to feed and water, I try to set up in a location that puts me with shotgun range. It's often necessary to adjust positions a time or two to find the best location. Dove, just like any game bird, waterfowl or big game animal, must be handled properly in the field in order to taste good on the table. Through the years, I have had folks tell me they just don't like the "gamey" taste of doves and other game birds. These same folks are very apt to carry a downed bird around in their game bag in 95 degree temperature for hours before "breasting" it out and putting it on ice. It's tough to beat fresh doves coals. Placing a sliver of jalapeno pepper on the dove breast, wrapping the breast/jalapeno with good smoked bacon and grilling is standard procedure for Texas dove hunters. Last August, I hunted white wings down in Mexico at Rancho Caracol. On one morning shoot, the combined number of birds harvested was well over five hundred and every one of them was properly taken care of in the field an expertly prepared that evening.
