



WILL ELDORADO REMAIN DRY,

Back in 1903 Eldonado and Precinct one voted to lay aside the sale of intoxicant drinks by a vote of 37 to 33 and since that date Eldorado and precinct one have always votea in the dry columns and Saturday will furnish another opportunity to try to bring bach booze in the form of 3.2 beer. Do you want it, if not come to the polls Saturday and cast a vote to keep it out.

How the previous electons were: July 22, 1911, for prohibition 199; against, 56. May 24, 1919, for prohibition 95; against, 53. Then in last years election for the state, Eldorado voted 135 against the sale of beer and 121 for the sale of beer. Since that election precinct four oted dry by about 7 to 3.

WHO KILLED BII JOHNSON? Friday morning April 6, 1934, Bill Johson was beaten to death by one C. M. (Whip) Jones and Lawrence Deuron, Johnson was working on the Highway near Eden Texas, help ing his fellow man get by the swollen Brady Creek, trying and making an honest living for his wife and babies. Two intoxicated men came a long, fell upon Johnson and actually beat him to death, and fired shots at others who tried to interfere. After beating Johnson to death they stopped W. J. Noguess a well known former citizen here, and abused him but left him. When arrested 6 hours later they claimed they did not know they had killed any one. They remembered having had some kind of trouble but were drunk and did not remember the incident.

Who killed Buy Johnson? Bill was sober, had a wife and some babies at home, yet he was killed because two drunks came his way, filled with intoxicants they took his life. booze took the life of Bill John-

President Roosevelt in his official proclamation, Dec. 5, 1933, said, "I ask especially that no state shall by law or otherwise authorize the return of the saloon either in its old form or in some modern guise." Then we might ask what constitutes or makes a saloon. In the old days it was a place where liquor was sold and drank over the bar, or sold to be carried away, and now where 3.2 has been voted back, most of our Cafe's sell and serve beer or liquor where it all is allowed. The old saloon had its restrictions, but

No. 2 cream is too sour to grade No. 1 and may contain slightly off flavors and odors and shall be reasonably free from exeraneous and deleterious matters. No. 3 cream shall be any cream which will not qualify as No. 1 or No. 2 cream, and which consists of all cream containing oily, yeasty, musty, onion or any other similar flavor or foreign fats and scrap butter that would render it unfit for human consumption ...
