





Government Officials and the Public to Maintain Bank Standards

Bank Standards TWO elements beside the bankers themselves are required in order to give the nation universally the type of banking it should have, Francis H. Sis-son, president of the American Bank-ers Association, declared in a recent address. He said that the efficiency of government officials upon whom the people rely to supervise the banks properly, and the patronage of the kind of banks a community shall have. "There can be no question that the kind of the United States should have "There can be no question that the people of the United States should have

"There can be no question that the people of the United States should have banks immune from failure and wholly free from bad or questionable banking," Mr. Sisson said. "It is not enough, as President Roosevelt has said, that while some bankers had been incompe-tent or dishonest, this was not true in the vast majority of our banks. A sit-uation should exist in which there is not even a small minority of bankers open to question. There should be no room for dishonesty or incompetency to exercise any influence in banking anywhere. "While bad faith and bad manage
