So Groom Schools can once again be commended for its high rate of educational values and its graduates being recognized as some of the best.

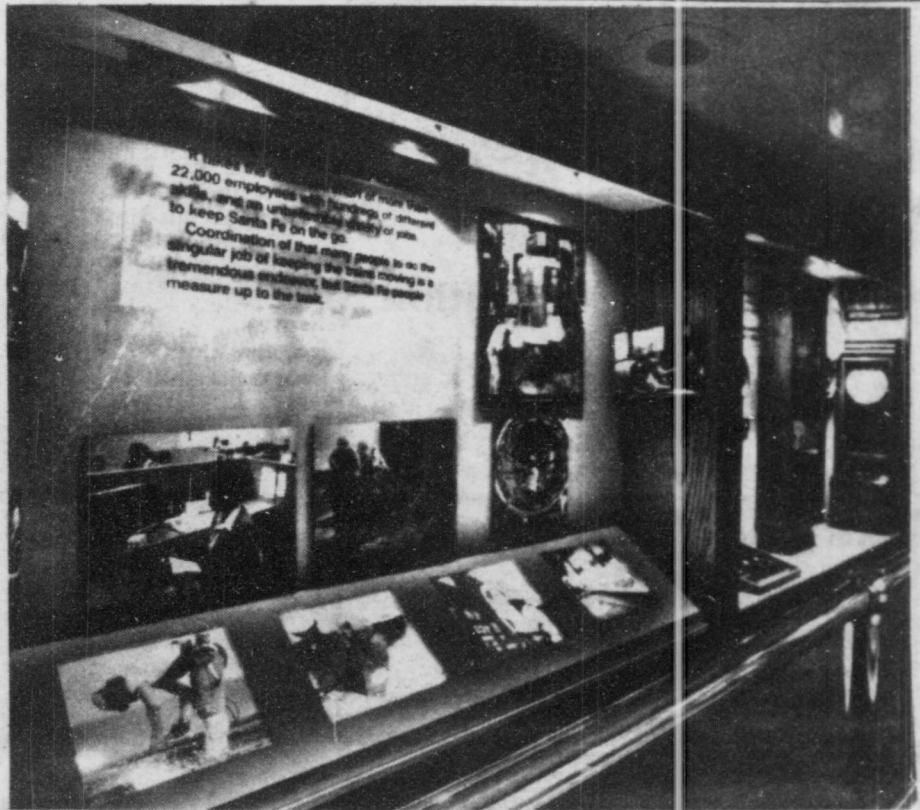


School Parking Policy Reminder

Museum Day/County Birthday Coincides

Always an area-wide event, the 23rd annual Carson County Square House Museum Day in Panhandle has even more reason to celebrate this year

than ever before.

The day-long museum celebration on Saturday will be held in conjunction with the 100th anniversary of the charter for Carson County.

Tigers Fall Short In 4th

Groom Tigers faced the Bovina Mustangs for what should have been the third non-district game of the season. The Tigers fell to the McLean Tigers with a score of 12 to 16. Groom now stands 1-2 gaining a forfeit and two defeats.

Denver Riddle punched the last 6 yards as Bovina rallied in the last quarter for a victory over Groom.

The Tigers jumped ahead 12-0 in the first half as Michael Rose returned a punt 60 yards and passed to Kevin Kerlee for 50 yards. Two extra-point kicks were missed.

Groom held the 12-0 edge until Coy Kirkpatrick pegged to Bud Venable for 38 yards. Venable kicked the extra point. Then came Riddle's deciding touchdown. Again Venable

kicked the point.

It was Bovina's first win after two setbacks.

Groom had seven downs over Bovina's 5 and 186 yards rushing over Bovina's 84. Groom had 60 yards passing above Bovina's 59. 246 yards were gained by Groom while Bovina managed 143. Groom completed three out of the 12 passes intended, while Bovina completed 3 passes out of the 6 passes attempted. Penalty yards totaled 5-45 for Groom and 4-40 for Bovina.

The Tigers will face Lazbuddie on home turf Friday night at 7:30 p.m. Lazbuddie is coming to Groom with a big win under their belt, after their Friday night game against Silverton

view through October. An antique clothing show, displayed from the museum's collection, will join the other two exhibits. Gowns and dresses from the 1860's to 1930's will be exhibited on handmade mannequins in the Freedom Hall Building of the Museum Complex, according to Don Markham, museum director who also fashioned the mannequins.

The annual Museum Day program, beginning at 2 p.m. in the Panhandle High School auditorium, will commemorate Carson County's Centennial. Jay R. Roselius will conduct the salute and Bill Waters, chairman of the M.K. Brown Foundation, will give the keynote address on "Looking to the Next Century."

Waters has practiced law in Pampa since 1949 and was elected district attorney of the 31st Judicial District in 1954, serving for 14 years. In

1965, Waters was president of the District and County Attorneys Association of Texas and is now a member of the nine-person Professional Ethics Committee appointed by the Supreme Court of Texas.

Pianist James Rauscher of Amarillo College will provide the program's musical entertainment. Rauscher is a summa cum laude graduate of the University of Wisconsin-Eau Claire and has a master's in piano performance from the University of Illinois. He is working toward his PH.D in fine arts from Texas Tech University. Rauscher performs with the Amarillo Symphony and is the accompanist for Mary Jane Johnson, opera soprano.

The Pioneer Tea and Reception will be from 3:30 to 4:30 p.m. at the War Memorial Building. Hosted by the Federation of Women's Clubs, the reception lets visitors and pioneers get together during the afternoon.

Santa Fe Railway's "Exhibit Car" will be on display 9:30 a.m. to 5:30 p.m. Friday and Saturday, September 23-24, at the old Santa Fe depot, 100 South Main, in Panhandle as part of the Carson County Square House Museum's "Museum Day" celebration.

The refurbished rolling museum contains various railroad artifacts spanning the company's 120-year history as well as exhibits on modern operations, fashioned out of a baggage car in 1979, the 85-foot long

museum will be open free to the public.

Included in the Exhibit Car's 12 displays are a history of the railroad from its start in Topeka, Kansas in 1868; a history of locomotives used in the past 120 years; and a shadowbox of transparencies illustrating the various job skills practiced by the company's 21,000 employees.

A collection of antique timepieces is one of the most valuable exhibits in the car. America's railroads were the first to use standard time zones which was necessary more than a century ago to coordinate train schedules.

The newest display added this year highlights the corporate art collection, one of the oldest and largest collections of Southwest Art in the United States. The exhibit features some of the uses of art applied to commerce.

In a communications display that includes the nostalgic as well as the modern, a bamboo hoop once used to pass train orders to a moving train and an old telegraph key are contrasted with the modern telephone, portable radios and radio base stations used in today's railroad operations.

Another display emphasizes engineering and mechanical innovations in railroading such as the Fuel Foller, a skeletal intermodal car. Its light weight saves the company more than a million gallons of diesel fuel annually.

The remaining displays feature other aspects of railroad operations such as the different sizes of rail used, unit train operations for bulk commodities such as coal and grain; and the grade crossing safety program called "Operation Lifesaver."

The annual barbecue will be served from 4:30 to 7:30

p.m. in the County Agriculture Building. Some 375 area citizens donate, prepare and serve the food. The meat, cooked slowly over mesquite in barbecue pits, totals 13 beeves.

The Country Store, offering home-baked cakes, breads and pies plus crafts, will open at the County Agriculture Building from 9 a.m. to 9 p.m. More than 300 people donate to the Country Store.

A special invitation goes out to all area school teachers to bring their students for a lecture and viewing of the Painting display. They can schedule their classes any time from September 26 through October 30.

BRIEF EXPLANATORY STATEMENTS
OF PROPOSED
CONSTITUTIONAL AMENDMENTS
GENERAL ELECTION
NOVEMBER 8, 1988

PROPOSITION NO. 1 ON THE BALLOT

Senate Joint Resolution 8 proposes a constitutional amendment providing that when the federal government reimburses the state for expenditures of state funds dedicated to acquiring rights-of-way and for constructing, maintaining, and policing public roadways, such federal funds must also be used for those purposes.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment and/or clarification providing that federal reimbursement of state highway dedicated funds are themselves dedicated for the purpose of acquiring rights-of-way and constructing, maintaining, and policing public roadways."

PROPOSITION NO. 2 ON THE BALLOT

House Joint Resolution 2 proposes a constitutional amendment to establish an economic stabilization fund in the state treasury. The fund would consist of one half of the unencumbered balance of general revenues at the end of a biennium and three fourths of the difference between the net oil and gas production taxes received in a fiscal year and the net oil and gas production taxes received in the 1987 fiscal year. During any fiscal biennium, the amount in the economic stabilization fund could not exceed 10% of the total deposited in general revenue in the preceding biennium.

The state comptroller and the state treasurer could decide to trans-

fer monies from the fund into the general revenue fund to alleviate a temporary cash shortage in general revenue. The legislature could make appropriations from the fund on approval by a three fifths vote of each house to make up the difference between anticipated general revenue and appropriations. On approval of two thirds of the members of each house of the legislature, the legislature could appropriate monies from the fund for any purpose.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment establishing an economic stabilization fund in the state treasury to be used to offset unforeseen shortfalls in revenue."

PROPOSITION NO. 3 ON THE BALLOT

House Joint Resolution 5 proposes a constitutional amendment that establishes the Texas growth fund. All investments of the Texas growth fund must be directly related to furthering economic growth and employment opportunities in Texas. At least 50 percent of the fund must be invested in equity and/or debt security for the initial construction, expansion, or modernization of business or industrial facilities in Texas. Not more than ten percent of the fund may be invested in venture capital investments. Of the funds available for venture capital investments, not more than 25 percent may be invested unilaterally, and the remaining investments must be matched at least equally by funds from other sources. The Texas

growth fund will be managed by a board of trustees consisting of four members appointed by the Governor and one member from and elected by the membership of each of the following: The Board of Regents of the University of Texas System; The Board of Regents of the Texas A&M System; The Board of Trustees of the Teacher's Retirement System of Texas; The Board of Trustees of the Employee's Retirement System of Texas; and the State Board of Education. The trustees may set the investment policy of the fund, enter into investment contracts, and take any action necessary for the creation, administration, and protection of the fund. The amendment authorizes the Board of Regents of the University of Texas System and the State Board of Education, in managing the permanent university fund and the permanent school fund, to acquire, exchange, sell, supervise, manage, or retain any kind of investment, including investments in the Texas growth fund. The fund will be phased out after the tenth anniversary of its creation, but the Legislature may create a second growth fund by a two thirds vote of each house.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment to provide for the investment of the permanent university fund, the permanent school fund, and public employee retirement systems in the Texas growth fund created by the amendment, which will directly create, retain, and expand job opportunity and economic growth in Texas."

The McLean City Council met in its regular monthly session on September 13 at City Hall. Members present were Mayor George Green and Aldermen Dale Glass, Wayne Bybee, Martha Jo Bailey, and W.C. Simpson.

In one of the major items of business, the council approved the second and final reading of Ordinance No. 233, setting the ad valorem tax rate at 28.63 cents per \$100 valuation. Last year's rate was 29.6 cents.

A public hearing on the proposed 1988-89 budget was held. No members of the public appeared to offer comments. After a brief review of the figures, the council approved a \$557,670 budget for the coming year. Of this amount, \$418,200 will go into the water, sewer and gas fund to maintain and operate those systems. A portion of this money also goes toward salaries of city employees.

The main source of revenue in this portion of the budget comes from collections for the use of the city's sewer, gas and water facilities.

The remainder of the budget, \$139,470, will go into the General Fund which is used to fund various city departments such as the park, cemetery, refuse department, fire department, Lovett Library and the Ambulance Service. Revenues

Also competing for the title of Homecoming Queen this year were:

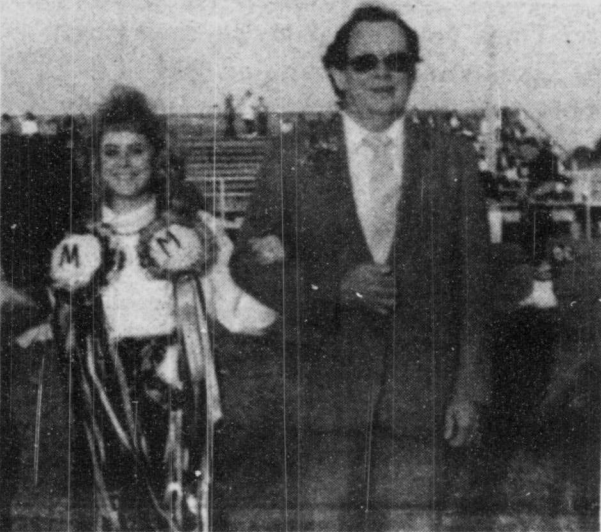

Tigers Impressive In 40-8 Victory

The McLean Tigers came within 37 seconds of throwing a shutout at Friday night's Homecoming game as they defeated the Miami Warriors by a score of 40-8. Playing in front of a large home crowd, the Tigers played tough on offense and defense throughout the entire game.

Receiving the opening kickoff, McLean controlled the ball for 3 minutes and 54 seconds on a drive that went all the way to the Miami one foot line. Great running by Quinton Brown and Tres Hess, and a mixture of running and receiving by Calle Holwick, was responsible for the Tigers' success in controlling the ball. Only a great goal-line stand by the Miami defense kept the Tigers out of the endzone.

The Tigers had to turn the ball over to Miami on downs but the defense quickly went to work and shut down the Warriors' offense. Miami had to punt the ball and Donald Harris ran the punt back to the Miami 31-yard line. After a 3-yard run by Tres Hess, a 28-yard pass from Harris to Holwick gave the Tigers their first score of the night. The extra point attempt was unsuccessful and McLean led 6-0 with 2:19 left in the first quarter.

Miami's second possession started on its own 35-yard line. The Warriors were able to march the ball into the endzone but the play was called back on a holding penalty. The quarter ended

during the Miami drive with the Tigers still in the lead.

As the second quarter opened, Miami was on the McLean 13-yard line. A third down attempt to gain yards was stopped by a good defensive effort from Dale Barker and Robert Sanderson. Going for a score on 4th and 6, the Miami drive was halted as Tres Hess lassoed and stopped the ball carrier. McLean took over on downs at its own 13-yard line.

The Tigers and Warriors fought a tough defensive battle in the second quarter as each struggled for field position. Almost halfway through the second quarter, the Tigers gained possession of the ball at their own 32. With 5:48 left in the first half, running back Quinton Brown shot 48 yards down the field for a TD, giving McLean a 12-0 edge. The extra point kick by Donald Harris was good and the Tigers led 14-0 going into the half.

Miami received the opening kickoff in the third quarter and started at its own 20-yard line. Several plays later, a Warrior fumble was recovered by Caesar Looney at the Miami 21-yard line. Hard running by Hess, Brown and Tony Polito put the ball at the 1-yard line of Miami. On a second down play, Polito crashed into the endzone for the first of his three touchdowns during the evening. With a good extra point kick by Harris, the Tigers led 22-0 with 7:16 left

in the third period.

On its next possession, Miami's offense was virtually immobilized by a great defensive effort from the Tigers. The Warriors were forced to attempt a punt on 4th down and 17 but the kick was blocked by Dale Barker and the Tigers took over on the Miami 23-yard line.

On a third down reverse play, Calle Holwick brought the Tigers down to the 4-yard line of Miami for a 19-yard gain. Two plays later, Polito bulled his way in from two-yards out for another six points. The extra point kick was no good and the Tigers led 28-0 at the end of the third quarter.

The final period of play was a battle for position as each offense tried to move the ball. With 8 minutes left in the game, the Tigers gained possession at their own 31-yard line.
