Man Held In County Jail After Weekend Stabbing Incident

Several Groom residents were awakened by Groom's Emergency phones or sounds of commotion early Monday morning in the area of Martin and Choctaw streets.

Lonny Greene, 32, of Groom was rudely awakened to find himself being stabbed four times, once in the shoulder, on the head, in the temple of the head and a defense wound to his hand. The stabbing occurred between 1:00 and 1:30 a.m. at 108 Choctaw Ave. in the residence of Joyce Greco. Greene was sleeping in the house when the suspect Jackie Allen Dickerson, 52, of Clarendon entered the

house. Greene was able to escape with the knife in his head. He ran out the back door and down the street about two blocks to 207 Martin, residence of Sheila Cline.

Authorities arrived at 207 Martin at 2:17 a.m. Greene and Greco identified Jackie Allen Dickerson as the assailant. Greene was transported by Groom's Ambulance crew to Northwest Texas Receiving Center where he remains in stable condition.

Jackie Allen Dickerson was arrested an hour later in Howardwick, after a warrant from Judge Max Wade was issued. Arresting officers were State Trooper

Gary Davis and the Donley County Sheriff's Department.

Jackie Allen Dickerson was released July 12 from Texas Department of Corrections for a parole violation. His record stated he was incarcerated for auto theft. Dickerson was currently employed by Johnny Brooks of Groom. Dickerson claims Greco to be his common law wife. Greco is employed by Conway Restaurant.

At press time Dickerson was in custody and local enforcement officer Tim Taylor reported Dickerson had confessed to the crime.

Commissioner Britten Votes No—

County Judge's Vote Decides Pay Increase Proposal For County

County Commissioners, in regular session Monday morning, spent most of the time approving and/or discussing financial burdens of county government.

Study on the proposed 1989-90 budget began with commissioners reviewing figures based on a 5 percent salary increase for all elected officials. The lengthy discussion and debate ended with an eight percent increase for the judge, 7 percent for the sheriff, 5 percent for the clerk, treasurer, attorney and tax assessor/collector and an increase for car allowance in the amount of \$100 per month for all four commissioners, being approved for inclusion in the proposed budget. Increases were also included for the of the peace.

The split vote (Strawn and Smith for; Lockridge and Britten against) carried on Judge Roselius' deciding affirmative vote.

The proposed budget appears elsewhere in this

issue of the News for Public Study.

Commissioners also approved amending the County Attorney's budget to include \$953 to pay expenses for part time help. Even with the increase, County Auditor Agnes Bell stated the attorney's budget would not go over his allotted funds.

Commissioner Lockridge reported that 2 1/2 miles of caliche road in Precinct 3 had been completed with the help of Natural Gas Pipeline Company.

Judge Roselius informed the commissioners of a new law which will go into effect August 28, 1989 that will allow counties with a population of under 20,000 to purchase up to \$20,000.00 without securing bids.

In other action, a \$20,000. safe keeping receipt was released to First National Bank of Panhandle. The court also approved an increase of jury fees from \$10.00 to \$20.00, effective September 1, 1989. This is a

fee collected by the county for all cases going before a jury and helps defray the costs of jury trials.

School's Child Nutrition Program Set

Joyce Hutsell, Business Manager for the Groom School District, has announced that the Federal program to assist with child nutrition has been implemented for the 1989-90 school year. "The School District is very fortunate in having a successful food services department in the school, and the Federal program is a valuable asset in maintaining the quality of the service.

"The intent of the Federal program is to assist families in this vital part of children's education in three ways.

"If the program is run according to Federal guidelines, then each lunch served to students is partially subsidized by the program.

"In addition, if families are eligible for some assistance, the Federal program will reimburse the district for part of the cost in making meals available at a reduced cost. The cost for a student breakfast with this program is only 30 cents. The lunch for a student of any age is 40 cents.

"Last, families whose income falls to a certain level become eligible for free meals, and in that case breakfast and lunch are made available to the stu-

dents of the family at no cost.

"Students who are receiving meals through the Federal assistance program are treated exactly the same as students who are charged regular price," says Hutsell, "and the entire program is treated with the greatest of confidentiality."

Income guidelines are published in this issue of the News, so that heads of

families can compare their gross income last month with the income and the number of persons in the household as listed on the income table to gauge if meals assistance is available.

Those who are self-employed should take the adjusted gross income from page one of the 1988 income tax return and divide that

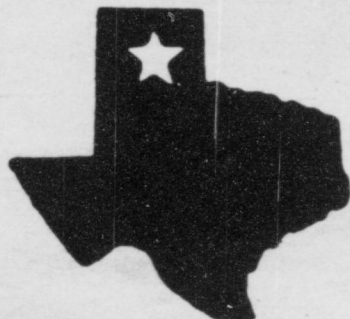

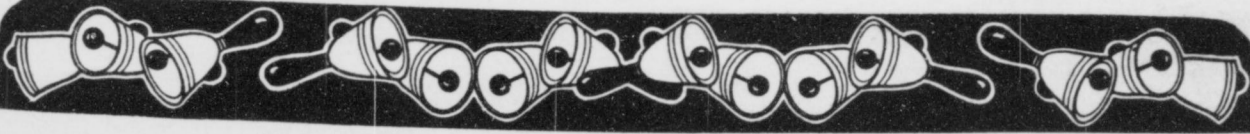

SUBSTITUTE TEACHER LISTS UPDATED

Groom School Principal Judy Babcock is in the process of updating the district's substitute teacher lists for the 1989-90 school year. According to Mrs. Babcock, the personnel files for substitute teachers are required by school policy to contain the same information required for regular professional teachers.

Persons who are currently on the substitute teacher roster should check with Business Manager Joyce Hutsell to verify that their 1989-90 file contains the following: teacher certification, where applicable; a complete teacher-application; a notarized Oath of Office required for State of Texas teachers; and a copy of the high school diploma or latest college transcript showing completed hours of college credit.

School district policy requires that substitute positions are to be filled by the person most qualified to do so. The updated files will assist district officials with compliance in the matters of school policy and state laws and regulations.

"Since the district traditionally requires the services of substitute teachers to check in as soon as possible. If there are any persons who would like to assist the

district when substitutes are needed, we would appreciate having applications on file," continues Babcock.

"It is very helpful if these applications are completed at the earliest possible time," says Hutsell. "Since meals are supposed to be paid for in advance or at the time of the meal, families need to know by the first day of school whether to send money for prepaid regular meals or reduced price meals.

"In some cases, no money at all is required, and it is helpful to have the applications processed prior to the first day of school."

The business office is located at the west end of the school building at 304 West Third in Groom. Hutsell's telephone number at the school is 248-7251.

Social Security Numbers Required

"In accordance with Texas Education Agency guidelines," states Kenneth Sweatt, Superintendent of Groom Schools, "the Groom School District is making every effort to identify those pre-kindergarten aged children in the District who may be in need of classes prior to beginning kindergarten."

The criteria for determining these students are family income, which falls into a category qualifying the family for free and reduced meals on the school lunch program or is non-English speaking, or both. The child should be age 4 by September 1, 1989.

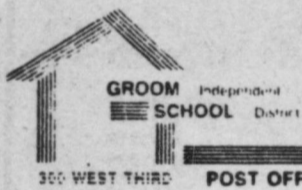

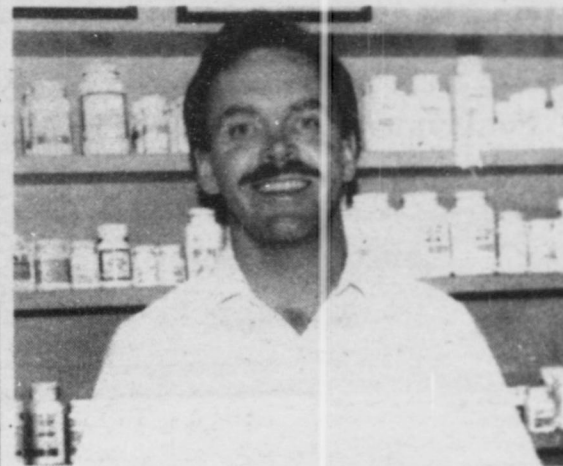

City Sales Tax Up

State Comptroller Bob Bullock said Friday that cities, counties and transit authorities received 9.8 percent more in sales tax rebates this month than they did in August 1988.

"We sent more than \$193 million in sales tax money to local governments this month, and Texas businesses continue to report higher sales tax collections," Bullock said.

Bullock noted that cities received an average of 7.4 percent more income from sales tax this month than in August 1988, and year-to-date payments to cities are up by an average of 9.7 percent over the same period last year.

"We've predicted that the steady growth trend will continue, although it remains spotty in some areas of the state," Bullock said.

Checks totaling \$121.9 million were sent to 1046 cities that have a local sales tax rate of either one or one-half percent.

McLean received a net payment of \$2,237.75 this period. A comparable payment of \$2,093.66 was made during the prior year. Figures show an increase of 6.88 percent. Thus far McLean has received payments totaling \$14,062.53 in 1989. In 1988 payments totaled \$13,525.09 which shows an increase yearly of 3.97 percent.

Another \$11.3 million was allocated to 92 counties that collect the one-half percent county sales tax.

August's checks represent taxes collected by monthly filers in June and by quarterly filers in April, May and June and reported to the Comptroller's office by July 20, Bullock said.

Gary Pitner, representative of PRPC, appeared before council to explain the cost, how system works and installation of the 9-1-1 emergency system. The cost will be 50 cent per telephone customer and will take some time to install and operational. Motion by Billingsley seconded by Bailey, to pass resolution for City to participate in this 9-1-1 plan and authorizing the Mayor to sign contract with PRPC for administration of 9-1-1 service. Vote Unanimous. Motion passed.

Repair or replace heating system at Clinic was tabled for September meeting.

Public hearing for street grant application was held. Discussion concerning the area to use in applying for grant and how scoring for grant is based. Council felt we should try for grant on same bases as 1988 application. A second public hearing will be held September 5, 1989.

Auclair and a passenger, Allen Baumruck, 76, also of Las Vegas, were taken to Coronado Hospital in Pampa by McLean Ambulance. Both were listed in good condition by a hospital spokesman.

Agriculture Commissioner Jim Hightower announced today that the Texas Department of Agriculture has recovered nearly \$1 million for 45 farmers from the Panhandle and Victoria area to help cover their losses for grain they had in storage at failed grain elevators.

"These 45 farmers worked long and hard to produce a crop, and entrusted two grain elevator companies to keep it in safe storage. When the companies failed and the producers lost their grain, TDA saw to it that the farmers were reimbursed for their crop when the elevator assets were liquidated," Hightower said.

"When you put money in a bank, you want the account to be insured. TDA provides the same type of safeguard to Texas grain farmers—we make sure their losses are insured."

Each of the nearly 750 grain warehouses licensed by TDA is required to post a bond and have other proof of financial liability that is used to reimburse farmers who have crops stored in their facility, should it fail.

Reimbursements have recently been made by TDA to producers who had grain stored in Oles Grain Company, which had elevators in Amarillo, Bunker Hill, Exum, Kress, Nazarethth, Perryton, Spearman, Switch, Tulia, Vega and Vigo Park, and to farmers who had done business with Vicotria Grain of Guadalupe. Both companies went bankrupt.

"TDA inspectors regularly audit state-licensed grain warehouses to ensure that their grain is available to farmers when they need it. After reviewing warehouse storage records and copies of negotiable warehouse receipts, TDA inspectors take a physical inventory of the amount of grain on hand," Hightower said.

"Only about one percent of the warehouses checked by TDA have problems with shortages. Most of those shortages are easy to reconcile and the warehouse continues to operate. Those that are unable to cover shortages are placed into receivership," Hightower said.

Oles Grain Company has been in receivership since 1984. TDA recently made disbursements totaling \$270,000 from bond proceeds on the elevators. Bankruptcy trustees have also paid out nearly \$2 million to farmers holding warehouse receipts for grain stored in Oles' 11 facilities.

Victoria Grain has been in bankruptcy since 1986. Depositors at that facility were paid \$650,000 from bond proceeds and cash from the sale of remaining grain at the warehouse.

"TDA will continue to aggressively enforce the Texas Grain Warehouse Act," said Sheila Jackson Lee, assistant commissioner for producer and consumer protection. "Texas grain farmers must have access to the grain that is legally theirs, in the same quantity and quality as when they first brought it to the warehouse for storage."

According to Kenneth Boatwright, director of TDA's seed and grain warehouse program, there are several precautions farmers should take to protect their financial interest at a grain elevator.

"The first thing a farmer should do is to make sure that any grain elevator they use is licensed by TDA or the U.S. Department of Agriculture," Boatwright said. "State or federal licensing ensures that the warehouse is properly bonded."

"The farmer should also obtain a weight ticket for each and every load of grain brought into the warehouse and then a warehouse receipt for the total amount in storage. That warehouse receipt is a negotiable instrument and should be kept in a safe place," Boatwright said.

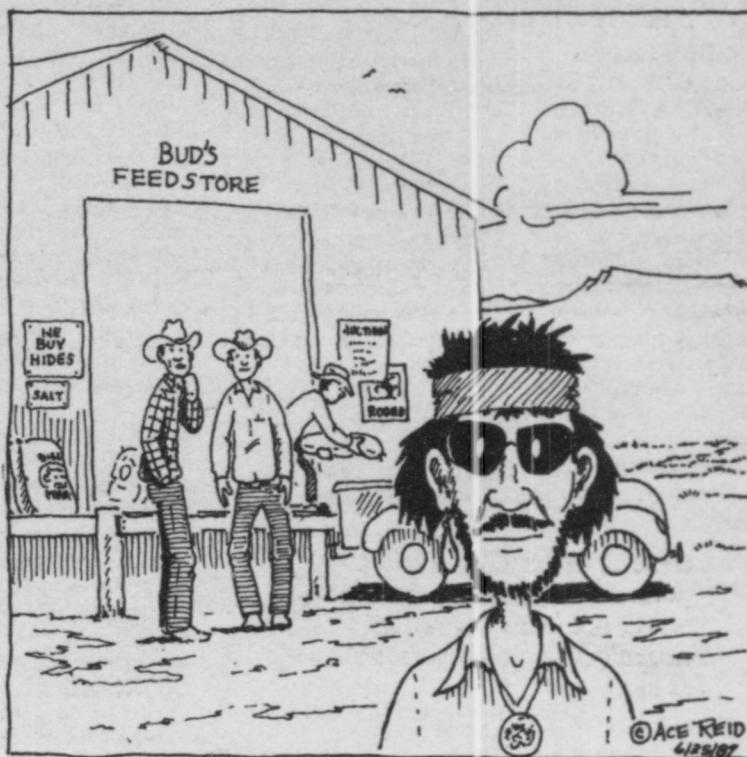

**OUTREACH CLINIC
TO BEGIN**

The Brest Cancer Screening Project of the Don and Sybil Harrington Cancer Center and the High Plains Baptist Hospital at Amarillo will begin a community outreach clinic in Panhandle beginning August 21, 1989, from 1:00 p.m. to 5:00 p.m. at the St. Theresa's Church Parish Hall. The project is designed to educate our community about the importance of early detection of breast cancer.

The clinic will provide low cost screening which includes a breast exam, individualized breast self examination instruction and mammograms. The clinic will be staffed by professionals specially trained in breast cancer detection.

Currently, the most effective method known to win the battle against breast cancer is early detection. Early detection is best done by following the guidelines recommended by the National Cancer Institute for breast cancer screening for women who have no signs or symptoms of breast cancer: 1. Learn and perform breast self examination every month, 2. Have a physical examination including the breasts every year, and 3. Have a mammogram according to the recommendations by age. Age 35 to 40 - one baseline mammogram, 40 to 50 - a mammogram every 1 to 2 years and over 50 - a mammogram every year.



Groom City Council Sets Tax Rate At 50¢

Groom's City Council met in regular session on Tuesday, August 8, at 8:00 p.m. at City Hall.

Members present were: Alderman, Alfred Homer; Alderman, Bill Homer, Jimmy Britten, Ronny Fields and Gregory Lamb. Absent were Alderman, Jerry Thornton.

The first item of business was the opening of sealed bids for the roofing the City Hall. Crawford Roofing submitted a bid for 38 squares at a price of \$3,700. Master Roofing Company submitted a bid for \$4,830.00 for 48 1/2 squares. Parsley's Roofing submitted a bid of \$5,347.50 for 48 1/2 squares. The council will award the bid on August 22.

August 22 was the date set by the council for the second public hearing to consider grant proposal to Texas Department of Commerce.

Gary Pitner, Executive Director of Panhandle Regional Planning Commission presented a resolution to the Council to join the 911 emergency plan. A 50 cent charge per month, per phone customer with additional two tenths of one percent on interstate long distance calls. The total cost of the 911 system will be approximately one and one-

half million dollars. The system will not be operational for 18 to 24 months. The costs will not appear on Groom residents bills until the early part of 1990. Council approved the system.

Dwight Brandt, Engineer and Gary Pitner were present for the public hearing concerning grant proposals. The duo explained the scoring methods of the proposals. Council will consider Grant proposal at the August 22 meeting. Water distubution will be first consideration, solid waste site second and sewer lines third.

Jimmy Britten moved to approve a \$50.00 a month increase in salary for full time employees. Council members discussed the proposed budget for 1989-90.

Bill Homer moved to approve the General Fund Budget for \$65,880.00, water works budget of \$131,630.00, road fund budget of \$33,000.00 and capital improvements of \$25,000. Ronny Fields seconded the motion.

Jimmy Britten moved to order the tax rate to be set at 50 cents general fund and Interest and Sinking Fund at 10 cents for 1989. Greg Lamb second the motion.
