## City Council Refuses Extension To Property Owner Leo Edmondson

The Groom City Council met last Tuesday night in regular session. Bill Homer, alderman, was absent. Also attending the meeting were city attorney Jim Shelton, Leo Edmondson and Donna Burton, representing the Groom News.

After the reading of the minutes the council held a public hearing concerning condemnation proceedings of Lot 6, Block 28, commonly known as the old Assembly of God Church building and parsonage.

During a council meeting in April of this year, Mr. Edmondson and his lawyer, Mr. Ed. Hinshaw of Panhandle, met with council members to ask for a six month extension to clean up the condemned property. The council granted him the extension with the clear understanding that if the October 15th deadline was not met, they would begin litigation.

Mr. Edmondson stated "I could give you nine good reasons why I haven't got it done... but I'm not going to."

Mr. Edmondson worked on the property last April for a few days after the city council meeting and only began work again a few days before the current

meeting.

Edmondson agreed with the aldermen that the place was a fire hazard but felt that there were contributing factors that should warrant another six month extension.

"Trash blows or is thrown on my property" he stated, "I feel like the city should have cleaned it up before I bought it."

Greg Lamb reminded Mr. Edmondson that the property in a sheriff's sale is sold in as is condition, and that he (Edmondson) was aware of the condition when he bought it.

In a later interview, Mr. Edmondson said, "The reason I haven't cleaned up the property is due to technical, legal things in Oklahoma... I was unable to leave (Oklahoma) because I was on bond. The city is not being fair to me."

He also added that he had a lawyer waiting for the city to make the first move.

City Attorney Jim Shelton counseled the aldermen on their next step.

"Once the city has declared a dangerous structure, the city must take action... if problems should occur it increases the chances for potential liability."

Shelton gave the city several options of how to proceed. They can demand payment from the owner for the clean up and file a judgement against the owner. Also a criminal complaint may be filed against the owner carrying a fine of up to \$200.00.

The council voted to have a title search done in preparation for litigation.

In other business the council adopted ordinance #171 allowing updated service credits for employees retirement system.

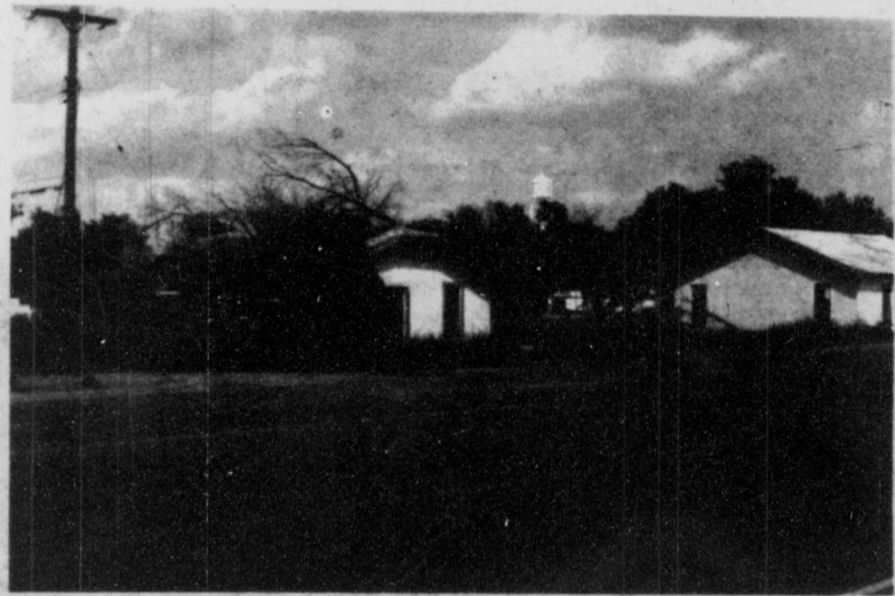
Ken Burger was elected to serve on the Carson County Appraisal District Board.

Discussion was tabled on disposal of tree limbs until the next meeting.

Brown and Grantham were retained as city auditors for another year.

The council approved to accept property donated to the city by Helen Witt.

Mayor Jimmy Britten appointed Greg Lamb to serve as chair and Jerry Thornton to serve on a committee to look into suitable replacements for the christmas decorations the city traditionally puts up. Bobby Cornett will present this at the next G.E.D.C. meeting.

## Texas Law Causes Groom School Board To Change Nepotism Policy

The Groom Independent School District Board of Trustees met last week in regular session. All members were present.

No bids were received from the complete computer system and or the "Writing to Write" software program.

Bids, were however, received for parts of the system. The board unanimously voted to reject those bids as they did not follow the specifications outlined in the bid proposal. The board instructed Kenneth Sweatt to seek the best price for the system needed.

Bids were opened on the two school buses the school has for sale. Two bids were received for \$325.00 each. The board elected to reject the bids.

Kenneth Sweatt was

named to head a committee to identify and assist students with special problems, not considered special education problems. Mrs. Judy Babcock will also be a part of the committee.

The board voted to have the south gymnasium doors replaced. They are old and outdated. The two narrow doors will be replaced with one wide door.

Discussion was held concerning the need for a pole barn. The bus barn is too short for the new bus. With plans to purchase another bus next year, the need for protection against the elements for the schools investment has arisen. Although the board took no action at this time they are considering several options.

Texas law relating to nepotism having changed, required the school trustees

to update the local policy regarding the same. The law, simplified, allows boards to hire their first cousin as opposed to the third cousin in previous laws.

In other words a board member cannot hire their spouse, child, grandchild, brother, sister, uncle, aunt, niece or nephew, parent, grandparent or great grandparent.

If the relationship is one by marriage the board members cannot hire his spouse's parents or child, or if the prospective employee's spouse is a board members parent or child. Also if a board member's spouse is the prospective employee's grandparent, grandchild, sister, or brother. Death or divorce terminates relationships by marriage.

### NOTICE OF RATE INCREASE

The City of Groom was recently notified of a rate increase effective November 1st from Browning Ferris Industries. BFI handles all of Grooms waste collection, hauling and disposal.

The increase is due to legislative changes made with 1 House Bill 11, Article 9, that increases the state landfill tipping fees. Under the old law the rates were 50 cents per ton or 17 cents per cubic yard of compacted waste and 10 cents per cubic yard of uncompacted waste. The new rates will be the greater of 50 cents per ton or 50 cents per cubic yard of compacted waste or 10 cents per cubic yard of uncompacted waste.

The new rates will be:  
Residential - \$10.50  
Senior Citizen - \$9.00  
Commercial - 1.5 yd. - \$30.00  
Commercial - 3.0 yd. - \$39.00.

Berggren also was preceded in death by a son, Scott in 1960.

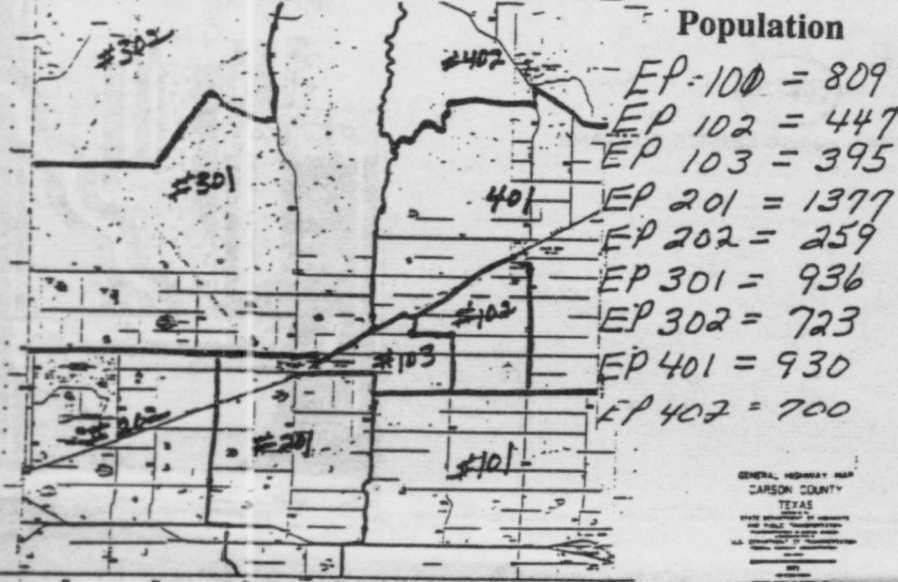
Survivors include a daughter, Elizabeth Ann Tabor Trimble of Farwell; two sons, Dale Berggren of Farwell and Davey Berggren

### ORDER ADOPTING COUNTY ELECTION PRECINCTS

WHEREAS, the Commissioners Court of Carson County is charged by Article 42.001 of the Texas Election code to divide the county into compact and contiguous election precincts; and

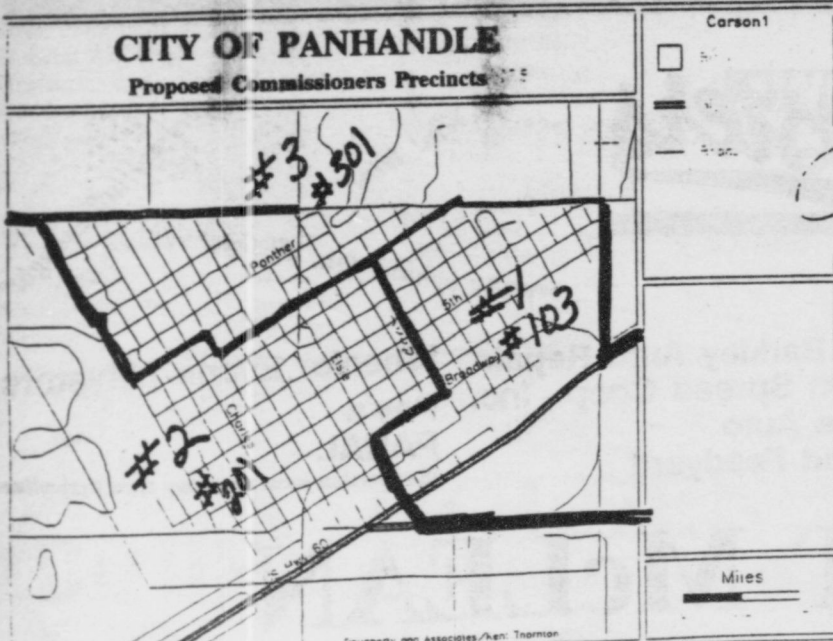
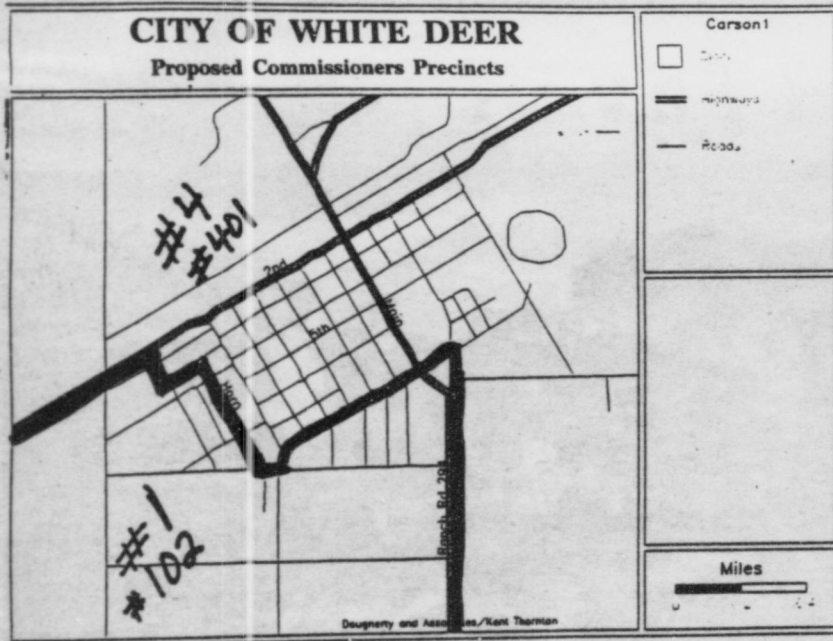
WHEREAS, it is necessary to change boundaries of County Election Precincts in Carson County to conform with new County Commissioner and Justice of the Peace Precincts; and

WHEREAS, the Commissioner Court of Carson County, through a series of public hearings and meetings, has received and has considered oral and written testimony and evidence regarding the need for the alteration of certain Election Precincts.

THEREFORE, BE IT ORDERED by the Commissioners Court of Carson County that Carson County, Texas be divided into nine (9) County Election Precincts in accordance with Exhibit A attached to this order, which is a description of the boundaries of each and every County Election Precinct in Carson County, Texas, and which is incorporated into and is made part of this order.

The County Election Precincts ordered herein shall be effective January 1, 1992. BE IT SO ORDERED.

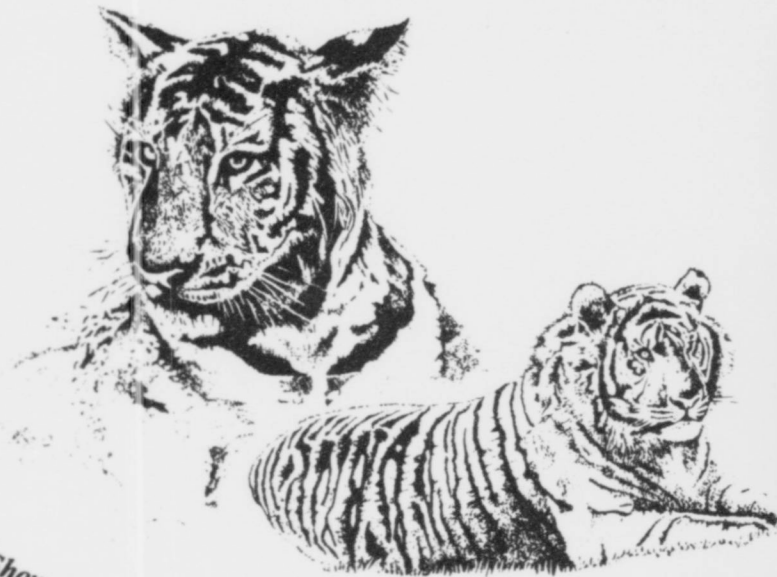

## Public Notice

On July 1, 1991, Southwestern Bell Telephone filed an application with the Public Utility Commission of Texas that proposes to delete Paragraph 3.4(G) from Section 3 of Southwestern Bell's intrastate Access Service Tariff, which concerns credits where a customer uses Switched Access Service to furnish a service which has been defined to be an exchange service. The application was assigned Docket No. 10463.

Because Southwestern Bell is not aware of any customers who presently use switched access service to furnish an exchange service, Southwestern Bell does not believe its revenues will be affected. However, certain interexchange carrier customers of switched access service have made claims under the aforementioned tariff. Such customers, but only to the extent they provide an exchange service using switched access, would be affected by this application. Based on claims made for credits (assuming such credits were allowable), Southwestern Bell's revenues would be affected by no more than \$1,168,962 annually, which is .037 percent of the Company's adjusted revenue for the 12-month period ending December 31, 1990. It is not possible to know how many interexchange carriers might believe themselves entitled to credits, but 189 carriers have registered with the Commission pursuant to PUC Substantive Rule 23.61.

The tariff, after suspension, is proposed to be effective May 1, 1992.

Persons who wish to intervene or otherwise participate in these proceedings should notify the Commission as soon as possible, but no later than November 15, 1991. 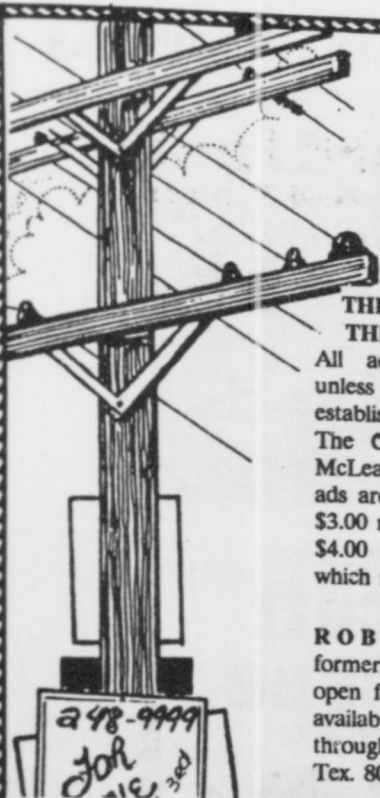

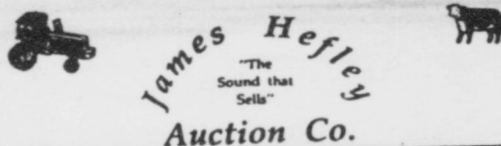
