# Minors Cited With 'MIC' Tickets, Officials Express Consequences

Last weekend, Sheriff's Deputy Jeff Oldham was alerted to an unusual amount of traffic on a little traveled county road. What he found at the end of the dead end road was several Groom youths and one adult who had been drinking. No liquor of beer was found at the scene.

The teenagers were issued a "Minor in Consumption" citation.

The "MIC" tickets carry an up to \$200 fine and the minor must attend an Alcohol Awareness Course. In some cases the parent or guardian may be required to attend with the youth. The fine can be waved in lieu of community service at the discretion of the judge in each individual case.

give community service on first offenses because most of the time the fines essentially punish the parents, not the offending teenager. There are many types of community service jobs, most are menial manual labor.

Had the teens been driving a "Driving under the Influence" ticket would have been issued. A DUI is a Class A misdemeanor for the first offense. It carries up to \$2000 fine and or jail The person time. immediately has their drivers license suspended. When that happens according to Groom's local insurance agent, Johnny Brumley, that persons standard insurance company immediately places a "Do Not Re-instate"

status on their policy.

The offender now must seek insurance from a high risk insurance pool and can expect at least a 60% increase in their auto insurance. If that person is a minor (under 21) their car insurance may increase as much as 100%.

In addition to all of these expensive and embarrassing problems, the person who gets the ticket now has a record with the Department of Public Safety. Only under certain circumstances, does this record get wiped clean. For most people, this record follows them for the rest of their lives.

Let us clarify that while

parts of the law describe a minor as someone under 21, other parts of the law describe an adult as over 17. Therefore, depending on the circumstances of the conviction, the court can hold a 17, 18 or 19 year old as a responsible adult and ask that their debt to society be repaid in the manner of an adult.

Two of the minors are members of the athletics' programs at Groom ISD and they will pay an additional price, as set by Groom School Board policy for extra-curricular activities. They will be suspended or benched for a game as well as do extra work, such as running, while they ponder their mistake.

"This incident is just the tip of the iceberg", states Loren Brand, Carson County Sheriff. "Drinking by underage kids goes on all the time. These kids just happen to be the ones we caught. They are not bad kids, just a little unlucky at the moment."

"It is not pleasant for us to write these kinds of citations...it ruins the kids reputation, upsets their parents and is very expensive all the way around. But we have to think of it in this way...that maybe we are saving the life of this child by making them think twice about doing (drinking or drinking and driving) this again."

#### Alcohol & Minors

Underage consumption of alcoholic beverages is a problem that has become epidemic nationwide. It is a problem practically in every town regardless of size Groom is no exception Our recent Justice of the Peace seminar in Lubbock covered this subject in depth with presentations from the Texas Juvenile Probation Commission and by the Texas Alcoholic Beverage Commission. The Texas Legislature in the last session also recognized the problem and the concern of the parents by enhancing some of the laws concerning minors and juveniles.

Groom has always had strong support for our children through our churches, schools and families. Unfortunately the old tradition of "teenage beer busts" lives on. If you discuss teenage activities with even the oldest citizens, most of the time they can tell stories about their friends and beer in their school days and young adulthood, and if you quiz them, you will find that just about everyone knows of a tragedy that occurred that was alcohol related. This article is not intended to argue the right or wrong of alcohol, but to present the laws that apply to minors and hopefully get the minors and the parents to think about the tragedies that happen and the consequences of the law as it pertains to the young people. This quote was on one of our handouts from the juvenile department:

"The vital, vulnerable years of childhood should be given a first call on societies' concerns and capacities. . .

There will always be something more immediate; There will never be anything more important." (James Grant)

The following list of laws and penalties are excreted to conserve space. The entire text is available at the Justice of the Peace office.

# Adults Like Drinking With Kids

Groom has proven to be no different than any other of the Carson County towns or any other town in the United States, we have big problems with minors drinking alcohol or using illegal drugs. In Groom, the case is primarily beer and liquor. But the huge problem and the one we all need to focus on is who is the adult, or the low lives as well as other names I could use but will not use or print at this time, distributing the alcohol to minors? Also needing looked into is the identification of the store or stores selling to minors or knowingly selling to someone when they know the beer could end up in some minor's hands.

A look at the recent incident of last Saturday night, October 14, when two sheriff's deputies handed out MIC's (Minor In Consumption) tickets to three Groom minors. They were caught north of Groom on a dead-end country road. "There was an adult present with the minors," said Sheriff Brand, "The Texas Alcoholic Beverage Commission has been called into Groom to investigate." It was good work by our Carson County Sheriff's Department.

The ages of the youths given the MIP tickets were 19, 17, and 17. There were other minors at the scene who were not ticketed, but that does not mean they were not drinking to some extent. The quantity was of an amount that made it more difficult for our limited and underpaid Sheriff's Department manpower to determine. These kids were ages

Thanks be to God, there were no deaths or injuries on this night except for some chewed butts and bent pride. I hope this (adult) person knows all the problems he caused the kids, their families, our school, our football team, and our basketball team.

The coaches have had to make very hard decisions concerning this matter. These are never popular decisions, and the coaches are still made to look like the bad guys, when they do not deserve it.

I do not take many stands on issues like I probably should but this hit too close to home for me to let it drop.

So I visited with Sheriff Loren Brand, Deputy Ray Davis, who will return to work next week after bypass surgery, also to District Attorney Randall Sims, County Attorney Ed Hinshaw and Justice of the Peace Bill Hinson to get their opinions on the issue of contributing to a minor, and what they have done and intend to do about situations such as this.

Talk about some folks that can never please everyone! But yet, it is their job. It is what we elected and pay them to do. And like many other unpleasent jobs, someone has to do it.

Deputy Ray Davis told me they know of adults who contribute and encourage minors to drink and it is very difficult to catch the responsible persons. Davis told me, "I had one person in White Deer tell me that we could not catch him at it and there was nothing Davis or anybody else could do about it."

Well, guess what, they

eventually did catch that person according to Sheriff Brand.

District Attorney Randal Sims said, "Yes, I will pursue the case and convict when it becomes a felony charge."

Misdemeanor will pay
\$500.00."

Hinshaw explained that

the law is any school age student caught drinking and driving will automatically lose their license." student who has yet to get a drivers license is caught drinking and driving, there will be no license." Therefore; again, any school age student caught drinking and driving is placing his or her license in jeopardy. The Texas Legislature has enacted laws that simply put, the state does not want kids drinking and driving. And neither do any of the RESPONSIBLE adults in this town.





# As The Interstate Turns

On October 7th Trooper Gary Davis investigated an accident involving a Groom youth who was traveling East on IH-40 Business when he ran off the roadway striking a state sign, slid across the road to the south striking a Groom ranchers fence. The driver then turned around and drove through another section of the fence. Seventeen hours after the accident, Davis located the driver and vehicle involved in the accident. The young man was issued citations for Failed To Drive In A Single Lane, Failed to Report Accident and Reckless Damage.

On October 8th Trooper Gary Davis arrested a White Deer man for Theft By Check in Gray County. The man was placed in the Carson County Jail until the Gray County Sheriff's Office could pick him up.

On October 10th Trooper Gary Davis stopped a Clarendon man on I-40 for failing to stop and render aid on an accident in Amarillo. Trooper Davis got all information and relayed it to the Amerillo Police Department.

On Saturday, October 14th the Carson County Deputies cited several Groom youth for Minor In Consumption of alcoholic Beverages. For those of you who hid the smel of alcohol with chewing rum and gave a false date of birth to the deputies, as a

reminder, giving a false name, date of birth or address to a peace officer is a Class C Misdemeanor.

On Sunday, October 15th a 16 year old juvenile was placed in custody for being a runaway from Douglas County, Georgia. The girl's 18 year old boyfriend was placed in jail for Harboring A Runaway after giving the trooper false information.

On Wednesday, October 18th a Milwaukee, Wisconsin man was arrested for an outstanding warrant out of Illinois for Forgery. The warrant was seven years old. The man was placed in the Gray County Jail on \$25,000 bond.

On Thursday, October 19th two St. Paul, Minnesota men were arrested on I-40 one mile

east of Groom for Possession of Marijuana Less Than Two Ounces. Later that afternoon a Groom woman was arrested for Theft by Check. She was released upon payment of fines.
