> "Voting bonds does not help the poor people who need hospital care. The American Medical Association plan is all wrong. Most doctors starve and the people do not get medical care. One-third of the single practitioner's time is taken up in making out bills and worrying over collections. Ninety-two and one-half per cent of all doctors in this country come under this classification. It is only the top 7%% who make any money.

"The cooperative plan takes care of the doctors as well as the patients, and is the modern way for medical and hospital care."


## SERVICEMEN AND **EX-SERVICEMEN Should Vote**

### YOUR QUALIFICATIONS FOR **VOTING ARE:**

A veteran who has an honorable discharge dated within 18 months of the next elections, and is otherwise a qualfied voter, is entitled to vote without a poll tax receipt or certificate. The law requires that an ex-serviceman does not need a certificate to show the election judge. If the judge is in doubt, he may require the prospective voter to execute an affidavit stating that he is an ex-serviceman and otherwise a qualified voter.
