DO YOU SOMETIMES wonder just what goes on at the various agricultural experiment stations over the country? Here are a few facts concerning work which has been done at the Spur experimental station during the past five years.

Summer grazing experiments with yearling steers on native buffalo and toposa grassland have been conducted annually since 1942.

Stocking pastures at an average rate of one steer to 5.04 acres for a 146-day period to utilize 50 per cent of the grass has increased acre gains from 27 to 29 pounds and steer gains from 93 to 148 pounds per head, when compared with pastures stocked one steer to 3.40 acres to utilize 75 per cent of the forage.

At the close of the grazing season, 57 per cent of 71 head of yearling steers used on light grazed pastures for 6 years graded Low Good or higher in fleshing, but only 3 per cent of 108 steers used on heavy grazed pastures graded Low Good or better.

Rotation grazing on native buffalo and tobosa grassland has not increased gains or improved the grass cover. Pastures with a predominance of tobosa grass that occupy flatter areas have produced greater gains per acre than pastures with a predominance of buffalo grass which occupy sloping land.

Clipping studies on buffalo and blue grama grasses show that harvesting the grass at 2-week intervals markedly reduced yields although fairly good stands of the grasse remained. Buffalo and blue grama grasses produced the highest yield when harvested at intervals of 8 weeks during the growng season, or 62 per cent more grass than when they were clipped at intervals of 2 weeks. The grass cover on heavy grazed pastures closely resembles that on grass plots clipped every 2 weesk. These facts, scattered through the Spur station's progress report, are given here since the climatic factors, etc., at Spur are similar to those in the McLean area. The report issued by the Spur officials will not, naturally, reach all those interested, and these few facts are being reprinted here to aid in the dissemination of this information.





Speed Kills-Take It Easy Speed kills-take it easy

This is the warning issued by Colonel Homer Garrison Jr., director of the Texas Departmen of Public Safety. The departmen in a program is cooperating against speeding which is part f a year-round traffic safety educational program. The continuing campaign, which emphasizes a timely phase of traffic safety each month, is sponsored nationally by the National Safety Council.

Speed is a contributing factor in two out of every five fatal traffic accidents, according to Chief W. J. Elliott of the Texas Highway Patrol. This means that 13,000 persons were victims of accidents involving excess speed in 1947 alone, as revealed by nation-wide accident reports.

"If each driver would take i just a little easier, and not only obey the speed limits set by law but a speed limit set by common sense, we would have fewer deaths and injuries from traffic accidents," Captain Polk Ivy of the Amarillo office of the Highway Patrol said.

"The legal speed limits posted in business and residential districts and on the open highway are for average good driving conditions-dry pavement, good visibility, no unusual traffic conditions for that locality. When conditions are less than ideal. speed should be adjusted ac cordingly. So whenever you drive, wherever you drive, take it easy-and live longer."




