LAST MAY, for the first time in many years, precinct conventions the two major political parties enjoyed a nice attendance throughout the state of Texas. The two voting precints in Mc-Lean were no exception, with both the Democrats and Republicans holding conventions and attracting many more people than ordinarily attend such meetings.

The interest in precinct conventions, and on down through the state conventions, was brought about by desires of people all over Texas. These desires varied: some people were seeking a change in our administration; others liked things the way they are.

But whatever the desires, the voice of the people was heard by professional politicians, a voice which hadn't been loud enough to be heard in many years.

Each election year, two of these precinct conventions are heldthe one in May which has already come and gone, and the next one next Saturday, July 26. Both the Democrats and the Republicans will hold such conventions in Texas on Saturday.

The primary purpose of the precinct conventions is to select delegates to the county convention, which will be held in Gray Couny at Pampa on Saturday, August 2. Where there is an issue to be settled, the precinct convention also instructs its delegates in the matter. This is done at the precinct conventions of both parties

At the county conventions, delegates to the state conventions are chosen. There, also, is decided upon various other matters of policies, etc., which may come up at the state convention. Republican county conventions will also decide on whether they are to submit names of their party for possible nomination by the party at the state convention. In the Democratic state convention, those persons who were nominated in the primaries are certified as candidates in the general election. But, since the Republicans hold no primary election, these candidates must be nominated at the state conventions if they are to appear on the ballot.
