



In order to keep the record straight, the citizens of Gray County ought to know, and deserve to know,

the facts. For that reason, and that reason alone, I respectfully ask your consideration of the letter I

Dear Mac:

My attention has been called to a portion of the contents of a certain letter which Bruce Parker is circulating among the voters of Gray County, which is as follows:

" . . . according to the records my opponent is a partner of Curtis Douglass, an attorney, who defends more drunken drivers in the County Court of Gray county than any other attorney in Pampa ... What would happen to your drunken drivers if the attorney representing them and the Judge were partners?"

A statement such as this should be ignored because it is silly and ridiculous, except for the fact that Parker, who seeks the confidence of the people of this county by asking for a public trust, stoops so low in last minute desperation by inferring that I would try to corrupt you in your judicial capacity, and that you would likely be susceptible. In my opinion, any person who would make such a reckless charge is wholly unfit to hold any public trust, or else simply lacking in intelligence.

You are not a partner of mine and have not been associated with me in the practice since February 1, 1952. Parker could have learned this by asking either you or me, and his failure to do so certainly shows an evil design. In the next instance, everyone knows that even if we were partners and you were elected, I would be disgualified not only at law but also as a matter of legal ethics to try a case before you.

Now as to the drunken drivers and their cases in the County Court of Gray County, the following shows a hurried check of the records in cases where I have represented the defendants. I will not use the name of the defendants, but will show only the date originated and the disposition made, viz:

The above cases are all that I could find on the records. There could be others pending, probably two or three, but you will note that the dates on the above cases go back before Parker was judge, but at a time when he was County Attorney.

The above record speaks for itself.

If Parker is proud of this record, very well, and I can assure you that I did not try to corrupt him or use any improper influence upon him in the making of it. His failure to produce came either from a lack of knowledge of his duties, or else a failure to perform.

I had no idea I would be brought into, and made a subject of dispute in your race. I have no business with Gray County and seek none. I pay my taxes and that is about the extent of any business transaction I ever hope to have with the County. But in view of such a wild charge, one that imputes dishonesty not only to you, but also me, I consider it my duty to write you this letter.



WHAT HIGH FEDERAL taxes and inflation are doing to family incomes in Texas and other states is brought out today in a report by the West Texas Chamber of Commerce.

Taking an average family of four (husband, wife, and two children) that all of you would enjoy such as an example, the WTCC showed how today's family incomes at various levels compare with those earned in 1940 after Federal income taxes are deducted and due allowance made for the reduced purchasing power of the dollar as the result of inflation. A \$10,000 family today has \$8,226.40 after taxes. But its purchasing power is \$4,439.99 in 1940 dollars. In 1940 this family had \$9,560 after taxes.

The \$100,000 family has \$43,968 after Federal income taxes today and this income has the purchasing power of only \$23,303.04 in 1940 dollars. But in 1940 this family had \$57,051.60 after taxes. Looking at the picture another way, the WTCC brought out these additional facts with due allowance for taxes and inflation:

A family of four today must earn a net income of \$4,165 to equal a 1940 income of \$2,000.

A \$3,000 income earned in 1940 compares with \$6,595 earned today.

A \$4,000 income earified in 1940 compares with \$9,010 today. A family which earned \$5,000 in 1940 must show a net income of \$11,480 today to maintain the same standard of living.

Seeding the cover crop of rve. wheat, austrian winter peas, hairy vetch, or a mixture of these in version of sunlight. fore the cotton is harvested is the best method.

There are several ways to plant the cover crop without injury to the cotton. The seed may be sown by hand and covered with the cultivating plows. Some farmers use a regular grain drill and remove the appropriate discs to miss the cotton rows.

Several farmers have had good success adapting the old one-row horse-drawn drills to their tractors.

The district has two drills especially designed for seeding cover crops in cotton middles. These seeders may be rented from the district at 25 cents per acre. Farmers are urged to locate their cover crop seed now and be ready to plant as soon as moisture conditions are favorable.
