

PUBLIC SCHOOLS TO COLLECT CLOTHING FOR NEEDY CHILDREN

Beginning Monday, Dec. 7, local school children will bring bundles of used clothing to school during World Clothing Week. According to Superintendent Freeman Melton Jr., the drive will continue thru Friday, and is part of a nationwide campaign to raise used clothing, shoes and bedding for orphaned and needy children and adults in the United States and overseas. World Clothing Week is conducted by the schools in cooperation with the Christian Children's Fund, Inc., a charitable organization which assists orphans and other needy children in the United States and 36 countries of the world.

Superintendent Melton had this to say when announcing the drive, "We expect World Clothing Week to be one of the finest service projects ever conducted by our schools. The clothing collected is used in handicapped areas of America by CCF to help needy children—some of whom can't even attend school regularly because they have no coat or shoes. It goes to orphans and other needy children in the United States and overseas. Also, free clothing is distributed during disaster emergency situations. Every student has been given literature to take home explaining the purpose of the drive and asking the cooperation of their parents and friends."

Melton continued: "The Christian Children's Fund reports that good used clothing is one of the most vital needs of children and adults in the world over. Through World Clothing Week, the school children of McLean will see to it that many needy boys and girls will be warmly clad this winter. At the same time, our own young people will be learning a valuable lesson in humanity, and experience the joy that comes with sharing with those less fortunate. I hope the citizens of our community will get behind the schools in this effort. Send all types of wearable infants', children's and adults' clothing and shoes to school during World Clothing Week."

Since 1938 the Christian Children's Fund has been aiding needy children. Today, it assists over 26,000 orphans in more than 315 orphanages in 37 countries. In addition to the United States CCF operates its programs in Africa, Austria, Belgium, Bolivia, Borneo, Brazil, Burma, Canada, Chile, England, Finland, France, Greece, Hong Kong, India, Iran, Indochina, Indonesia, Italy, Japan, Jamaica, Jordan, Korea, Lapland, Lebanon, Macao, Malaya, Mexico, Okinawa, Pakistan, Philippines, Puerto Rico, Syria, Taiwan (Formosa), Viet Nam and Western Germany.

TV CABLE SYSTEM TOWER GOES UP

A 170-foot tower for McLean's new cable system of television reception is presently under construction. The tower will mark the first major step in the installation of the cable system, which will solve at long last the problem of viewable TV reception in McLean.

Dale Greenhouse, co-owner of the system with Ted Simmons, stated that cable and poles had been procured, and with the installation of the tower, the cable will be laid.

Construction of the cable will move from the tower, located in the northwest corner of town, across the residential district. Spurs will be run from the main cable into every block of residences. Presently Greenhouse did not state a definite completion time, but said work would commence as rapidly as possible.

Proclamation

OF "Spiritual Civil Defense Day"

LEST WE FORGET, and perish! We remember the tragedy that struck our nation on Sunday, December 7, 1941, when we were wantonly attacked at Pearl Harbor, and

WHEREAS, evil forces more sinister and deadly than those rampant at Pearl Harbor are now at work among us, conspiring to destroy the United States of America, and

WHEREAS, we see daily the increasing evidence of the subtle efforts of these evil forces to subject man's body, enslave his mind, and destroy his spirit, and

WHEREAS, in this ever-present threat of another more devastating Pearl Harbor not only our material wellbeing and our military might, but also our spiritual, moral, and intellectual strength are being attacked, infiltrated and subverted by militant atheism, and

WHEREAS, the American concept of life is founded on the belief that it is "In God We Trust," and that we must be "One Nation Under God, Indivisible, With Liberty and Justice for All," and

WHEREAS, the churches and synagogues are the bulwark of our nation's faith and primary source of our moral strength and spiritual power, and

WHEREAS, President Eisenhower, recognizing the urgent need for individual preparedness for survival by every American, has designated December 7, 1959, as Civil Defense Day.

NOW THEREFORE, I, John C. Haynes, Mayor of McLean, Gray County, Texas, do proclaim Monday, December 7, 1959, as "Spiritual Civil Defense Day," and sincerely urge all people to give earnest thought and prayerful consideration to the awesome threat of complacency hanging over us, and to the diabolical communist conspiracy infiltrating our society.

I urge all spiritual and intellectual leaders to alert our people to the threat to our freedom and to lead them in services of worship, dedicated to the survival of our religious heritage, our moral values, our intellectual freedoms and our national liberties, on Saturday, December 5, or Sunday, December 6, as their customs dictate, and to seek a great united expression and demonstration on the part of the people on December 7, to determine to exert every effort to cooperate in the National Plan of total civil defense, thereby doing all in our power to not only be prepared for, but to deter and avoid the devastating cataclysm of a nuclear holocaust.

Bids Opened For Housing Project

Construction to Be Completed in '60

McLean's Housing Authority opened bids Tuesday last week for the construction of the government housing units, which will be built in the near future.

Present at the bid opening were representatives from four construction companies, in addition to Jack Whitworth, architect, and commissioners of the housing authority.

Bids submitted were Hayes Construction Co.—\$132,500; Baker Construction Co.—\$137,500; Farrel Lumber Co.—\$142,627.29; and Penhall Construction Co.—\$166,788.

Plans are now being made to commence with the construction of the units. A number of steps must still be taken in satisfying government regulations before actual building can begin.

THANKSGIVING BRINGS FIRST SNOW TO AREA

McLean's first snow of the season came in early Thanksgiving morning on the heels of a blue norther that engulfed the entire Panhandle of Texas.

Two inches of snow that fell Thursday gave a slow soaking 78 inch of moisture to the ground. Late Thursday and early Friday, however, warming temperatures rapidly melted the snow and by late Friday the ground had been mostly cleared.

The cold weather reached south to central Texas, but snows fell only in the Panhandle area. Clarendon received only a trace and Childress had only freezing rains.

After the cold front passed, temperatures have been warm and presently, no more of the cold is in sight.

Cotton Allotments To Be Set

Cotton acreage allotment for the 1960 upland crop are now being established for all the eligible farms in Gray County, according to the county agricultural stabilization committee. Notices of the allotment will be mailed to farm operators well in advance of the December 15 referendum.

Evelyn J. Mason, county office manager, pointed out that the 1960 allotment—representing the county's share of the state allotment less any acreage reserved for new cotton farms—is divided among farms on which cotton was planted or "recorded as planted" in 1957, 1958 or 1959. An allotment may be "recorded as planted" if it was "reserved" under the soil bank conservation program or if it was otherwise preserved under some local provisions. The minimum farm allotment for "old" cotton farms is the smaller of 10 acres or the farm's allotment for 1959.

Editorial

Editor's Note: In place of a regular editorial this week we would like to present a few observations by Columnist Sydney Harris who appears locally in the Amarillo Globe-News. We think Mr. Harris' observations are particularly keen and intelligent and hope they will provoke a few thoughts for you as they have for us.

CHICAGO—Purely Personal Prejudices:
When a man makes a promise against his nature, I will bet on the nature against the promise.

Advising a troubled person to "see your minister or doctor" is ludicrous or futile in most cases—for neither pastors nor physicians are specially trained and equipped to handle emotional disturbances, nor do they have the time for intensive personal counseling.

Parents should live for their children, but not through them: the parent whose satisfactions are wholly reflections of their children's achievements are as much monsters as the parents who neglect their offspring. Nothing can deform a personality so much as the burden of a love that is utterly self-sacrificing.

We may look for a suitable mate but we will not find one until we first learn what to overlook.

The next time some poor devil of a defendant is being badgered on a witness stand, charitably keep in mind that no life could withstand the sharp scrutiny of two hours, cross-examination by a shrewd and well-paid lawyer.

In order to justify his behaviour to himself, a thief has to believe that everybody steals, in one way or another; thus, we reshape the world to conform to the image we have of ourselves. (Even in the arts, for instance, many persons who cannot appreciate serious music believe that most music-lovers are cultural frauds.)

A teacher who tries to be "democratic" is as absurd as a ship's captain who lets his crew cast votes on the course and the destination.

The harried executive, his pressured wife, and their over-organized suburban children might not care to ponder the words of Nietzsche, when he observed: "Whoever has not two-thirds of his time to himself is a slave."

Those who always play for safety eventually find out that the most dangerous thing in the world can be the refusal to take a chance.

The hardest lesson for a gifted person to learn is how to avoid giving offense; as the Goncourt brothers wrote of a colleague who came to grief: "He did not possess enough tact to make people forgive him for being talented."

It takes much more character to be creatively idle than to keep busy doing nothing of consequence; this is why most men are utterly lost when they retire from the routine of their business lives.

A relentless analysis of motives is fatal to a good relationship between the sexes: when couples talk a great deal to each other about themselves, they draw farther apart, not closer together, for they are substituting discussion for direct experience.

We suspect only those faults in ourselves which we feel capable of committing ourselves—which is why the virtuous are so naive and the wicked are so cynical. It is, for instance, utterly impossible to convince a thief that everybody is not at heart likewise a thief.

Some people are so addicted to looking on the dark side that, upon emerging from a tunnel, they would

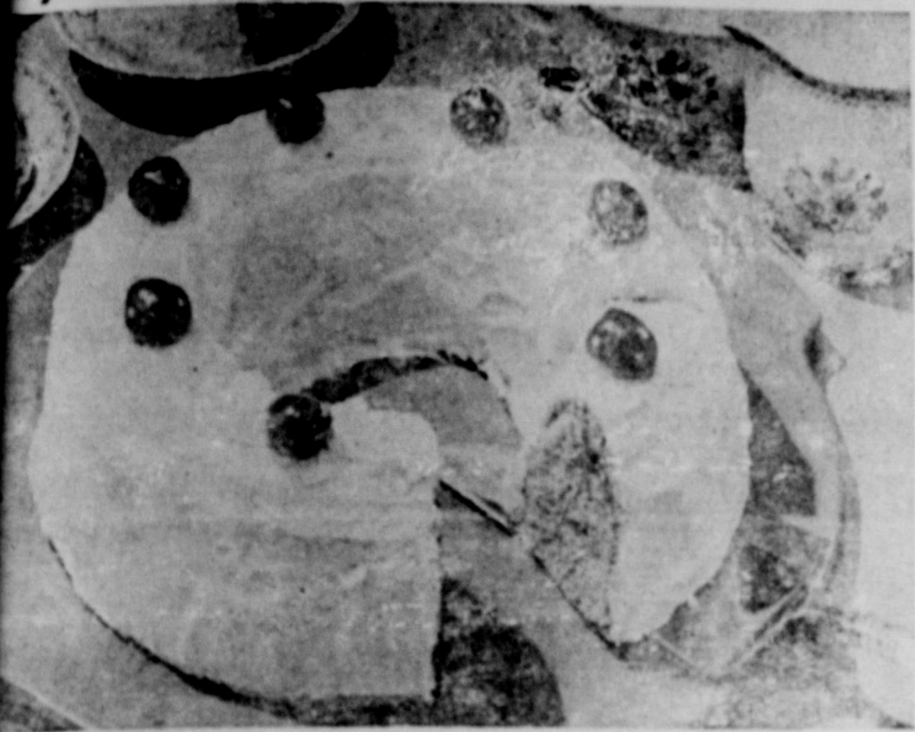

eggs, vanilla, vinegar and ban-

margarine mixture; mix well.
Turn into greased and floured
9-inch layer cake pan. Bake in
moderate oven (350 degrees F.)
45 minutes, or until cake tests
done. Cool. Sprinkle with con-

BANNER: Texas' Court of Criminal Appeals has a long record for gathering its full complement of justices on such precarious footing as the point of a needle, and hacking hairs in twain with a dull machete. 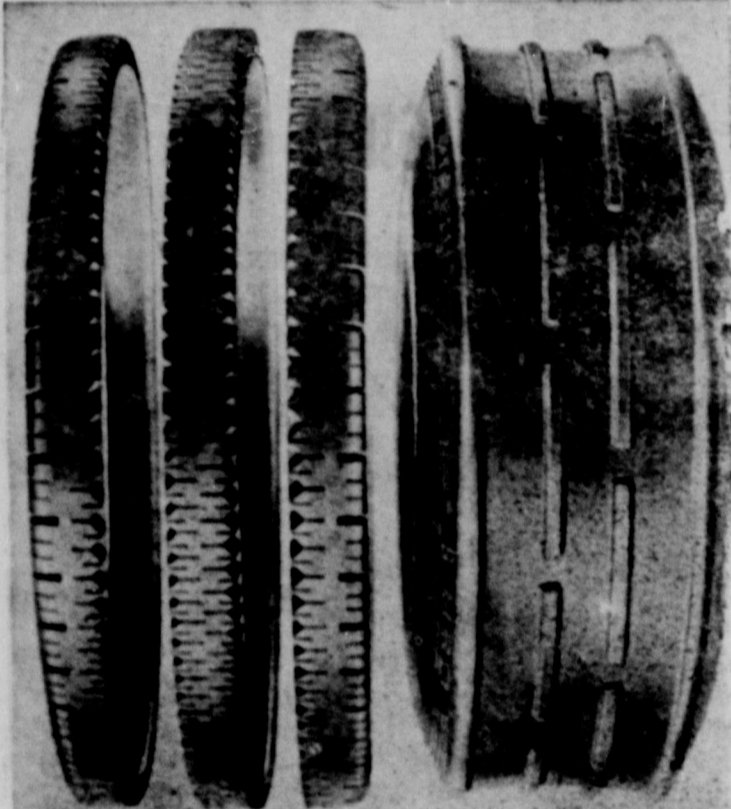
BANNER: Now that the public is becoming uncomfortably aware that many institutions of society are "rigged"; that deception is enthroned and accepted as a part of the American Way; and that truth is becoming as infrequent as the presence of a pregnant nun at Wednesday night prayer meeting; let us proceed to another situation where honor and integrity has given way to corruption. I refer to deliberate and calculated perjury in a court of law, and to the practice of giving false testimony. There was a time in Texas when a man found giving false testimony in a judicial proceeding was prosecuted and sent to jail, as indeed the law still requires. When a man held up his right hand, placed the other on the Bible, and swore the testimony he was about to give in the cause at hand would be the truth, nothing but the truth, "so help me God"—it had damned well better be just that. But no more. I have never known of a man who testified falsely under oath to be charged with it, a felony under the law. I do not even recall that one has received

reprimand from the bench. Our judicial proceedings have turned into lying contests, with the most prolific and convincing liar walking off with the verdict. I am assured by our own county attorney that perjury is the most difficult case to win in Texas.

The judge's charge to the jury in a perjury case, he says, is the longest and most complicated one. At the end of recitation of such a charge, the jury is likely not to know what town it's in, much less, what decision should be rendered. I do not recall that Charles Van Doren was indicted for lying before a New York grand jury, which is the only illegal act the poor devil committed. I am told that nothing can be accomplished by filing perjury charges against our own Charlie Mooney for falsely testifying under oath that he owed this newspaper nothing. If there are no consequences to lying under oath; if courts merely ask for rather than demand truthful testimony; if blatant lying under oath is to be taken so lightly by courts of law and by the people they serve—then it should necessarily follow that youth's best preparation for the vicissitudes of economic existence is a marked excellence in the ability to lie, and stick with it.
