Stan S. Smith, 71, County Judge Since 1944, Died Here of Pneumonia Attack

Stanley Smith, 71, county judge since 1944, died here of pneumonia Friday following a brief illness.

Smith, who had been suffering from leukemia and who had surgery in Galveston the year, had just returned from Galveston where he was living with his malady frequent trips to the doctors was keeping it

Services were held from the Methodist Church at 3 Monday afternoon, with the Rev. Morris Bratton, pastor, conducting the services. County Approves Plan For Del Rio Road Improvement

Val Verde & Crockett To Join In Request To Hiway Dept.

Crockett county Commissioners Court in session Tuesday put this county's stamp of approval on a long range improvement program for Highway 163 from Ozona to Del Rio and agreed to assume its share of right of way cost on condition such costs are reasonable and the project is launched by the State Highway Dept.

The action clears the way for a joint Crockett-Val Verde county request to the State Highway Department to start an improvement program on the state highway which would include, widening, straightening and rebuilding of the road to carry the expected increase in traffic once Amistad dam on the Rio Grande above Del Rio is completed. The road as it exists today is responsible for a large number of traffic deaths in recent years.

The court's action this week came after a committee from the Ozona Lions Club, which has been carrying on negotiations with a similar committee from the Del Rio Chamber of Commerce, reported to the court on its conference with Del Rioans. The Val Verde court has taken similar action and District Engineers for the State Highway Department in the Del Rio and San Angelo districts have been consulted. Next step will be a joint request of the two counties to the Highway Department to put the project on its calendar.

The road building project is expected to be a long range one and the sooner it is started the sooner it will be available to meet the renewed traffic demands when the big lake above the new dam becomes a reality and a mecca for area fishermen and sportsmen, the committee and court agreed.

Wildcat Located In Northwest Crockett

Romac Co., Midland, will drill the No. 1-A Haun, a 1,400-foot San Andres wildcat in Crockett County, eight miles southwest of Rankin and 3/4-mile east of the one-mile Hanson (Grayburg) field.

Location is 2,574 feet north of the southeast (river) corner, thence 390 feet west to the location in 881-1-I&GN.

Returning for the new season will be Don Nell Carnes, Beverly Alford, and Janie Lara, all three starting forwards from last year's team, but at guard the picture is not so promising as only Glenda Friend will return from among the guards who started last season.

Glenda was an all-district performer last season, the only one the team has had thus far, but the replacements for the two graduated guards will be Coach Gotcher's biggest problem.

Lettermen returning to the squad other than the starters include Robin Jones, Janet Mason, Pauline Maness, and Charlotte and Gail Johnigan.

The Ozona girls will open their home season next Monday when they entertain the Sterling City girls at Davidson Gym.

RALPH JONES NAMED JUDGE WALKER SHIFTED TO PREC. 1, FLOWERS NAMED IN PREC. 2

Acting speedily to get the county's business moving following the funeral Monday of County Judge Houston Smith, who died Friday, the Crockett County Commissioners Court named one of its members, Ralph Jones, former Precinct 1 Commissioner, as the new county judge to succeed Judge Smith.

Then in more rapid fire action, Commissioner C. O. (Lefty) Walker, serving an elected term in Precinct 2, resigned as commissioner from that precinct and was appointed by the new county judge as commissioner from Precinct 1, filling the just vacated post.

The new face in the reshuffled court will be that of Richard L. Flowers, who was appointed by the new county judge as Commissioner from Precinct 2, succeeding Walker.

All of these appointments will be for a period of a little over a year. Under the law, appointments by the Court and by the judge to fill vacancies in the judge's post and on the Commissioners Court can be only until the next general election. The next general election will be in November, 1962, with terms of present officers expiring January 1, 1963.

The effect of the shifting of offices will be that three instead of two County Commissioner posts will be up for filling in next summer's elections instead of two as would be the case in the ordinary course of events. Both Walker and Flowers are appointed only until the next general election, and both will have to seek re-election in next year's election if they would serve beyond the appointive term. Even numbered precincts, No. 2 and 4, will reach term end next year and the candidate in Precinct 2 will be after a four-year term but in Precinct 1 it will be for a two-year term, so that the alternating odd and even number election sequence would be restored in the county. The next election would regularly have called for the election of the county judge and the race next summer will be for a four-year term in that office.

RESOLUTION IN MEMORY OF JUDGE HOUSTON S. SMITH

WHEREAS, on the 10th day of November, 1961, it pleased the Great Judge of the Universe to remove from the Bench of Crockett County, Texas, our beloved Judge, HOUSTON S. SMITH; and

WHEREAS, Houston Stanley Smith, was born in Leonard, Fannin County, Texas, on the 27th day of February, 1890, and moved with his family to Schleicher County in 1904. He attended school in Eldorado and the University of Texas and in 1913 came to Ozona as a teacher in the Ozona High School, serving as Principal, teacher in History and English and coach of Basketball and Baseball. In 1916, with encouragement from Judge Charles E. Davidson, he returned to Austin and entered Law School. In 1918 he entered the Service of World War I, and was commissioned a Second Lieutenant of Infantry in the United States Army. After being discharged he returned to the University of Texas and received his law degree and in 1919 returned to Ozona, entering practice in Judge Davidson's office. In a few years he became a full partner in the law firm of Davidson & Smith. This association continued until the Judge's death, July 25, 1944. On July 31, 1944 Houston S. Smith was appointed County Judge of Crockett County, Texas; and

WHEREAS, during all of said years he was an able and wise leader of this Court, giving his utmost devotion to his duties, always taking an active interest in the Schools, looking after the business affairs of the County, promoting good citizenship, striving to up-build the Community, and preserving peace and harmony among its citizens; and

WHEREAS, it has been the privilege of this Commissioners Court to work with him for many years where we have learned to love, respect and appreciate him;

NOW, THEREFORE, BE IT RESOLVED that the COMMISSIONERS COURT OF CROCKETT COUNTY, TEXAS, do hereby acknowledge our personal sorrow and loss by having a copy of this Resolution spread upon the Minutes of this Court, as an expression of our thankfulness for his life of service, and we do hereby extend our sympathies to his loved ones, and we order that a copy of this Resolution be furnished to his bereaved family.

A Community Leader Passes

Conservative leadership in politics is such a rarity nowadays that loss or retirement of such a one becomes a double tragedy and a distinct loss to the forces that seek to maintain the American way in the face of ever encroaching isms.

Houston Smith, as Crockett county judge, was a conservative so far as county business was concerned and in his personal thinking as well, even though he was a staunch supporter of the Democratic party as a tradition and sometimes shut his eyes to liberal moves by the northern and dominating wing of the party.

And conservatism is what the majority of Crockett county residents wanted and will want in their county judge. A careful approach to every proposal that required the expenditure of county funds was Judge Smith's nature and his first reaction usually was "no" until the need was proved conclusively and then there was no firmer supporter. And that policy, with the support of a likewise

conservative court, has kept Crockett county in the best financial condition of any county in the United States but at the same time has provided an ideal climate in which residents could enjoy ownership of homes, business and other property with a minimum of local taxes to add to their burden of providing for their families. This with all the necessary protections, modern community facilities, fine schools and the like, notwithstanding the conservative approach of county administration.

Judge Smith's death the past week-end has cast a pall of sorrow over the community. Many a county resident who depended on his sage advice, who enjoyed his learned conversation and who sought his guidance in personal and business undertakings will miss him sorely in the months to come. His handy presence next door to this newspaper, where he was most always available to provide a bit of information, a point of historical reference, or an amusing story of old times in West Texas will be especially missed. Thus, each of us who knew him well will feel our own personal loss most keenly. And the fact that he remained unmarried and that the family he leaves is known less intimately because they lived elsewhere and visited only infrequently, makes the expression of our loss and the manifestation of our love for him disappointingly difficult for us.

But because he set a pattern, or continued in the pattern set by the county's first judge, Chas. E. Davidson, who served it more than fifty years, the county has enjoyed a unique position in the nation for over 70 years. Until there is demonstrable need for a change to a more profligate way of operating the county, it is our hope that the new county judge, whoever he may be, will steel himself to blandishments of the easy way out and resolve to continue a policy that will project this community as one attractive to outsiders who might be seeking an ideal place to make their home because of its economical and sensible local government.

came here to teach in the public schools and in 1915 organized the first basketball team in Ozona High School, a team which beat all comers. At last summer's homecoming, surviving members of that basketball team got together for a reunion to honor their coach and to receive belatedly their athletic letters from him.

While teaching school, he worked in the law office of County Judge Chas. E. Davidson and after three years of teaching, decided to return to the University of Texas to study law. World War I interrupted his studies and he served during that conflict as an infantry second lieutenant. After completing his law studies, he returned to work in the Davidson office and later became a full partner with Judge Davidson, a partnership which continued until Judge Davidson's death in 1944. Smith was appointed to succeed Judge Davidson, who was the county's first judge and who had served a period of more than fifty years in the office.

Born at Leonard in Fannin county Feb. 27, 1890, he moved with his family to Eldorado in his early youth. His father, the late James Monroe Smith, was a captain in the Confederate Army in the Civil War and fought Comanche Indians as a ranger at Fort Griffin earlier. His great grandfather, Howard Smith, fought at Little Horseshoe Bend under Sam Houston and Andrew Jackson and his great-great grandfather was in the Revolutionary War.

A member of the Methodist Church since early manhood and of the Ozona Masonic Lodge since 1914, he was a faithful worker in each. He served as worshipful master of the lodge and as worthy patron of the Easter Star chapter. He was a 32nd degree Mason.

Surviving are one brother, Garland Smith of Sacramento, Calif.; eight nephews, Curtice Smith, Charles Smith and I. O. Campbell, all of Farmington, N. M., S. K. Campbell and Lee Campbell of Torrance, Calif.; Herman Smith of Sacramento, Guy Smith of Arvin, Calif., and James Smith of Ardmore Okla.; four nieces, Mrs. Ruth Closhessy of Farmington, Mrs. Helen Hecks, Albuquerque, N. M., Mrs. Mildred Beesley of Torrance, Calif., and Mrs. Zeda Greer of Arvin, Calif.; and a brother-in-law, S. D. Campbell of Farmington. Also here for the funeral were Glenn Campbell of Ardmore, Okla., a great nephew, and Mrs. Warren Johnston of Artesia, N. M., a great niece. He was never married.
