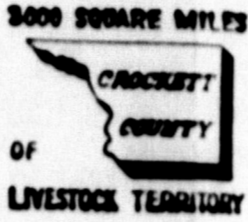

## Ozonan's Stolen Pickup Found In Ciudad Acuna

Officers recovered a pickup, stolen from the home of Al Loudamy Saturday morning, in Ciudad Acuna late Saturday.

They returned to Del Rio Sunday and took a statement from John Peacock, who is in jail there on charges of car theft. The man, who gave his home address as Arkansas City, Ark., was arrested in Uvalde while in possession of a car stolen from Del Rio.

The suspect allegedly abandoned the pickup in the Mexican city, walked across the border and took a car from the Texas town. The pickup was stolen here sometime between midnight and 5:30 a. m.

## County Receives Scattered Rains

Ozona received from 38 to 50 of an inch of moisture early Monday morning, while other portions of West Texas recorded upwards to 6 inches. The rainfall, coming on the heels of a weak front, was accompanied by high wind.

The heaviest fall reported in the county was north of town where the Vaughn ranch reported 1 1/2 to 2 inches. Southeast of Ozona the Ashby McMullan ranch reported 1.12 inches. An unconfirmed report said 6 inches fell on a ranch between here and Sonora.

South of town the James Baggett ranch reported 32 of an inch of rainfall, while further south the George Montgomery ranch received only 2 of an inch. No appreciable amount was reported west of town.

A thunderstorm early Wednesday left a trace of rain on Ozona, but the McMullan ranch and Demp and Ralph Jones ranches all reported another 1.3 inches.

## 5 Hospitalized After Car-Pickup Crash On Hiway

A car-pickup collision at the intersection of Hwy 290 and the Pandale road around 9:15 Monday morning sent five persons to the Crockett County Hospital.

The accident occurred when Mrs. Walter Capps, with Mrs. E. C. Alford a passenger in the 1965 Dodge automobile, attempted to make a left turn onto the Pandale road while traveling west on Hwy 290. A 1965 Chevrolet pickup, driven by Richard E. Reynolds of Ft. Sam Houston and accompanied by his wife and her mother, Mrs. Geridine Kallander, traveling east on the highway, collided almost head-on with Mrs. Capps' car. Reynolds swerved the pickup in an attempt to avoid a collision and hit the right front fender of the automobile, overturning the pickup twice.

Both vehicles were demolished, according to investigating officer, Orville Perry. Reynolds was treated for lacerations and bruises in the emergency room of the hospital and released, while all four women were hospitalized. Mrs. Capps and Mrs. Alford are in satisfactory condition. Mrs. Reynolds and Mrs. Kallander, who was most seriously injured, were reported to be in satisfactory condition yesterday, after being taken off the critical list late Monday.

### Murder Charge Filed In Death Of Aged Man

Juan Rodriguez, Jr. was jailed Friday afternoon on charges of murder and bond set at \$5,000. The charges were filed after an autopsy report from a San Antonio pathologist indicated that the death of Thomas Mar, about 88, could be due to an alleged attack by Rodriguez.

The incident occurred a week ago Saturday when Rodriguez entered the home of Mar, where his small daughter was crying. Rodriguez admitted to slapping the old man when questioned by officers. Both Mar and the little girl were examined by a local physician. The child was found to be unharmed and bruises about Mar's face were thought to be superficial.

Immediately after the incident, Mar was placed in the Crockett County Hospital while officials investigated a move to have him placed in the State Hospital at Big Spring as a senile demented. Mar died late the following Monday night and Sheriff Billy Mills ordered the autopsy.

The case will be brought before the next session of the grand jury. District Attorney Dixon Mahon indicated earlier this week that there might possibly be a called session soon, because of other cases needing the attention of the grand jury.

### Crockett Worm Case Is 39th In State This Year

Mission — Texas recorded its 39th screwworm case here today, May 30, when a larval sample sent in by a Crockett County rancher proved to be positive.

Bud Hoover, who operates the Bill Hoover Estate Ranch 35 miles southwest of Ozona on the Pecos River, said the worm sample was taken from the navel wound of a new-born calf in his herd. Crockett County, in Extension Service District 6, lies immediately north of Brewster and Val Verde Counties where recent worm cases have been confirmed.

Officials at the Mission Screwworm Laboratory, in cooperation with County Agent Pete Jacoby of Ozona, announced immediate plans for treating the ranch. They plan to drop 300,000 sterile screwworm flies over the area at the rate of 100,000 a week for a three-week interval.

Twelve non-screwworm samples arrived at the Mission lab for checking Tuesday, officials, reported. The worm samples were taken from sheep, horses, cattle and wildlife. "We need to keep the samples coming in at a rapid rate so that we can identify and treat cases immediately and keep the infestations from spreading," Dr. M. E. Meadows, Jr., veterinarian in charge of field operations, explained.

### Suburban Co. Acquires Interest In Area Property

Suburban Propane Gas Co. Whippany, N. J. has expanded its gas properties in West Texas.

A 50 per cent working interest in 69 gas wells in Crockett County and a 37 1/2 per cent interest in the Ozona gas processing plant were acquired from Pauley Petroleum Inc., of Los Angeles. Purchase price was not disclosed.

Wells and plant are in the same area where Suburban has a 70 per cent interest in 31 gas wells on more than 12,000 acres in the Ozona gas field.

Suburban now has a gross interest in 172 gas wells, two gas-processing plants, 146.8 miles of gathering lines, and 70,000 acres of oil and gas leases. It has a gross interest in 60 million cubic feet of well-stream gas, with residue-gas sales of 51 million cubic feet daily to two pipelines.

Wells and plant involved in the sale are operated by Delta Drilling Co. The Ozona plant currently processes 40 million cubic feet of gas daily, and produces 50,000 gallons of condensate and 80,000 gallons of LP-gas daily.

**Oil Well Blowout In West Crockett Field Controlled**

A blow-out in a northwest Crockett county well was quickly controlled and resulted in no fire or injuries to personnel late last week.

James G. Brown & Associates, Midland, No. 1 C T. Harris, in 12-3-WCR, unidentified project, 22 miles southwest of Big Lake and 1 1/2 mile north of the Escudido (Ellenburger, Fusselman and lower Pennsylvanian) field, has indicated production in a second unidentified zone with the flowing of gas at the estimated rate of 15 million cubic feet and oil at the estimated daily rate of 600 barrels per hour while the well was out of control for eight hours.

Operator had drilled to 8,437 feet when the project blew out. There was no fire and no injuries. It was brought under control by pumping in a large quantity of heavy mud.

Eighth producer and a 1 1/2-mile south extension was indicated in the JM (Ellenburger) field of southwest Crockett with the flowing of gas at the maximum rate of 22 million cubic feet daily when drilling reached 13,278 feet at Shell Oil Co. No. 11-1-A Mitchell, in 11-Q3-TCRR, 35 miles southwest of Ozona.

It flowed 1 1/2 hours on a 1 1/2-inch choke, making gas at the rate of 9.2 million to 12.5 million cubic feet daily. It then flowed through two 2-inch lines on two 1 1/2-inch chokes, making gas at the

**Dual Producer In Tippett Field**

The Tippett, West multi-pay field of Crockett County gained its fourth McKee producer and a location east-southeast and the same distance south-southeast extension to that pay with dual completion of Gulf Oil Corp. No. 3-E J. H. Tippett, recent third 5,000-foot detrital producer, 8 1/2 miles southeast of McCamey.

It was finalized for 80.4 barrels of 42.6 gravity oil, no water, with gas-oil ratio of 187-1. Production was through a 10-64-inch choke and perforations at 5,842-44 feet, which had been acidized with 1,500 gallons. Tubing pressure was 650 pounds.

Triple completion is being effected from Ellenburger open hole at 6,584-620 feet.

It was finalized May 23 from the detrital for 129.04 barrels of 42 gravity oil, no water, with gas-oil ratio of 1,472-1, through a 10-64-inch choke and perforations at 4,982-96 feet.

Location is 3,781 feet from the north and 467 feet from the northwest lines of 36-31-H&TC.

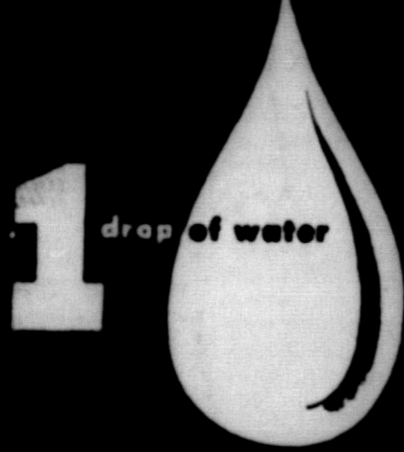

Crockett Water Resources Ample Survey Reveals

Much more underground water is available for development in Crockett County than now is being pumped, according to Texas Water Development Board's latest report, titled "The Occurrence and Quality of Ground Water in Crockett County." Copies of the report were presented to the Commissioner Court here last week by Fred Osborn of the Texas Water Development Board.

Total pumpage of water in the county in 1963 was about 5,670 acre-feet. Approximately 45,000 additional acre-feet could be pumped annually from the Edwards-Georgetown aquifer alone, the

publication notes. Report 46, "Occurrence and Quality of Ground Water in Crockett County, Texas," was written by Hilary H. Iglehart. It was prepared by the Water Development Board in cooperation with Crockett County Commissioners Court.

Water quality in area wells varies greatly, but generally is good. Typically, water is hard and high in fluoride content. Only a few wells are considered unusable.

At several places in the county, oil-field brine has been disposed of by undesirable methods such as dumping it directly on the ground or storing it in open unlined surface pits. Locally, lower water quality has resulted from these practices.

The report says injection of brine deep into the ground is the best method of disposal at present. Disposal by

injection into overflowing wells or wells with corroded casing, however, may contribute to water contamination. Unplugged or inadequately plugged oil or stratigraphic test holes may also be a source of contamination in the future.

The report reveals an amazing volume of brine produced from oil producing wells in the county in the year 1961. In that year, the report reveals a total 47,187,814 barrels of brine were produced. Of this ocean of sea water, all but 1,873,984 barrels were pumped back into deep formations but those near two million barrels were disposed of in open, unlined pits to become a threat to pollution of the county's fresh water supply.

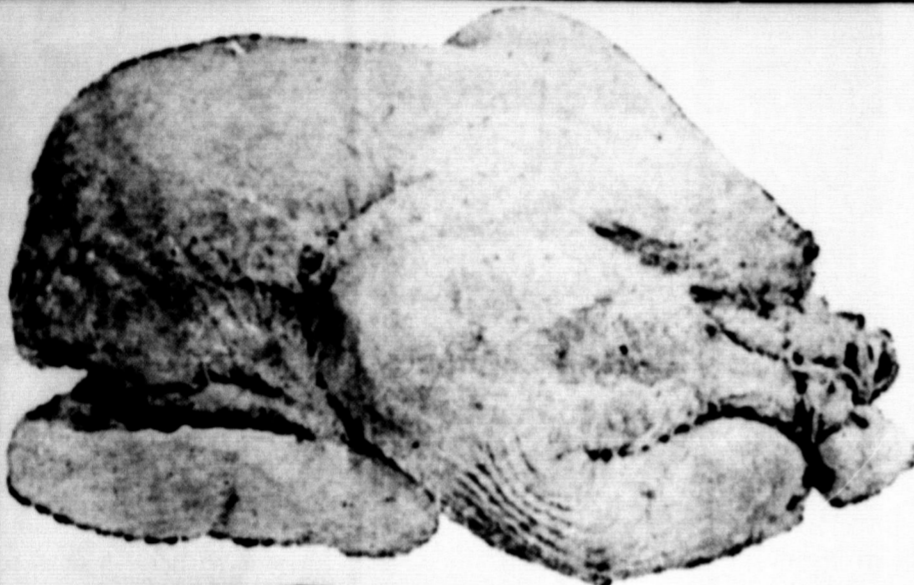

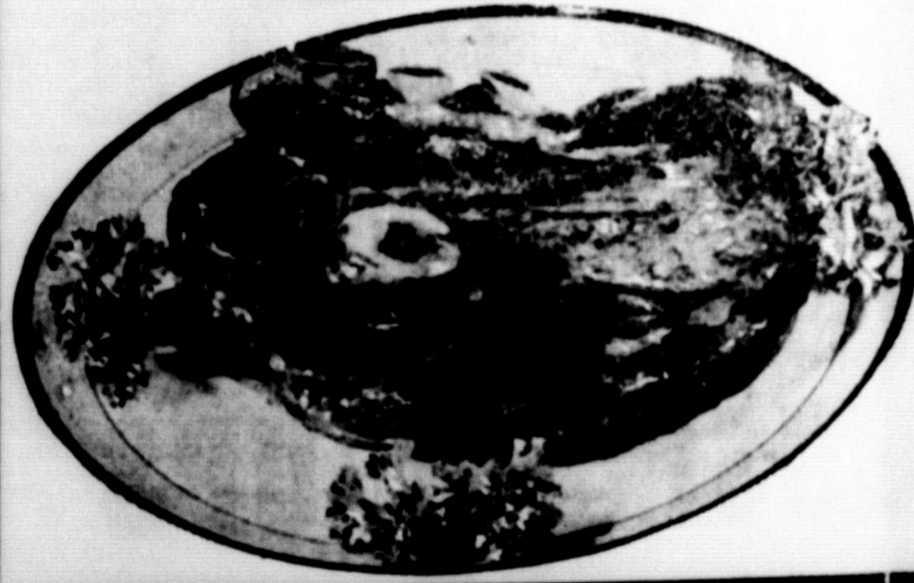

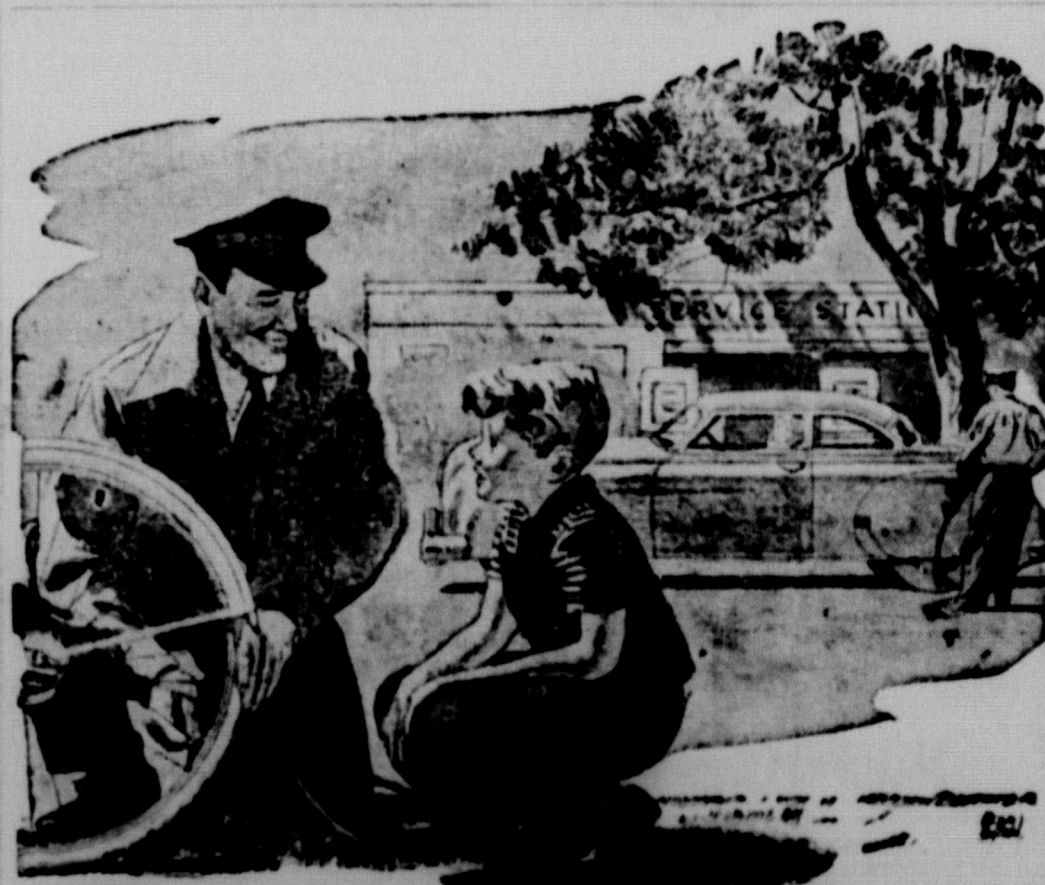

With all members present, the Planning Board met at the fort Saturday morning to organize and to begin its planning. Dr. Jeiks was named chairman of the group and Mrs. Clayton as secretary.

Dr. Jeiks told the committee that their first step would be to decide on the disposition of the fort site. Mr. Meadows suggested that the land be offered the state park and historic site. The Meadows deeded the 3 acres of land to Crockett County and the county is expected to make the offer of the deeded land at the proper time.

Dr. Jeiks then named committees to work on specific parts of the master plan for the partial restoration and development of the fort site between now and August 1 when the planning committee will hold its second meeting.

Named to study and report on construction costs was Mr. Clift, the architect, from Odessa. To estimate needs, planning, construction and interpretation, Dan Scullock of the State Parks and Wildlife Department was named by the chairman. Dr. Dukes, ASC historian, was appointed to do the historical research on the project and to estimate the archaeological work at the site. Dr. Jeiks named himself and Dr. Tunnell, the state archaeologist.

The state legislature in the last days of the just closed session, appropriated \$250,000 to further acquisition and development of historic sites and parks, includ-

ing Fort Lancaster and four other historic sites for first attention. Mrs. Harrell has given outspoken praise to State Senator Dorsey B. Hardeman of San Angelo and Representatives Hilary Doran of Del Rio and Gene Hendrix of Alpine for their efforts in behalf of Fort Lancaster's inclusion in this appropriation.

While on the site, members of the planning committee studied ways of making the site more attractive in its present state and marked a layout of trails for tourist guidance. Plans were also discussed for securing attractive temporary signs to be placed on the fort grounds and preparations of a brochure on the fort for distribution to interested persons.

In discussing plans, members of the committee pointed to the urgency of making the site ready as a tourist attraction by the time the Hemisfair is ready in San Antonio and as a part of the statewide effort to provide more and more attractions for tourists visiting the state.
