



pointed by the President of the United States, the appointment must be confirmed by the Senate. This is a safeguard to insure the highest degree of competency on the court.

Most of us, at one time or another, will disagree with a decision which this court has made. Whenever this is the case, let us remember that all the members of this court have sworn to uphold the Constitution of the United States. As citizens, we have the right to make our disagreements known through writing to the Justices of the Court, the President and the Congress. If enough pressure is brought through these channels the laws may be amended, but to attempt to take matters into one's own hands rather than abide by the decisions of this court undermines the basic principle of democracy and the law and order that holds it together.

Our priceless heritage embodied in the flag of the United States, is as alive today as it was when written for the ages in the Declaration of Independence and the Constitution. It stands for all the world to see and for all Americans to cherish. And in the tradition of Washington, Jefferson, and Hamilton, we, too, have a privilege, a right, and a duty. While we may disagree as to the methods, we should not disagree as to the goal -that of preserving the greatest democratic society the world has ever known.

Our flag is a symbol, not of sentiment, but of history, the history of men and women willing to live and die for it. Surely this willingness is with us still, because daily we experience more of the blessings that are ours-ours because we are Americans.




