## **Crockett Field** Gains Confirmer

The Howard Draw, Northeast (1165 San Andres gas) field of Crockett County gained its seventh well and a 3/8 mile north-northeast extension with completion of Texas Oil & Gas Corp., Midland, No. 1-B Todd Cattle Co., 20 miles west of Ozona, for a calculated, absolute open flow of 850, 000 cubic feet of dry gas per day.

Production was natural from open hole at 893 feet, where 7-inch casing was set, and 1,326 feet, the total depth. Location is 1, 320 feet from

Some time ago, a perceptive Canadian commentator - Gordon Sinclair - took time out to deliver a thoughtful essay on what's good about America and Americans. Coming from a foreigner, it makes for interesting, and heartening, listening. Here is what Mr. Sinclair had to say

"This Canadian thinks it is time to speak up for Americans as the most generous and possibly the least appreciated people on all the earth .





### About Your Collision Insurance

# CONSERVE AND SAVE

### **ON WINTER HEATING**

- For savings on energy, set the thermostat on the temperature setting that provides adequate comfort (the President suggests 68°). Don't continually switch it up and down. Remember, the lower you set the thermostat in the winter the more money you save on energy.
- A routine service inspection by a qualified service man is advisable prior to the heating season. Follow the manufacturers recommendations on this. Clean filters keep the heating unit operating at maximum efficiency and economy. Filters are the most neglected part of any forced-air heating system.
- A wood burning fireplace should be equipped with an efficient damper. Be sure to keep the damper closed when not in use. A chimney with the damper open carries warm air out the house, wasting heat.
- To decrease heat loss and reduce energy cost in rooms that are not in use at night or in extremely cold weather, draw the draperies and lower the shades over the windows, glass panels and doors. If the sun is shining on glass areas, open the draperies. The sun shining through the glass will supply additional heat at no cost.
- Some wall heaters have fan-forced circulation. To clean, turn the unit "OFF". Blow dust out of unit with vacuum exhaust attachment. Clean the grill cover with a vacuum or warm detergent water.
- Proper insulation and weather stripping will make your home more comfortable. It will help keep dust and dirt from blowing in, and will help to eliminate cold drafts in the winter time, thus saving money on your heating bill.
