LIONS ENGAGE ROCKSPRINGS IN CRUCIAL BOUT

Win For Locals Would Throw Dist. In 3-Way Tie For Flag

TO PLAN PLAY-OFF

Eldorado, Junction and Ozona Battle For Championship

When Coach Ted White's Ozona Lions tangle with the Rocksprings eleven on the local gridiron next Saturday afternoon they will be fighting with a new hope and vigor, with a new objective,—another chance at the western half district championship.

By virtue of a win by Eldorado over Junction last Saturday at Junction, this half of the district was thrown into a three-way tie for district honors. Eldorado, Junction and Ozona each having lost one district contest. Junction beat Ozona 13 to 6, Ozona beat Eldorado 12 to 7 and Eldorado beat Junction 7 to 6.

Each team has one more district contest this season, the Lions facing the toughest competition this Saturday of the three. While the Lions are battling the strong Rocksprings eleven, Junction will be entertaining the weak Sonora lads and Eldorado will have easy sailing over Menard.

For another try at the district championship, then, the locals must win their game over Rocksprings Saturday, and according to Coach White that is going to be no easy matter. Rocksprings barely nosed out the fighting little Sonora lads on their own gridiron recently, but their three spark plugs, the mainsprings of the backfield, were out of the game with injuries. These men are back in harness and the locals are not looking forward to something soft when the Edwards county crew invades Powell Athletic Field here Saturday.

The crucial contest is scheduled to begin at 2:30 Saturday afternoon. The Lions are going to need every available voice of encouragement for the scrap and doubtless every Ozona rooster will be on the sidelines following the play. Should the Lions take the contest from Rocksprings, Coach White will go to Sonora Sunday to meet coaches from Eldorado and Junction for the purpose of arranging for the play-off of the tie. The coaches will draw for places in the play-off and decide on the question of where the games are to be played.

There will be strong bidding of money guarantees to get the games for the respective "home towns," it is expected, and if Ozona is to compete in the bidding, it likely will be necessary for local backers of the team to underwrite the guarantee. With interest at high pitch in all three towns it is likely that any reasonable guarantee can be met from gate receipts, but local sportsmen should get in touch with Coach White and agree upon an offer and underwrite the guarantee to the visiting teams in the championship play-off.

Work Relief To Start Here Today

21 Men On Rolls To Be Given Work In Cleaning Streets

Twenty-one unemployed men will be given work under a work-relief program to be started here today under the direction of the county relief board and the relief director, R. O. Smith.

The 21 men are to be put to work on a city-wide street cleaning campaign as the first project under the work order issued by the Texas Relief Commission, administering state and federal relief. The Texas commission, upon orders from federal authorities, has instructed county boards that hereafter direct relief may not be issued except in case of illness or real necessity and has ordered work relief projects to get under way today.

Details of the proposed canning program not yet being worked out, the street cleaning project has been determined up on as being the most feasible for starting the work. Streets are to be cleaned of all trash and rubbish and as soon as the county is able to secure brooms, all loose gravel, left from paving, will be swept up and hauled to unpaved streets for scattering.

Lions Smother Sonora 38 to 0

Visitors Fight Gamely To End In Face Of Heavy Odds

In a one-sided game, featured by sensationally long passes and long broken field runs for touchdowns on the part of the Ozona High School Lions and a never-say-die fighting spirit of a hopelessly outclassed Sonora team, the locals piled up a total of 38 points to nothing for the Brones on the Powell Field gridiron Saturday afternoon.

The Lions were able to score almost at will over the tighter and less experienced players from Sonora. Despite their handicaps, however, the visitors fought gallantly every inch of the way, never once letting up even in the face of the overwhelming odds.

The locals scored early in the contest when they marched the ball straight down the field for a touchdown from the kickoff. Jake Miller traveling the last 20 yards for the first marker on an end run. The kick for the extra point was wide. Trying out their passing wings, after the first score, the locals made but little headway through the rest of the quarter.

The next thrill came in the second quarter when Westfall shot a long pass from the Sonora 35 yard line over the goal line into the waiting arms of Jake Miller. The Lions then broke their long-standing jinx by kicking a goal from placement for the extra point.

Early in the third quarter, the Lions again opened up with a running attack. Westfall breaking through tackle for a 45-yard run for a touchdown. Here the jinx returned and the kick for the extra point failed to click. A few minutes later the locals were again on their way. Westfall taking

SUMMARY OF THE NEW TRAFFIC REGULATIONS

The completion of paved highways through Ozona having created a new traffic problem for the town and presented a new danger of serious accidents, the County Commissioners Court and the Sheriff's department have deemed it advisable to promulgate a new code of traffic regulations for motorists driving within the city.

The new traffic "buttons" were installed this week and with the installation of these traffic signals, the new regulations go into effect. In order that there may be no room for misunderstanding and that motorists may acquaint themselves with the new rules and be governed thereby at once, I am making this detailed publication of the new regulations, which are to be rigidly enforced hereafter.

The traffic signals themselves are plain as to their meaning. They have been so placed that traffic entering the main highways and streets is halted upon entering the faster thoroughfares, thus avoiding accidents at intersections. The "buttons" order traffic to "stop" upon entering the main streets and they also order motorists along these streets to drive slowly. If these signals are obeyed, it will slow down traffic in the business section and avoid many serious accidents. Failure to observe the "slow" and "stop" signs of the traffic buttons will subject the offender to a fine.

Hereafter it will be a violation of the traffic rules to turn around on the streets anywhere except at intersections and then the driver must keep to the right of the "buttons". Turning left across a street in the middle of a block to mark a violation of this rule and will be a finable offense.

Hereafter it will be a violation of the traffic rules for trucks or cars to be parked along the west wall of the city park. This rule has been made in order to clear this street of big trucks, vegetable peddlers' trucks and the like that park along that side of the main street and create new accident hazards by cutting in on the driveway on that side. Parking will be allowed on the other three sides of the park but not on the west side on the main business street.

The earnest co-operation of every resident of Ozona is requested in the observance of these new traffic rules. It may prove a little inconvenient at the start, but you will become accustomed to it soon and it will be a great help in avoiding accidents. Unless the public co-operates by observing the rules, it will be necessary to enforce them by complaint in the courts, but I feel sure that such action will not be necessary and that Ozona people will help me make driving safer.

Announcing Changes In
Policy Required By the
NRA CODE
for
Building Material Dealers

At a recent meeting of lumber men of District 31, in Del Rio, details of the requirements of the lumber dealers' code, operative under the NRA, were studied and the following discount and credit terms were adopted as uniform throughout this district. These terms are set by the government and we have no choice but to observe them. Every lumber yard in the district will sell on the same price list.

EFFECTIVE NOV. 15, the following terms, as set by the government, will apply:

10% cash discount will be allowed on items marked X on the price list. (This includes all building materials).

5% discount will be allowed if paid on or before the 20th of the month following that of purchase

Prices will be net up to the end of the next month after which interest at the rate of 8% per annum will be charged each month.

All materials purchased on deferred payments covered by contract, the contract taken at the time of purchase running six months or longer, the prices herein will be increased by not less than 10%.

The above terms are taken from a letter of instructions written by W. A. Earnest, Del Rio, Texas, Chairman district 31, and endorsed by R. G. Hyett, Houston, Texas Administrator Division No. 23.

The above terms do not apply to Hardware, Paints and other items not classed as building materials.
