## IN FAIRNESS TO ALL....

It is not of our own choosing that we have adopted the code of rules announced last week concerning prompt payment of water bills. We have found it necessary to adopt these rules and to enforce them strictly, not only as a measure of self protection, but also in fairness to all customers alike. Delinquent accounts and credit losses are charged to operating expenses and contribute to the increased cost of providing service. The prompt paying customer, then, is penalized on the rates in force for losess and added expense due to delinquencies.

Under the new rules just adopted, these unnecessary drains will be stopped We have not adopted this plan with a view to working a hardship on our customers, but for the sole purpose of operating on a business-like basis, fair to all alike, to cut down losses and operating expenses and to work toward ultimately lower rates.

## We Ask Your CO-OPERATION

It will be for the benefit of all if we can have 100 per cent co-operation in putting this plan into effect. Announced rules will be RIGIDLY ENFORCED. ed, surely. But a rule that is only half enforced is worse than no rule at all, and the only way we can be fair to all is to enforce the regulations on all alike.

The new rules are simple. Here they are:

1. All current accounts must be paid in full by the 10 th of each month or customer will be subject to discontinuance of water service, together with a charge of $\$ 1$ for connection when bill is paid.
2. A deposit of $\$ 5$ will be required of each new customer.
3. Landlords will be held responsible for accounts of their tenants unless due notice of occupation and removais is made known to us.
4. People having private water supplies, and who desire our services occasionally will be required to pay a service charge of $\$ 2$ for each separate connection.
5. Customers who know themselves to be in arrears at present, must make immediate arrangements whereby we may be able to continue to serve them There can be NO exceptions to this rule.
