

PLANT BLUEBONNETS IN SEPT. FOR SPRING BLOOMS

COLLEGE STATION - Texas luebonnets may be planted in

ptember for blooms next spring. Bluebonnet seed, which are aailable in most any seed store, will sprout much better if allowed

planting, says Sadie Hatfield, specialist in landscape gardening with the Texas A. and M. College Extension Service. After the seed soak, they should be raked into the soil and watered at once. The young plants will grow during the cold winter months, since they are injured only by heavy freezes and then only a few will be killed. In light, sandy soil, the bluebonnet will grow best, says Miss Hatfield. In rich, fertilized soil the plants will develop tall stalks, maiv leaves but few blooms.






