James A. Davis, president of Empire Natural Gas Co., and J. P. a remarkable record in competi- Kenney, another official of the company, both from the Fort Worth headquarters, were here this week to meet with the Commissioners Court to present their requests for a franchise.

Mr. Davis said the company hopes to have natural gas available in Ozona by November 1. The company operates gas sytems in Brady, Big Spring, Gorman, Desdedmona, Lyndon, La., and other places.

The gas supply for the Ozona system is to be secured from the Magnolia Clayton gas - distillate well about 10 miles east of Ozona. Mr. Davis said that his company had secured an agreement with Magnolia to purchase the city's supply from the Clayton well's output and that contract will be signed with the company next week. All necessary pipe and other ma-

terials are already on hand in the company's yards in Big Spring and as soon as all preliminary details are completed, bids will be asked from contractors for installation of the system here.

A schedule of proposed rates to be charged the different classes of customers in Ozona was filed by the concern with the Commissioners Court. For general use, domestic and business customers, the rate schedule is as follows: First 2,000 cubic feet per month

HOUSE JOINT RESOLUTION NO. 2 proposing an amendment to Section 49-b, Article III, Constitution of Texas, so that the total amount of bonds or obligations that may be issued by the Veterans' Land Board is in-creased to One Hundred Million Dollars (\$100,000,000); providing for the issuance of add bonds and certain conditions relating thereto and the use of the Veterans' Land Fund; providing for an election and the issuance of a proclamation therefor. BE IT RESOLVED BY THE LEGISLA-TURE OF THE STATE OF TEXAS: Section 1. That Section 49-b, Article III, Constitution of Texas, be amended so that the same will hereafter read as follows: "Section 69-b, There is hereby created a Board to be known as the Veterans' Land Board, which shall be composed of the Gov-ernor, the Attorney General, and the Com-missioner of the General Land Office. The Veterans' Land Board may issue not to exceed One Hundred Million Dollars (\$100,000,000) in bonds or obligations of the State of Texas for the purpose of ereating a fund to be known as the Veterans' Land Fund. Such bonds shall be executed by said Board as an obligation of the State of Texas, in such form, and upon the terms as are now prescribed by Senate Bill No. 29, Chapter 318 bolica shall be executed by said Board as an obligation of the State of Texas, in such form, denominations, and upon the terms as are now prescribed by Senate Bill No. 29, Chapter 318 of the Acts of the Fifty-first Legislature (provided, that when the limitation of Twenty-five Million Dollars (125,000,000) is used in said Senate Bill No. 29, the same shall here-after be construed as One Hundred Million Dollars (1100,000,000), or as said Act may be hereafter amended, or by other laws that the Legislature may hereafter enact; provided, however, that said bonds shall bear a rate of interest not to exceed three per cent (3%) per annum, and that the same shall be sold for not lees than par value and accrued interest. Two Ozona young men have been ordered to report for induction inlisting Ray Piner's leadership in to the armed forces on August 16, with a group of other inductees from the five county area served by Selective Service Local Board No. 110 at Sonora.

AUSTIN. The Texas draft call together since 1947 as voluteer Paul L. Wakefield, state Selective Service director, announced

This compares with a September quota of 619 and an August call of 772. From March through July, state calls were decreased; but beginning with the August call, quotas have been increased, the state draft director pointed out. The October quota of 742 is the state's share of a national quota of 41,000, biggest national monthly quota since March. Part of the September and October quota of men will see service with the Marine Corps.

General Wakefield said that local board quotas for October wil! be assigned and mailed "around August 8th or 9th." No local board quotas will be available until that time. Local boards have received September calls.

The state director of Selective Service said his headquarters had received information that not as many male college students in the Southwest had taken the Selective Service qualification test as in other areas.

Figures received showed that 6 per cent of male college students in Western South Central states took the test, as compaared to 19 per cent in Northeastern states, and 11 per cent over the nation and territories as a whole.




