

STRIKE NEGOTIATIONS RESUMED

Britain and Italian Cabinets Deliberating Over Dispute

ENG. STANDSPAT UNTIL SITUATION BECOMES EASED

No Indication Given Of Removal of Navy

British and Italian cabinets deliberated today over the grave Italo-Ethiopian situation.

Informed quarters reported that the British had decided to continue their Imperial Defense Committee as a council of action until the situation is eased. No indication has been given that the British navy will be withdrawn from the Mediterranean.

The British cabinet approved the action of its statesmen at Geneva and decided to continue in firm support of the League covenant.

Mussolini today told his cabinet that Italy had offered no counter proposals to the League of Nations settlement plan. The cabinet was adjourned until Saturday.

The League committee, acknowledging its efforts to solve the problem have been defeated, gave the League its report which the League council will consider. There were indications that the council might give the whole matter to the general assembly.

The press of Rome intimated today that the League had exhausted its possibilities in the controversy.

OFFER STANLEY CONSERVATION CHIEF POSITION

AUSTIN, Sept. 24. (P)—E. N. Stanley this afternoon announced that he would not accept the offer of Commissioner Thompson as conservation enforcement chief in East Texas due to the "financial condition."

AUSTIN, Sept. 24. (P)—Ernest O. Thompson, chairman of the Texas Railway Commission, today offered Stanley the position of chief conservation officer of conservation laws in East Texas.

Stanley, who formerly held the post, said that he was considering the offer.

Thompson did not give any reason for the projected resignation of Stanley, whose impending resignation has been reported for several weeks.

A group of East Texans has asked the commission to make Tucker Royall, Palestine, enforcement chief.

Two additional cowgirl sponsors, to represent West Texas and New Mexico cities at the Midland Fair, were announced today, bringing the total number entered to fifteen.

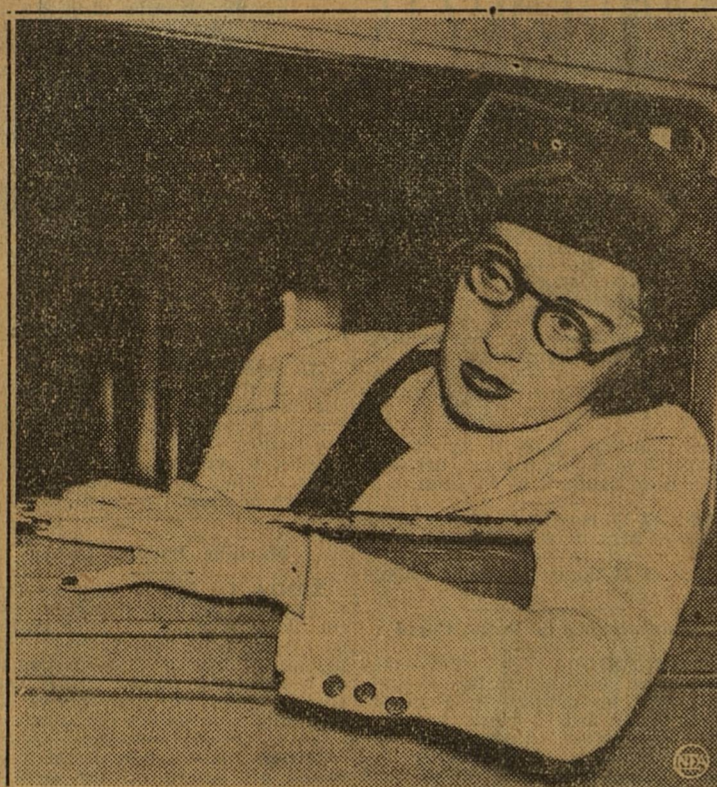
Several other towns and cities have announced that sponsors will be chosen and the names sent here soon.

PRODUCER, MINER REPRESENTATIVES STILL DIFFERING

One and Half Cent Difference Bars Settlement

WASHINGTON, Sept. 24. (P)—The soft coal strike negotiations were resumed today with a stumbling block reported to be a difference of one and one-half cents per ton in the pay of the miners.

The producers are standing by their offer of seven and one-half cents per ton while the miners are demanding nine cents.

Relief administration officials said that funds would not be provided for an estimated 400,000 strikers unless a settlement occurred and the National Labor Relations board made officials detentions of the dispute justifiable.

FLEEING FELONS KIDNAP FOUR IN PRISON ESCAPE

BATON ROUGE, La., Sept. 24. (P)—The kidnaping of a couple and their two young children by two fleeing Louisiana convicts was reported Monday by the State Bureau of Criminal Investigation.

The bureau said Gus Will Lee and Jerry Cannon, serving terms from New Orleans for banditry and robbery, respectively, who escaped from the penitentiary Saturday, abducted the Mr. and Mrs. Henderson Riley of Tunica, La., and their two children in their flight and later released them unharmed.

Lee and Cannon were said to have encountered Mr. and Mrs. Riley at Tunica, not far from the State penal farm at Angola and compelled them to take them in their automobile to Woodville, Miss.

There the convicts got out of the car, gave the Rileys 90¢ to buy gasoline to return home, and permitted Riley to keep two guns he had in the car.

The Rileys were taken about thirty miles by indirect highway route across the State line.

JIM TULLY'S SON SENT TO PRISON

SUSANVILLE, Calif., Sept. 24. (P)—Thomas A. Tully, 24, son of the author, Jim Tully, pleaded guilty Monday to a charge of assaulting a girl. Superior Judge H. D. Burroughs sentenced him to a term in San Quentin prison.

The sentence carries a term of one to 50 years. Tully was arrested eight days ago, on complaint of Juanita Sheppard, 16-year-old Westwood, Calif., girl, who alleged he beat and attacked her after a party.

When a group of men milled outside the Westwood jail, reportedly bent on lynching, young Tully was removed here for his protection. Young Tully had been working in a lumber camp near here.

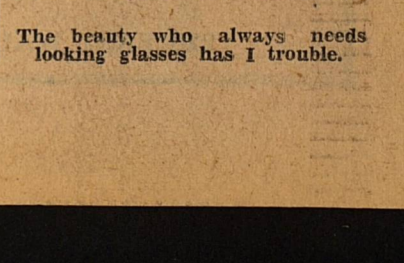

NEW YORK BANKER LEAPS TO DEATH FROM HOTEL ROOM

HOUSTON, Sept. 24. (P)—A man identified by police as James A. MacIvaine, 45, second vice president of Chase National Bank, New York, leaped to his death Monday night from his room on the tenth floor of the Lamar hotel here.

A note addressed to "Helen" and unsigned was found in the room along with personal effects. The note was penned on the last pages of a diary that gave the man's name, date of birth and his home address as 50 Canaan street, Caldwell, N. J.

MacIvaine screamed and twisted in the course of his fatal plunge. Hundreds of theatre-goers passing the downtown hotel looked on in horror.

The body first struck the top of an automobile then fell face downward on the pavement. He lived about 15 minutes. The note, written in pencil, in a pocket diary, read as follows: "Dear Helen: This is being written on a train to Houston. I love you dear and I am awfully sorry you took me. What a curse to you I am but maybe the boys somehow can be saved. Poor dear Lydia and darling Aunt Lizzie. I will probably not die, work luck for you. It will be in all the papers. I am tired and probably there is no need to write this for you will come to see me. Oh, the boys, the boys. Our affair was so muddled and you will be so poor."

A verdict of suicide was rendered in Houston this morning in the case of MacIvaine.

Wink to win, Pecos to place and Midland to show. That, in this writer's opinion, is how the district race will end this season.

Wink, perennial champions of the district, has 12 lettermen back from their championship team of last year, far more lettermen than any other school, and despite their being last in starting their fall training, they should win out.

Unless we are mistaken the Wink team will be forced to journey to Pecos for their game with that team but for several seasons they have been a "jinx" for Pecos teams and should have enough power this year to again assert mastery over the Reeves county boys.

The next toughest game for the Wildcats will be with the Midland Bulldogs and the game will be played on the Wink field, giving them an almost sure cinch to win.

It is evident from past performances this season that the Pecos

team will be stronger this year and with both the Midland and Wink games to be played on the Eagle grid they have a much better chance of coming in first than they would if they played on foreign fields. However, lack of reserve material is going to handicap them greatly.

Little Joe Bob Kelton is the spark of the Pecos team and as he goes so go the Eagles. Either Midland or Wink is liable to concentrate their defense to stop the diminutive back and if successful they are liable to ruin the pennant aspirations of that team in one game.

In third position we find the Midland Bulldogs and only for one reason. Their two toughest games, Wink and Pecos, finds them playing on foreign fields. With only five lettermen on the team this year it is asking a little too much of them to defeat such teams as the Pecos and Wink ones before hostile crowds. Were those two games to be played in Midland we would have no hesitancy in picking the Bulldogs, but as the schedule is arranged we fall to see them above the show position.

In fourth position we are placing the Odessa Bronchs and officially designating them as the "dark horse" of the race.

With a new coach and school spirit higher than it has been in several seasons the Odessa team is going to get together with each succeeding game if they will forget the lean years and the defeats they suffered each year at the hands of teams who had no real business in beating them then they will make it tough for other teams of the district.

In Tucker and Green the Bronchs have what should develop into a couple of backs of real first class. Green, a 190 pound fullback, started out like a house afire last year but before the season was over he fell victim to the defeatist attitude that has characterized Odessa teams for the last few years and as the season advanced he became less and less effective.

If that team makes up their mind this year that they are going to win some games then the watchword of the league might well become "Watch Odessa."

What the Crane team possesses this season we have been unable to find out but unofficial reports say that it is not as strong as it was last year.

In last position Stanton is placed and there is little doubt that they will do anything over the season to make that seem a bad pick. The Martin county lads are two or three weeks behind other schools in getting started and, coupled with the fact that they cannot put more than 20 men on the practice field, most of them without any experience, it is doubtful if the Buffaloes prove very troublesome to other teams this season.

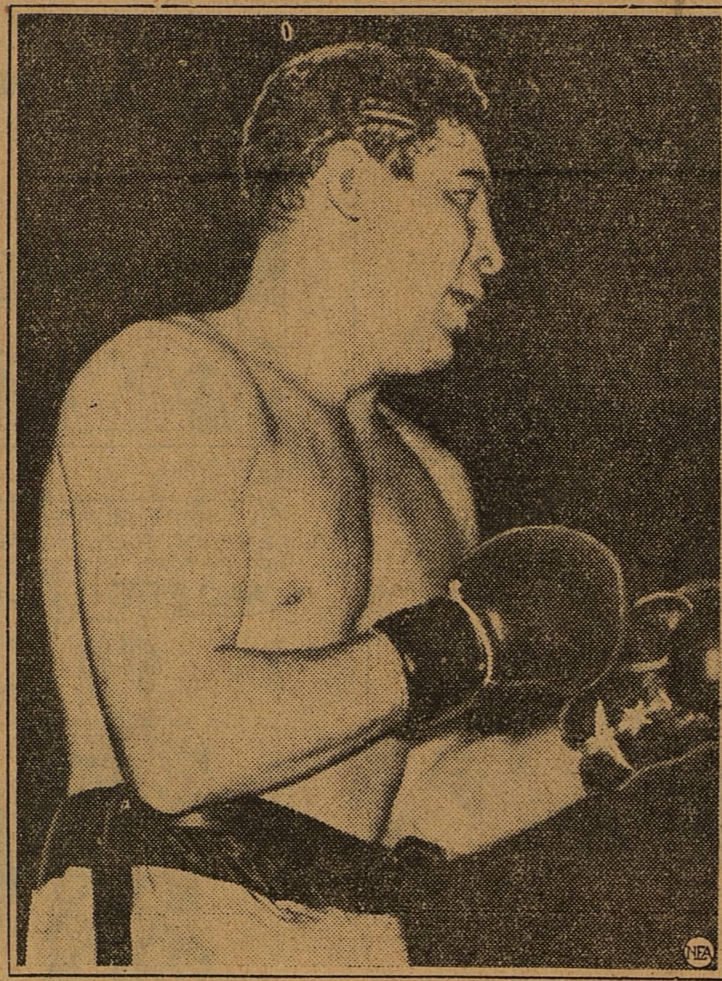

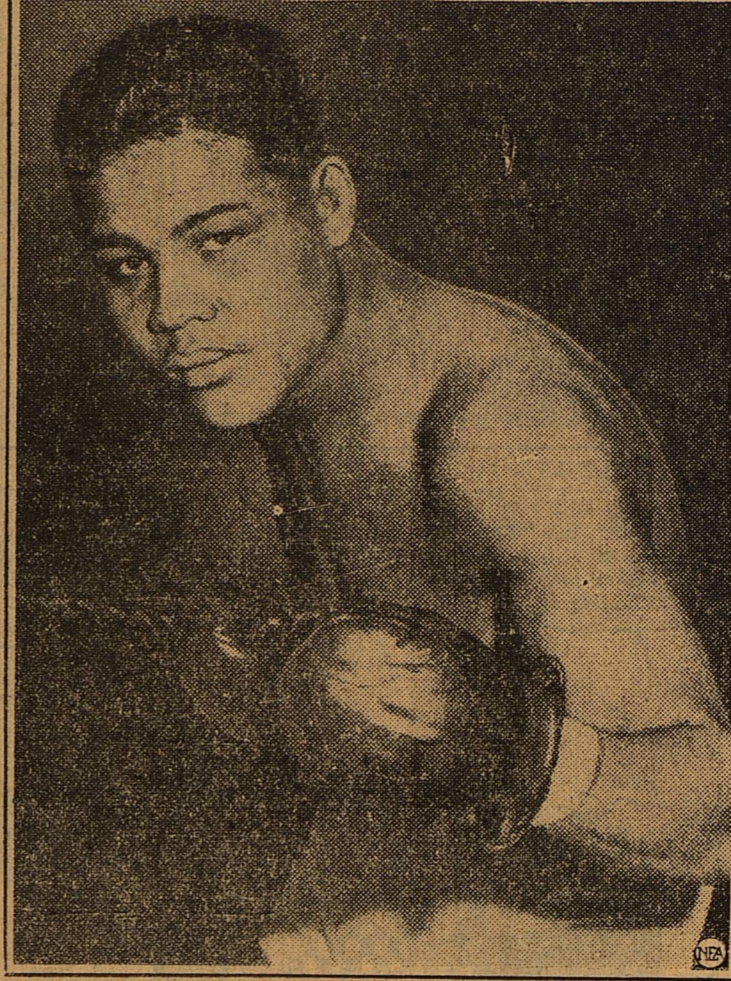

Millions Of Fish Die Of Strange Marine Condition At Corpus

BROWNSVILLE, Sept. 24. (AP)—A strange marine condition which sometime ago killed millions of fish in the Gulf of Mexico in the vicinity of Corpus Christi Monday had left more millions dead along a 50-mile strip of coast.

The dead fish were reported extending 20 miles south of here along the coast of northern Mexico and 30 miles north up Padre island on the Texas coast.

As in the previous disaster, the first intimation was the strong odor of sulphur dioxide, which made persons cough and hurt their eyes. Brownsville residents who camped on Padre island Saturday night reported the water there was yellowish in places, and that they could see heavy gas rising from the water. They said the gas made them cough almost continually.

The dead fish started drifting in Saturday, but came in great numbers Sunday. Hundreds of tarpon, the great fighting fish of the gulf, were washed up and today lay rotting in the sand. There were millions of smaller fish, such as pike, Spanish mackerel, mullet and many other kinds.

Present also were thousands of dead gars. These are normally fresh water fish which follow the waters of the Rio Grande out into the gulf.

The most extravagant police arrangements ever made for a ring spectacle were completed with the assigning of 1,225 patrolmen and detectives to duty around and within the stadium Tuesday. There will be another 500 plainclothesmen and members of the pickpocket squads within the park.

Dozens of police were needed Monday to control the lines surging past the ticket windows of the Twentieth Century Sporting Club on Broadway.

"They'll buy anything with a number on it," sighed Jacobs, the promoter. Mike has done a great deal of reshuffling since the tickets first went on sale. The ringsters are backing up almost into the laps of the bleacher customers, and such strange symbols as "Row XX" were appearing on tickets. This is the first New York outdoor fight, however, in which the back ringside rows

In general the issues boiled down to this, Louis, winner of twenty-four straight professional fights in his fifteen-month career, twenty by knockouts in which he had all his own way, will be hit harder than ever before in his life by this perfectly conditioned, serious but still highly erratic Baer. Can he take it?

On the other hand, Baer, who has been hit by experts, will get slugged as he too never has been slugged before. Can he, frankly admitting more dissipation and high living over the last two years than any athlete can stand, take it with the same old doggedness?

Lean and fit, anything but overconfident, Baer abandoned his planned airplane trip down from Speculator, N. Y., where it was raining, and instead took a train.

He and Louis figure to earn \$300,000 each, almost as much as they have earned together up to now. They share, too, in the \$27,000 return from the radio broadcast, and the \$25,000 for the motion picture rights.
