



The Resettlement Administration is under Rockwell G. Tugwell, as-sistant secretary of agriculture, one of President Roosevelt's original "brain trusters". Its various functions embrace nearly every Federal activity that relates to the farmers' welfare, in-cluding a land classification divi-sion, land utilization division, proj-ect division and farm debt adjust-ment division, the latter being classified as one of the rural reha-bilitation agencies, formerly func-tioning in Texas through Rural Communities, Inc. Farm debt adjustment work was

Communities, Inc. Farm debt adjustment work was established by executive order of the President throughout the na-tion nearly two years ago, and set up in the forty-four states under direct supervision of Alvin T. An-derson, whose offices were housed in the Farm Credit administration building. In Texas this work was known as the Texas Farm Debt Con-ciliation committee, with a state committee, of which R. J. Murray was state chairman, and with coun-ty committees in each county to contact debt-distressed farmers. As the work was formerly conducted contact debt-distressed farmers. As the work was formerly conducted Murray had divided the state of Texas into 10 districts, with a dis-trict supervisor over each district When the Resettlement adminis-tration took over this work the en-tire nation was divided into regions




