FLIGHT OF EAKER CLEVELAND, Aug. 29 .- (AP)-The transcontinental mail plane

'Shuttle" was forced down late last night when it was struck by a five gallon can of oil during refueling contact, while on return flight to Los Angeles from New York, in an attempt to establish a record for sustained flying. Capt. Ira Eaker, the pilot, immediately made plans to resume the flight.

Captain Eaker has made several landings in Midland, first with the army refueling trimotor "Question Mark," and later on trips associated with the Brownsville-to-Panama dawn-to-dusk attempt and business flights. Two landings were made enroute to Eden, where Eaker's mother lived until the time of her death a few months ago.
