Contract was let Wednesday by Sam Preston, county commissioner and director of the Midland Chamber of Commerce, for a new road connecting Midland with Andrews, Seminole and Eastern New Mexico.

The new road will run from South Camp via the Clabber Hill ranch road to the Andrews-Odessa road. It will be grubbed, and dragged to make it a fast automobile road to accommodate oil men, ranchers and farmers.

The new road will be paid for by the Midland Chamber of Commerce from its regular budget, without any additional call for anyone for extra funds. The Midland County Commissioners Court is cooperating with the Chamber of Commerce in its road program wherever possible.






