A piano and violin duet by Miss Lydie and Mr. Ned Watson, of the Watson School of Music, was greatly enjoyed


Mayor Welcomes

The two steel hangars shown in this picture, with two of the T. A. T. Flying Service passenger planes waiting on the concrete apron for their passengers to eat lunch are but part of the facilities just completed at the Big Spring airport which is to be dedicated Wednesday and Thursday.

Going into the project on a large scale, business men of the city have framed a program which will, leaders in aviation declare, attract a record crowd.

This 230-acre port is equipped to meet requirements for A1A rating by the department of commerce, with hangars, shop building, five-room administration building, and a field lighting system, including a 200,000 candlepower beacon, two batteries of flood lights, border and obstruction lights surrounding the entire field.
