ALTO BANK BANDIT SHOT DOWN

President Proclaims Necessity for Continuing the NRA

EIGHT JURORS SELECTED FOR MURDER TRIAL OF MORGAN

TESTIMONY WILL BEGIN ABOUT 4 P. M., BELIEVED

Unwritten Law Figures in State's Examinations

Selection of a jury for trial of Arch Morgan, charged with murder growing out of the death last October of Phil Dawson, moved faster as the afternoon court session progressed.

Eight jurors had been selected by 2:30. The three selected during the afternoon were J. C. Hudson, N. D. Stanton and W. L. Locklar.

Additional questioning was pronounced by state's attorneys relative to the attitude of veniremen concerning the "unwritten law." Jurors accepted were required to agree that such a law will be recognized only if specified in the judge's charge.

Indications were that taking of testimony will begin about 4 o'clock.

Five jurors had been chosen when the noon recess was taken, including W. T. Chandler, W. E. Hoggess, W. H. Neuh, S. B. Preston and J. P. H. McMillan. At that time, 38 veniremen had been questioned. Prosecuting attorneys were District Attorney W. R. Hamilton and L. A. Dale of Pecos. C. W. Dunaway was conducting the case for the defendant.

State's attorneys questioned each venireman closely as to whether or not he had formed an opinion in the case, whether he was acquainted with the defendant or his family members, whether it would require evidence to remove any prejudice which may have been formed and whether the venireman would follow strictly the written charge of the judge.

Dunaway questioned veniremen as to whether their opinions, if any, could be removed by evidence which may be presented in the case and whether they recognized a marriage right to defend himself against an unwarranted attack.

The court opened at 10 o'clock announcement was made by Judge Klapproth that the trial of Arch Morgan was called and the state and defense were asked if they were ready. Witnesses were called by each and they announced ready.

The list of 108 veniremen, less a few excused, was read, followed by the reading of the jury panel for this week and then the list of veniremen for the trial of Jones.

Upon reading of the indictment against Morgan was charged with the fatal shooting last October of Phil Dawson, the defendant pleaded not guilty. Veniremen were discharged from the room, subject to call, and were examined singly.

Ira Lord, Family Back from Funeral

Russian Princess Awarded Damages by a London Jury

Lands Safely



LONDON, March 5. (U.P.)—Princess Irina Yusupoff, niece of the late Czar, was awarded \$126,800 damages by a jury in her libel suit against Metro-Goldwyn-Mayer Pictures corporation today.

Her allegations said the picture painted her as having submitted to the monk as a patriotic duty after it was seen that Rasputin planned to seize the Russian throne.

Costes, known as the French Lindbergh, landed safely in Prussia today, cablegrams said. It had been feared over the week end his tiny plane had fallen in the ocean on a Paris to Copenhagen flight.

FRENCH LINDY IS SAFE IN PRUSSIA

MUENSTER, Germany, March 5. (U.P.)—Dieudonne Costes, French transatlantic aviator, landed safely at the airport here Saturday on route Paris to Copenhagen, having to set down because of bad weather.

He was not aware of the anxiety his disappearance had caused over the week-end.

When he took off from Paris, he had barely enough gasoline to span the 180-mile expanse of water over the North Sea, he indicated.

BEDFORD DRAWS OUT OF CAMPAIGN

H. G. Bedford, county commissioner of precinct number one and until today a candidate for reelection, issued a statement to The Reporter-Telegram this morning in which he withdrew from the race.

"I also wish to state that among my reasons for withdrawing, the principal one is that I fear I would not have as much time to devote to the duties of the office as they should command, and another is that with the expiration of the present term I will have served two terms in the office and feel that, at least in some measure, I will have fulfilled my obligation to the people by having helped to accomplish many of the things advocated in my first race for commissioner."

"And, at the same time, I realize that there are several good men well qualified to fill the office who would like to have it."

WASHINGTON, March 5. (U.P.)—President Roosevelt today proclaimed the necessity of the NRA for economic rehabilitation and at the same time flouted fears that it is the forerunner of fascism or communism.

He urged the people to take direct action against those who refuse to fly the blue eagle, tantamount to boycotting those "who think only of selfish gain." The president reiterated the right of employees to organize "by free choice."

The president's address was given before four thousand here for the NRA general conference of code authorities. The speech was the president's reply to criticism and was the longest made in months.

"The first task of industry today is to create consuming power. Therefore, I give the industry this challenge: 'Reemploy more people at purchasing wages and do it now,'" Roosevelt said.

The president made a complete survey of the recovery picture from start to finish and said common sense required the consuming public to compel the selfish to play the game.

He promised protection to the small business. Roosevelt's words were construed as a last warning to chiselers who he said "Government cannot forever continue to absorb the whole employment burden."

He also said "I can't tolerate abuse of economic power—abuses against labor, employees or the consuming public, whether they persist either with the aid of codes or despite their prohibitions. That means we have arrived at the time for taking stock and correcting errors."

REPRESENTATIVE FRANK STUBBEMAN ANNOUNCES FOR DISTRICT ATTORNEY

Frank Stubbeman today announced his candidacy for district attorney of the 70th judicial district of Texas, subject to the action of the democratic primary.

Stubbeman is state representative from this district and represents a larger territory than any other person in the Texas house of representatives. He has just returned from a recent session of the legislature at Austin.

In that body he was one of the active sponsors of the worm bill and helped secure the passage of that measure, as a result of which the farmers of this area will eventually be reimbursed for money spent for fumigation of their cotton and for sterilization of

their cotton seed.

Stubbeman says that he has for several months considered entering the race for district attorney but has not announced sooner for the reason that he has until now been busily engaged in his duties as a legislator.

Stubbeman maintains a law office at Midland and his law practice extends over a wide area in Texas. He now has cases in court from El Paso to Austin. After receiving his training from the University of Texas law school, he began the practice of law at San Angelo with Judge Charles Gibbs, well known in this area. Stubbeman moved from San Angelo to Midland four years ago to become associated with the late B. Frank Haag and was still Haag's law partner at the time of Haag's death last July.

BODY RECOVERED FROM TRINITY

DALLAS, March 5. (U.P.)—A woman's body, tentatively identified as Allie Wright, 24, was recovered from the Trinity river today after a search resulted from R. C. ALTO, Tex., March 5. (U.P.)—One was killed and one captured when two bandits made an attempt here today on the Continental State bank.

The dead man's last name is McClure, and the one captured said his name is Marvin French, 30, of Cherokee county.

Gus Rounsaville, bank president, and James A. Shattuck, cashier, saw the suspicious characters alight from a parked car in front of the bank, arm themselves and enter.

The two officials hid in the vault until they heard an order to "Stick 'em up!" whereupon they emerged and started firing.

The fusillade evidently did not harm the bandits, who fled to their car.

City Marshal Cal Earl's timely arrival was greeted by an exchange of shots from officer and bandits, and McClure was dropped with a single .30-30 rifle bullet in his body just as careful aim was being taken by the bandit at Shattuck, who was still firing.

W. R. McCurston, 37, customer, narrowly averted injury as a bullet deflected and shattered his watch.

NEW PARTIES MIGHT CLEAR OUT MISFITS

A Washington publisher recently called for the formation of a new political party in the United States, with opposition to the general trend of the "new deal" as its main platform plank.

Such a party, he says, might be called "The Constitution Democratic Party," and would replace the existing G. O. P. The present Democratic party he would re-name "The Socialist Democratic Party."

The reshuffling he advocates thus would give us two brand-new national parties to take the place of the ones we have.

It has been one of the axioms of American politics for a good many years that there is little real difference between the two major parties. It has been equally clear that neither party has been homogeneous, and that each one contains sizable groups sadly out of harmony with the majority opinion of their fellows.

To put through a general shifting of personnel and principles that would give us two big parties, each one more or less united from top to bottom, based on widely different conceptions of the function of government in the modern world, might be an exceedingly healthy development.

It is hard to escape the feeling that the actual trend of things today is in that direction. We have the "western progressives" in the Republican party, who are far closer to the administration than they are to such leaders in their own party as Mr. Hoover or Mr. Mills.

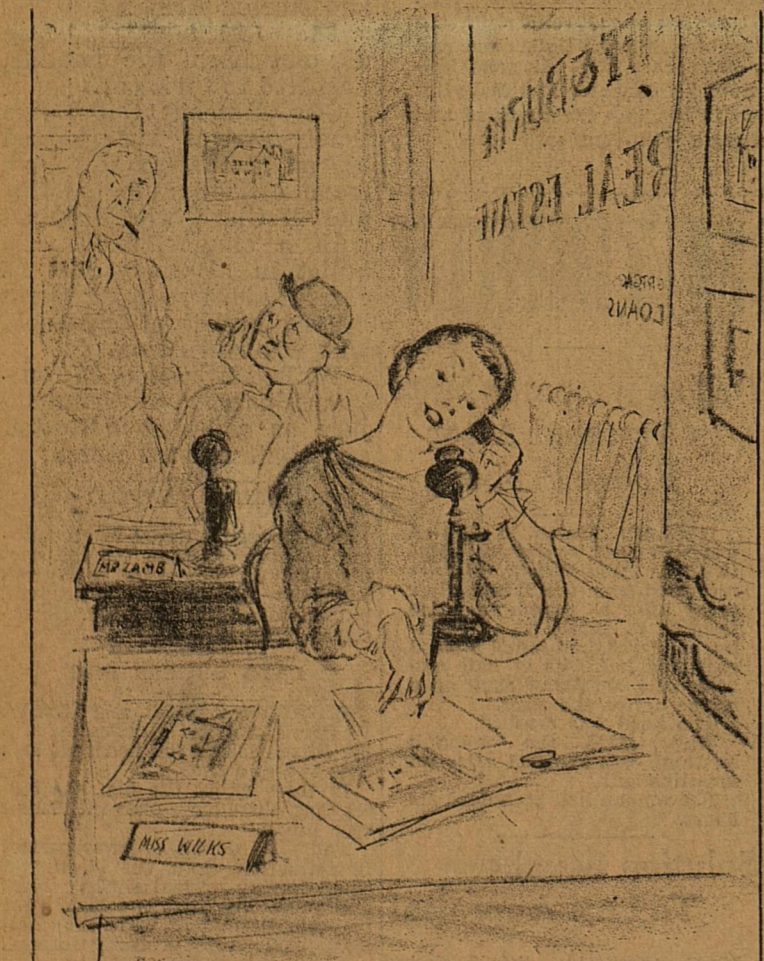
On the other hand, it is pretty obvious that men like Senator Glass and ex-Governor Smith are not exactly the same kind of Democrats as President Roosevelt.

Continuance of this trend can do one of two things. It can give us two new major parties to replace the old ones, or it can split both our parties and give us a group of half a dozen or more blocs, creating a condition in which no administration ever could have a majority in Congress and in which compromise and a multiplicity of "deals" would be the order of the day.

The recent experience of France is enough argument against the latter possibility. A republican government works best on a straight two-party system, with the two parties diametrically opposed, as a matter of principle, on most major issues.

If we are to have that in the future, it might be a very good thing for us to promote some sort of reshuffling like the one this Washington publisher advocates.

Letters Reveal a Little-Sung Note In a Pioneer Life

RUSK (AP)—The pioneer as trail-blazer and wilderness-conqueror has been duly recorded in song and story, but Mrs. Steve Sherman of Maydelle, Cherokee county, has a collection of letters revealing a little-sung note in pioneer life—the poignant home-sickness of pioneer women.

The letters were written by Mrs. Sherman's grandmother, a young Virginian on the Texas frontier. The nostalgia, bravely concealed from the young planter husband, battling with drought and limited equipment, crept into these letters to her mother.

Mails irregular. Hungry for news. More letters a constant plea. Coarse dirt to please father to effect memory of Virginia dainties. Always love was sent to the old, long-forgotten servants.

Babies came. Help was scarce. Diseases took its toll. "Two long graves in the wild woods of Texas." Weary vigils over the bed of another sufferer "slowly wasting away."

Each year hope of a visit home. Again the \$700, the carefully calculated cost of the round-trip, was not forthcoming. "Texas is a poor man's country. You have no idea how many poor men are here. They spent all their money coming and can't get away."

At last hogs and cattle in great numbers. "All that Texas affords" was theirs, yet no satisfaction. "I'd rather be poor in Virginia than rich in Texas."

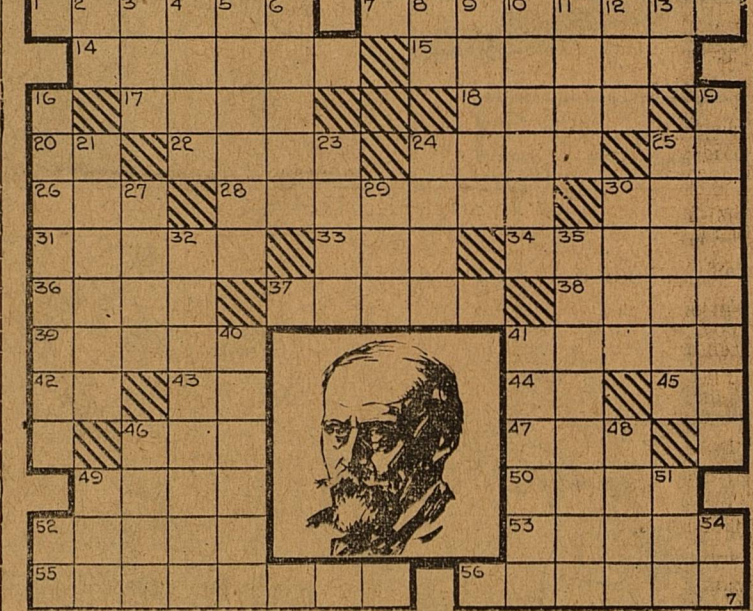

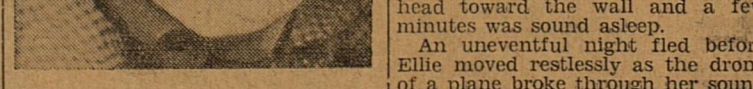

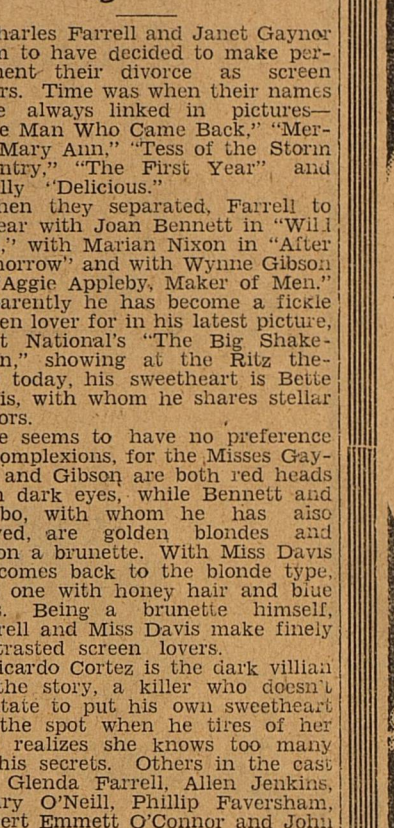
