PDRA's fate uncertain

There was an emergency Palo Duro River Authority meeting, May 20 held in the meeting room of the PDRA. The purpose of the meeting was to meet with Freese and Nichols Engineers to discuss the future of the Palo Duro River Dam and Reservoir since Dumas City Commissioners unanimously denied additional support of the PDRA project Monday night.

Details from the emergency meeting of the PDRA were not available by the Plainsman'S presstime.

According to PDRA general manager, Johnnie Lee, The PDRA project has been delayed because Dumas is possibly going to recend their statement of support for the

"Although we haven't received any official word from Dumas, we save had to cancell meetings with the contractor, the Texas Water Commission and the Texas Water Board," stated Lee.

However the Dumas newspaper reports that Dumas City Commissioners denied a request for additional financial assistence for the PDRA.

Dumas City Commissioners gave their support to the project April 28 in the form of a non-binding approval concerning financing their portion of a \$3.2 million cost over run on construction of a dam in Hansford County.

According to Lee, without the support of Dumas the project's chances of ever getting off the ground are slim unless other avenues can be found to support the project.

Dumas can't withdraw from the project unless all of Moore County withdraws because of the indebtedness of the bond issue that was

The Dumas City Commissioner's concern is on the economics of the project. In addition to the advalorem tax burden to build the dam, of which Moore County has the largest share, there is the costly second phase of the project. The City of Dumas is looking at better than half the cost - which is estimated at \$17.3 million, not

including interest.

At this point, no one is sure what the actual costs of the water plant lines and treatment facilities will be nor what kind of interest rate can be expected. Since it is unknown when the dam will fill up enough to justify the remaining construction.

Another concern to Dumas City Commissioners was a review of engineering estimates and contractor bids for a paved road over the dam site. Apparently, \$14,000 was allotted to construct this road. Actual cost is expected to be up to \$1.8 million.

According to Lee and contrary to what the Dumas newspaper printed, the PDRA has contacted the State Highway Department and is trying to work out a deal for a paved road across the dam site.

From the very beginning the project has had delays. But just as the project seemed to be ready to take off, now that a bid was let out and ready for the approval of the Texas Water Commission and the

Texas Water Board, the project has a new delay.

The project becoming a reality seems slim since Dumas pulled out from it. Dumas is the largest city in the proposal. Their share of the 25 year repayment schedule is \$143,489 for the first 10 years and \$192,014 for the final 15 years. Since they pulled their support these figures toward repayment are lost. And other ways to generate such revenue would have to be discovered, causing an even longer delay of the dam project.

The project started early in 1987 and the reservoir was to eventually hold 60,900 acre feet of water for recreation. Eventually the water would be utilized for tap water for the surrounding towns showing support for the project.

This project has been talked about for many years. On August 5. 1935 an article in the "Spearman Reporter" reported the local Lions Club meeting with County Commissioners to discuss a similar project. Although that project never developed it did help establish the Palo Duro River Authority.

Federal drought aid sought for South and West Texas


Commissioner Jim Hightower has asked officials with the U.S. Department of Agriculture to provide federal drought assistance to ranchers in South and West Texas.

"Ranchers in more than 100 counties in South and West Texas are suffering from a severe drought. The Texas Department of Agriculture is asking U.S. Agriculture Secretary Richard Lyng to allow these ranchers to grow hay on conservation acreage to graze their livestock and to receive supplemental livestock feed from the Emergency Feed Grain Program if local supplies are inadequate," Hightower said.

Hightower's letter was handdelivered Thursday to Secretary Lyng's office in Washington, D.C. Copies of Hightower's letter were also forwarded to Texas Governor Bill Clements, U.S. Senator Lloyd Bentsen and members of the Texas congressional delegation. state legislators, county officials, and farm leaders in the drought area.

"I have asked Secretary Lyng to reconsider USDA's earlier denial of a request by drought-stricken Texas counties that would allow Texas ranchers to plant badly-needed hay crops on thousands of acres in South and West Texas which have been set aside for conservation purposes. In addition, USDA must implement the Emergency Feed Grain Program to provide livestock feed in areas where local hay supplies and grazing pastures are inadequate," Hightower said.

"Some of these drought counties have not received significant amounts of rainfall since last fall, and many ranchers cannot stay in business much

longer if they have to purchase expensive hay from other regions of the state. These ranchers are faced with the prospect of either feeding their malnourished livestock on dwindling supplies of weeds and cactus or selling their cattle at depressed prices. A speedy decision by USDA will literally

have sought USDA permission to allow ranchers to grow hay and graze cattle on land covered under various federal conservation programs. Texas' initial request was rejected by USDA in mid-April on the grounds that "there is no evidence of the occurrence of a natural disaster in 1988 causing a current

shortage of hay." An additional 20 Texas counties, mostly in South Texas, have requested permission to participate in the Emergency Feed Program. Under the terms of the Emergency Feed Program, the federal government would share in the cost of feeding malnourished livestock in drought-stricken counties. The Texas Department of Agriculture is now making a survey of the quantities and location of federally-owned feed grain in Texas that would be available under the Emergency Feed Program.

determine the future of thousands of Texas producers," Hightower said.

The Texas Department of Agriculture is already taking steps to help these livestock producers. We are working with livestock specialists, soil conservation experts and local officials to hold a series of seminars in the most severe drought counties to help local ranchers with emergency land and herd management practices. Those one-day seminars will begin in early June. TDA is also assisting county officials in gathering information required by the Governor's Division of Emergency Management before federal disaster assistance can be requested. All of these efforts are needed because the National Weather Service has projected little or no improvement in rainfall conditions during the normally dry summer months," Hightower said.




