

3,330 voters register in Hansford County

In this year's presidential election, Hansford County has 3,330 registered voters for the Nov. 8 election. This compares to 3,309 registered voters for last November's 'non-presidential' election. This means 21 additional voters have registered in Hansford County this year for the presidential election.

In the last presidential election in 1984 where about the same number were registered but only 2,472 voted in the election.

All voters are encouraged to exercise their freedom to vote on Nov. 8 in the general election to elect presidential electors, members of the Legislature, and state, district, county and precinct officers, and for the purpose of adopting or rejecting the proposed Constitutional Amendments as submitted by the 70th Legislature.

Polling places will be opened from 7 a.m. to 7 p.m. at the following locations:

Voters of precinct one will vote at the Hansford County Courthouse. Precinct two voting location is at the Renner Ranch.

Lynx battle West Texas to draw

Facing a must win situation to remain in the playoff hunt, the 1988 Spearman Lynx traveled to neighboring Stinnett to tangle with the West Texas High Comanches. A battle of two outstanding defensive squads ensued, and when the final gun sounded the two had scrapped to a 7 to 7 tie.

The only scoring on the night

took place in the first half of play, with the Comanches scoring first on a blocked Lynx punt at the beginning of the second quarter which rolled into the end zone and was recovered by the Comanches for the score. The point after was good by West Texas' #52 David Weber and the Lynx trailed 0 to 7 with 11:20 remaining in the first half.

The Lynx evened the score two possessions later on what proved to be the only sustained drive of the night by either club.

Following a John Hughes recovery of a Comanche fumble at the W.T. 43-yard line, the Lynx crossed the scoring stripe by virtue of an eight play, 43-yard drive. On a third down and eight play from the 25-yard line, the fleet-footed Shawn Cook outraced pursuit down the sidelines before being bumped out at the one yard line. J. Garnett sneaked over from the one on the next play for the score. The first half clock had wound down to 3:00 before halftime, when Matt Tucker

booted the extra point to knot the score at 7 to 7.

The second half of the game was a classic defensive duel. Neither team could find much success on the ground or through the air and the tie remained intact when the scoreboard clock read 0:00.

It was not a good night for either side in the fumble department, as that too wound up a tie at five each during the game. The Lynx recovered all five of the Comanche fumbles, while the Lynx donated three of theirs to the Comanches.

Statistically the Lynx appeared to have the upper hand, however they also suffered two pass interceptions and were penalized five times for a total of 55 yards.

The tie, for all practical purposes, has dashed the Lynx chances for a playoff spot. It would take miracle wins by Boys Ranch over Panhandle (last Friday night), and a Stratford upset of West Texas High next week for the Lynx to have even a coin-flip chance.

The Lynx close-out the season

next Friday night at home as they face the Boys Ranch Roughriders, kick-off at 7:30 p.m.

14 seniors will be wearing their Lynx football uniforms for the last time at Lynx Stadium. The staff of the Spearman Reporter and the Hansford Plainsman would like to join the rest of the community in congratulating them on a very respectable season, and thanking them for the thrills and enjoyment they have provided.

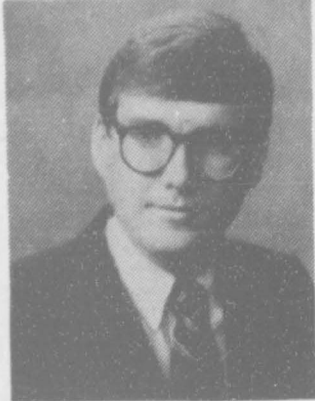

Consumers cautioned to check heating systems

Noting "accidents go up as the thermometer goes down," Railroad Commission Chairman James E. (Jim) Nugent today called on utility companies to remind homeowners and businesses across the state to have their gas furnaces and heating systems checked before cold winter weather reaches Texas.

"Every year we see an increase in the number of accidents involving natural gas as cold weather grips the state," Nugent said. "A simple check for leaks or other problems now can prevent tragedy later as furnaces are fired up for the heating season."

Nugent sent a letter this week to Texas gas utility companies asking company officials to enclose a safety reminder with gas bills or

other letter going out to customers. "Reminding your customers to use caution in the start-up and initial use of gas heating systems that have not been used for months may well save property and lives," he said.

Railroad Commission statistics show 39 explosions, fires, leaks, or other incidents involving natural gas in homes or businesses have been reported through the end of September this year, he said. The accidents have claimed five lives and injured 12 others.

"The majority of these tragedies occurred during the first four months of the year - the prime heating season," Nugent said. "A little caution is a small price to pay to make sure the system is safe and ready for winter."

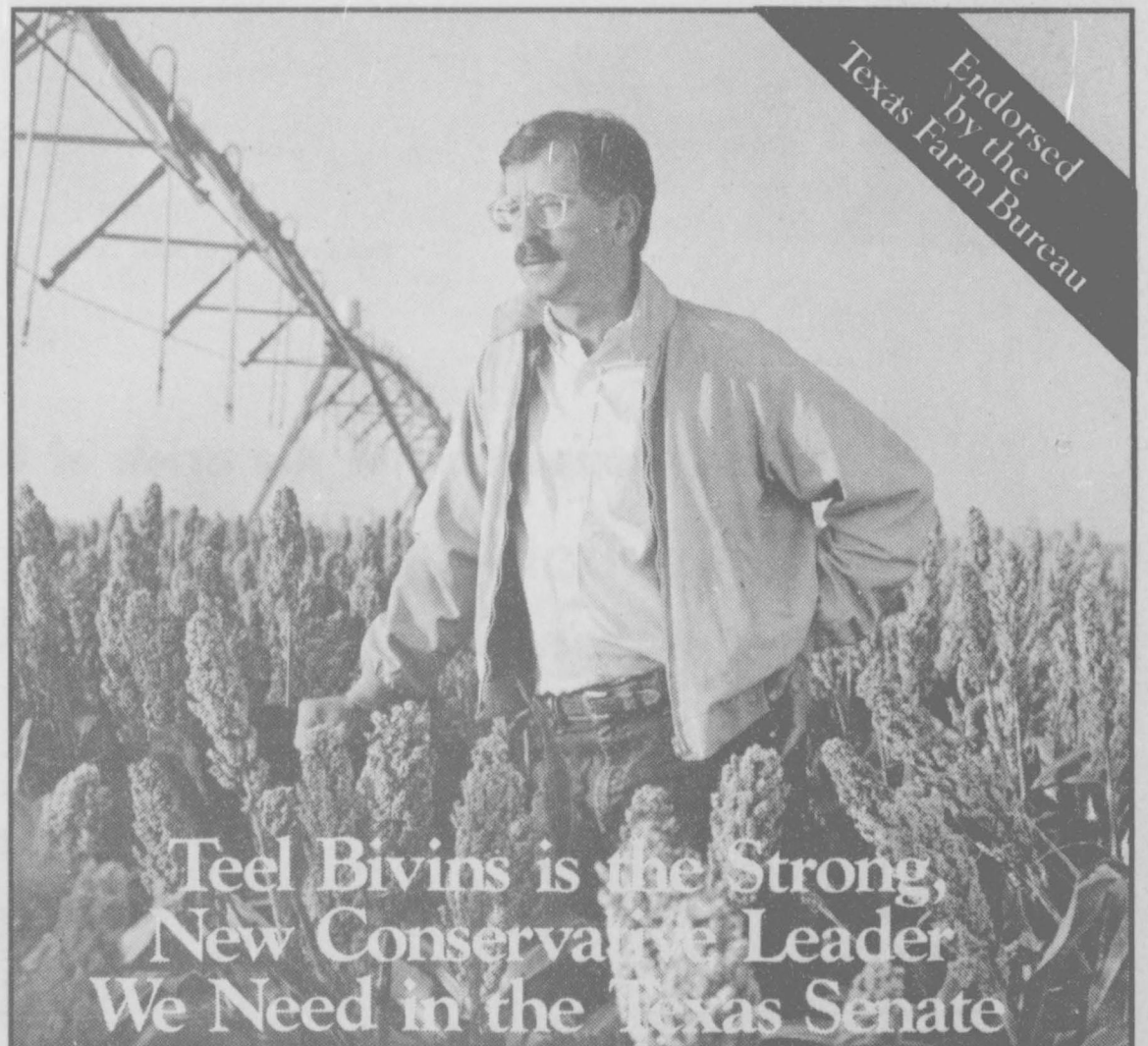

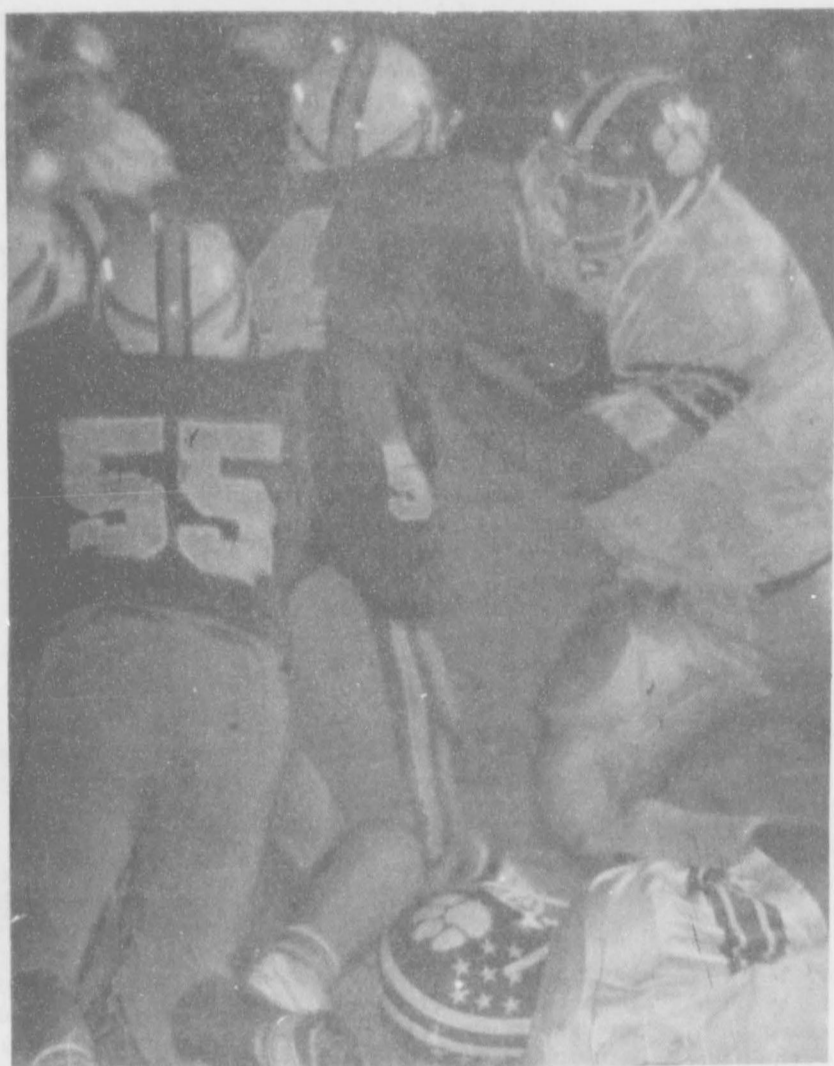

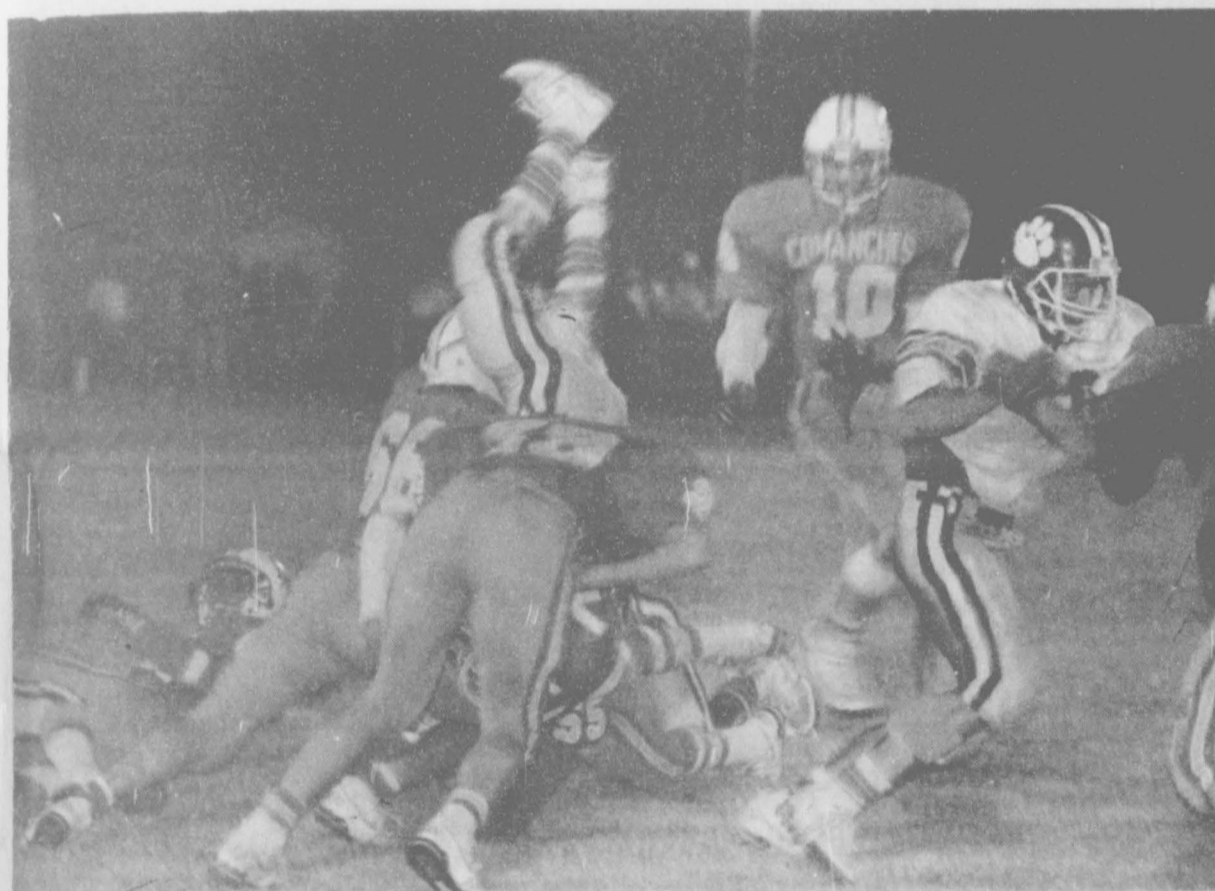
