Bond election calls for !\$2,500,000.00 for Manor and Hospital improvements

Bond election to be held December 17th

Hansford County residents have been notified that they will vote on the 17th day of December to decide on a bond election for the construction, repair or renovation of the buildings and improvements at Hansford Manor and the hospital in Spearman. The amount voted on is \$2,500,000.00 and the complete details are printed below. Of course your newspaper is for this very worthwhile project, which mainly is to add some 40 beds to the Hansford Manor.

Voting places, and questions to any of the proposed bond election can be answered by the hospital members, and of course the news papers in the county will be glad to furnish any kind of information that we can.

TAKE NOTICE that an election will be held in the Hansford County Hospital District on the 17th day of December, 1985, in accordance with an order adopted by the Board of Directors which is a part of this notice for all purposes and reads as follows:

AN ORDER ordering a bond election to be held in the Hansford County Hospital District, making provision for the conduct of the election and resolving other matters incident and related to such election.

WHEREAS, the Board of Directors of the Hansford County Hospital District, hereby finds that an election should be held to determine whether said governing body shall be authorized to issue bonds of said District in the amounts and for the purposes hereinafter identified; therefore,

BE IT ORDERED BY THE BOARD OF DIRECTORS OF THE HANSFORD COUNTY HOSPITAL DISTRICT:

SECTION 1: An election shall be held on the 17th day of December, 1985, in the Hansford County Hospital District, for the purpose of submitting the following proposition:

"SHALL the Board of Directors of the Hansford County Hospital District, be authorized to issue bonds of the District in the principal amount of \$2,500,000 for the construction, repair or renovation of buildings and improvements and equipping the same for hospital purposes; such bonds to mature serially or otherwise over a period not to exceed FORTY (40) years from their date, to be issued and sold in one or more series at any price or prices and to bear interest at any rate or rates (fixed, floating, variable or otherwise) as shall be determined within the discretion of the Board of Directors at the time of issuance or sale of the bonds; and whether ad valorem taxes shall be levied upon all taxable property in the District sufficient to pay the annual interest and provide a sinking fund to pay the bonds at maturity?"

SECTION 2: Paper ballots shall be used for said election, which ballots shall be prepared in accordance with the V.A.T.S. Election Code so as to permit the electors to vote "FOR" or "AGAINST" the aforesaid proposition. Said proposition shall appear on the ballot substantially as follows:

"THE ISSUANCE OF \$2,500,000 GENERAL OBLIGATION BONDS FOR HOSPITAL PURPOSES"


SECTION 3: The District shall be divided into four (4) election precincts for this election and the polling places designated for each election precinct and the persons hereby appointed to serve as Presiding Judge and Alternate Presiding Judge for each polling place are shown in Exhibit "A", which is attached hereto and incorporated herein by reference as a part hereof for all purposes.

Each Presiding Judge shall appoint not less than two (2) nor more than six (6) qualified clerks to serve and assist in holding said election; provided that if the Presiding Judge herein appointed actually serves, the Alternate Presiding Judge shall be one of the clerks.

On election day, the polls shall be open from 7:00 A.M. to 7:00 P.M.

Dennis Robertson is hereby appointed the Clerk and Debra DeArmand the Deputy Clerk for absentee voting for said election, and the Administration Office of the Hansford Hospital District, 707 South Roland, Spearman, Texas 79081, is hereby designated the place for absentee voting. The hours designated for absentee voting by personal appearance shall be from 8:00 A.M. to 3:00 P.M. on each day, except Saturdays, Sunday and official State holidays, during the period required by law for conducting absentee voting.

A Special Canvassing Board shall be used for this election in relation to absentee voting and Charlene Bryan is appointed Presiding Judge and Muriel Boyd the Alternate Presiding Judge of the Special Canvassing Board for absentee voting.

HANSFORD MANOR

Hansford Manor expansion project is moving right along. Above you see the "View from the Terrace" drawing as designed by Cox/Croslin & Associates from Austin. What you are seeing is the south terrace looking into the large day room with fireplace and cathedral ceilings. To the right and left of the day room you can see the two smaller quiet areas. One of the areas will have french doors and can be closed for private visits with family and friends if residents desire.

Other construction will consist of a new and greatly enlarged dining room with doors opening to a large terrace for spring and summer dining as well as cookouts.

In the residential section there will be eight suites which are much like large and compatibly equipped hotel suites, there is also a small refrigerator in the rooms. Nine private rooms and eight semi-private rooms, new nurses stations

and support areas complete the expected 2.2 million dollar expansion and renovation project.

At this time a bond issue is tentatively scheduled for December 17, and if passed with a beginning construction date of mid March, 1986 and completion 12 months later. We currently have 30 individuals on our waiting list and it seems to grow every day. There is no question that this expansion is needed and with additional beds it will help to bring the facility into a better financial situation. It is expected that the expansion will generate enough revenue to retire the bond without increasing taxes.

The preliminary drawings are in the administrator's office in the hospital and are available to the public for review and comments. Mr. Dennis Robertson will be glad to answer any questions you might have.

SECTION 4: All resident qualified electors of the District shall be permitted to vote at such election, and on the day of the election, such electors shall vote at the polling place designated for the District Election Precinct in which they reside. This election shall be held and conducted in accordance with the Texas Election Code, except as modified by Chapter 372, Acts of the 62nd Legislature, Regular Session, 1971, and as may be required by law, all election materials and proceedings shall be printed in both English and Spanish.

SECTION 5: A substantial copy of this order shall serve as proper notice of said election. Said notice, including a Spanish translation thereof, shall be posted at three (3) public places within the District and at the administration offices of the District not less than fourteen (14) full days prior to the date the election is to be held, and be published on the same day in each of two successive weeks in a newspaper of general circulation in the District, the first of said publications to be made not less than fourteen (14) full days prior to the date set for said election.

Coming to Hansford County:

FIRST PLUS CREDIT

Don Townsen, President of the First National Bank announced today the introduction of a new banking service that has not previously been available to Spearman and Hansford County. The new service for wholesalers, retailers and service industries will be offered by First National Bank the first of the year. It will be called First Plus Credit. Don expects First Plus Credit to be well received by the community and will provide a valuable service for those businesses who wish to participate.

First Plus Credit is First National's trade name for a service known as "accounts receivable factoring". The factoring of accounts is a banking service that has been used extensively in merchant banking for many years by urban banks and businesses. Factoring accounts very simply means that the participating merchant can take his current accounts receivable to the bank and get cash for them. For a small fee, and the participating merchants guarantee of the accounts, the bank sets up charge accounts for the merchants customers. Then each charge purchase by the customer is deposited at the bank for immediate credit to the merchant. The bank then handles all billing, record keeping and receiving of payments on the accounts. The accounts are billed out monthly similar to the way credit card purchases are billed. The monthly statement to the customer will show his total charges for the month to the merchant and will have invoices enclosed. Then the customer is given the option of paying off the balance of the account at no interest, for the time from purchase to statement date, or the customer may pay a minimum of

20% of the balance and finance the rest for the next 30 days.

Don commented, "The merchants have been very good to provide charge accounts to the people in the community. They have provided farmers and all other credit worthy purchasers with a very convenient source of short term credit. There is more charge purchasing than any community of this size that I have seen, and it has been very successfully handled with apparently small losses on delinquent accounts. It appears though, that the economic slow down has increased the amount of outstanding accounts and slowed down the repayments, causing tighter cash positions for the merchants. The increase also may force some merchants to hire additional help or to buy computer facilities to handle maintenance and billing of their accounts. Our bank has in-house computer facilities and will have capable people trained and ready to handle the merchants account maintenance, billing and payment processing. First Plus Credit can significantly reduce the merchants' expenses and time spent on maintenance of account receivable and provide instant cash for the accounts. All for a small fee of 2 to 2 1/4% of the accounts factored, about one-half the cost of Master Card and Visa purchases."

"First Plus Credit will be available beginning January 2, 1986, but we will be very happy to answer questions and visit with the merchants about this new service at their convenience," explained Don Townsen. He urges interested merchants to call him or to stop by the First National Bank.

Proposed additon to Hansford Manor



Pictured above is an overall view of the existing facility and the proposed expansion.

The new building will contain 15,312 square feet and 2,171 square feet in the remodeling of the existing facility.

Hopefully, at the November 14, Board meeting, the architect will have available a scale model of the complete facility. This model will be placed in various locations for the citizens of Spearman and Gruver to view. At this time a bond election is tentatively scheduled for December 17th.

It will take approximately one

year to complete the project. At the completion, we feel that Hansford Manor will be an outstanding asset to our community and to the residents of Hansford County.

In many ways our facility will be a pace setter for this area. We will be capable of offering "suites" to our residents who request such. The suites are designed primarily to accommodate residents that need only minimal supervision, assistance with medications or diets, or only the assurance that licensed medical personnel is available, if needed, 24 hours per day.



Dash salt
1 tablespoon plus 1 teaspoon granulated sugar
1/4 cup thawed frozen dairy whipped topping
Ground nutmeg

In small bowl sprinkle gelatin over 2 tablespoons skim milk. Let stand a few minutes to soften. In 1-quart saucepan heat remaining milk to a simmer; stir in gelatin mixture and custard mix and cook, stirring constantly, until custard and gelatin are dissolved, about 2 minutes. Stir in extracts and pour into medium bowl; refrigerate, stirring occasionally, until mixture begins to set, 30 to 45 minutes.
In mixing bowl, using electric mixer on high speed, beat egg whites with salt until soft peaks form; gradually beat in sugar, beating until whites are stiff but not dry. Carefully fold whites into custard mixture; spoon custard into 4 sherbet glasses. Cover and refrigerate until chilled, about 2 hours. To serve, top each portion with 1 tablespoon whipped topping and dash nutmeg.

Weight Watchers

FENNEL CASSEROLE

Makes 4 servings, each providing: 3-3/4 Vegetable Exchanges; 1 Fat Exchange; 15 calories Optional Exchange

1 tablespoon olive or vegetable oil
1-1/2 pounds fennel, cut into 3x1/2-inch strips (about 4 cups)
2 cups sliced onions (thin strips)
1 to 2 small garlic cloves, minced
1-1/2 cups canned Italian tomatoes (with liquid), drain and coarsely chop tomatoes, reserving liquid
1 tablespoon chopped fresh Italian (flat-leaf) parsley
1/4 teaspoon each salt and pepper
1 tablespoon each plain dried bread crumbs and grated Parmesan cheese
1 teaspoon margarine, melted
1/4 teaspoon grated lemon peel
Garnish: chopped fresh parsley

In 12-inch nonstick skillet heat oil over high heat; add fennel, onions, and garlic and saute, stirring occasionally, until fennel is tender-crisp. Stir in tomatoes, reserved liquid, parsley, salt, and pepper and cook until heated, 1 to 2 minutes. Remove from heat and transfer to 1-1/2 quart flameproof casserole.
In small bowl combine remaining ingredients; sprinkle crumb mixture evenly over vegetables and broil until topping is browned, about 1 minute. Serve garnished with parsley.



ENDIVE AND ARUGULA SALAD

Makes 4 servings, each providing: 2 Vegetable Exchanges; 1 Fat Exchange

4 medium Belgian endives
2 cups arugula leaves
2 tablespoons rice vinegar
1 tablespoon plus 1 teaspoon olive oil
1/2 teaspoon Dijon-style mustard
Dash each salt and pepper



CRIME STOPPERS



VICTORIA, TEXAS--Dale Ray Waller has been described as a one man crime wave by law enforcement authorities in four states.

The 37-year-old Waller is wanted by 14 law enforcement agencies in Arkansas, New Mexico, Oklahoma and Texas on a wide variety of charges ranging from Burglary to Fraud, Theft and Embezzlement. Even the federal authorities want to get their hands on the travelling fugitive, since he is wanted by the U.S. Marshal's Office for Parole Violation.

This week Waller has been added to the Texas Most Wanted List. A reward of up to \$1,000 is being offered by the Governor's Office for information leading to the capture of this most wanted fugitive.

Waller, whose list of aliases almost matches the number of charges against him, is wanted by no less than nine law enforcement agencies in Texas.

A typical case involving Waller is the January 3, 1984, theft of a camper shell from a Victoria recreational vehicle dealer. A man identifying himself as Roy L. Matthews bought a 1982 Viking Brand camper shell, using a \$2,500 check drawn on an account with First State Bank in Port Lavaca. However, a week after the purchase, the Victoria business was notified that there was no account with First State Bank listing Roy L. Matthews.

Investigators, with the assistance of the Department of Public Safety's Crime Analysis Unit, were able to identify Waller as the suspect in the case. Roy L. Matthews, it turned out, was just another alias used by Waller.

On March 5, 1984, Waller was indicted by the Victoria County Grand Jury for Felony Theft.

In addition to the Victoria County charges, Waller is also wanted by the following Texas agencies.



--Reagan County Sheriff's Department for Forgery and Burglary (warrant issued January 18, 1985).

--Yoakum County Sheriff's Department for Larceny (warrant issued January 29, 1985)
--Comanche County Sheriff's Department for Larceny and Theft (warrant issued February 12, 1985)
--Rusk County Sheriff's Department for Larceny and Theft (warrant issued September 23, 1985)
--Hunt County Sheriff's Department for Larceny and Theft (warrant issued October 4, 1985).
In addition to all the Texas charges, Waller is also wanted for embezzlement by law enforcement agencies in McAlester and Eufaula, Oklahoma; Fraud in Batesville, Arkansas; and Fraud and Forgery in Clovis, New Mexico.

ABILENE, TEXAS--Mario Blas Valera didn't waste much time getting into trouble with the law in his adopted country.

A native Cuba who emigrated to the United States during the Mariel Cuban boat lift about seven years ago, Valera is wanted by Abilene Law enforcement authorities for the October 28 murder of Frank E. Henry.

Investigators say the 44-year-old Valera also caught the attention of the Miami Police Department before leaving Florida, primarily over allegations that he was trafficking cocaine and marijuana.

Henry was gunned down on an Abilene street in what detectives believe was a narcotics-related killing. Witnesses told police the shooting appeared to be unprovoked.

An autopsy revealed that Henry was hit with what appeared to be a .32-caliber slug. When investigators searched Valera's apartment in Abilene, they found a partial box of Winchester .32-caliber silver-tipped hollow-point bullets.

Ironically, Valera had been arrested on September 3 in Abilene for Unlawful Carrying of a Weapon.

Detectives say that they received information that following Henry's murder, Valera fled to Odessa where there is a large concentration of Mariel Cubans.

He is also known to travel between El Paso, Odessa and Lubbock.

This week Valera has been added to the Texas Most Wanted List.

A reward of up to \$1,000.00 is being offered by the Governor's Office for information leading to Valera's arrest.

He is described as being 5-6, 160 pounds, with black hair, brown eyes and has a very dark complexion.

Valera goes by several aliases, including the name Jean Finley.

Associates have told investigators that Valera usually carries a gun and has a reputation of having a quick temper. He is known to have contacts in Miami, New York City and Juarez, Mexico.

An emotion-filled series of paintings illustrating the feelings of Glen Ayers during his tour of duty in Vietnam was on display recently at the Center for the Arts in Dallas.

Artist Glen Ayers describes the works as "one soldier's intimate view of Vietnam." Many of the paintings were done while Ayers was in the field in Vietnam. He would take photos out in the bush during the day, and was allowed to paint at night in a small room with blankets draped over the windows to prevent shooting by snipes. His parents sent him paint and brushes and he used old canvas jeep covers as canvas for his portraits.

The works were on display at the Center for the Arts, Jacee Park, 2000 W. Airport Freeway in conjunction with the Irving Art Association nonjuried show which was held Sept. 29 through October 11.

A reception was held and during this time, Ayers was interviewed over channel 5. Ayers now makes his home in Irving with wife Cathy and two sons Scott Glen two years old and Trevor Austin who is 6 weeks old. Glen was reared in the Spearman Area and his parents, Flavil and Josephine Ayers now reside in Gruver.

In observance of Veteran's Day in 1973, Cpt. Ayers wrote a letter to the People of Spearman, which was also published in the Faith Independent of Faith, South Dakota the residence of his parents at that time. Since Veterans Day was observed about 3 weeks ago and Thanksgiving just last

week, the editor of the Gruver Statesman would like to reprint this letter that was written over 12 years ago.

Dear People of Spearman. This letter is a letter of appreciation to a town called Spearman and the people who live there.

I have been in Viet Nam eight months now and I will be very glad to get back home. Every once in awhile, a fellow Marine asks me where I am from. I tell him. Of course he asks me where that is, which makes me a little mad, but I am proud of my little home town with its one little stop light, which seems to be the pulsating heart of a happy town.

A town floating in a sea of wheat with a proud banner called an elevator. It is a town far from killing and hunger. It only seems to have to worry about the next wheat harvest.

Being in a war zone, I have come to appreciate that little town more than ever. I hope my little town never has to experience the terrifying sight of bombs being dropped on its buildings Or the flashing of flares all night long. I hope my little town never has to run to a foxhole everytime the fire whistle blows. The most important thing I don't want the people of Spearman to experience is the cold, weak terrifying feeling a human gets when bullets are buzzing all around him or mortar rounds are walking toward the foxhole he is in.

There is one particular group in my town I would really like to say something about. They are called Veterans. I know there are many in our town alone. Chances are they are solid citizens in the community and very glad to be a part of the town. Chances are they appreciate life very much and are doing a lot to help the town.

When I first came to Viet Nam, there was a sign over my bed. It read "to live you almost die, to those who fight for it, life has a savior the protected will never know." To you as Veterans you know exactly what those words mean. To you who are not Veterans, go find a veteran and shake his hand. You can bet he will appreciate it and the fact he is able to shake your hand.

In conclusion I must say something about the men who have given their lives to Spearman. They are monuments now, an inseperable part of Spearman. A monument along with the elevators and the wheatfields. They are truly Spearmanites and will never be loyal to another town and truly will be remembered as long as Spearman wants to remember them.


