Join Your Spearman Fire Dept.

The Spearman Volunteer Fire Department consists of several members. As it is with any group of people, especially with a few new members, in order to function as a team and get along a chain of command is needed. Departmental officers consist of the fire chief, two assistant chiefs, and four captains. Without these assistants and captains the fire chief's job would be impossible.



James "Butch" Nobles, is one of the captains. He and his wife, Myong Chun, have lived in Spearman for fifteen years. Butch is employed by Whitehouse Lumber Company, and has been with the fire department for two years. He joined the team of firefighters after talking with the fire chief, another member, and attending a meeting to satisfy his curiosity.

Butch enjoys the personal satisfaction that he receives from knowing that he has the training and capabilities to help someone in need. The fire prevention that he has learned makes him feel safer at home, and he says that he is confident that he can help someone with this knowledge to some extent, even without firefighting equipment.

He has furthered his training of fire prevention and suppression by attending schools at Canyon, A&M, and several here in Spearman. He has also attended the jaws of life school. The responsibilities of a captain vary according to different situations. Butch is primarily in charge of making sure his unit is kept in shape, making sure that the members of his team are outfitted properly, and he is in charge at the fire scene until the chief or an assistant chief arrives. His unit #52 is the first unit out in response to fire emergencies. He would like to see more people on the department in order to provide the community with a better twenty-four hour protection against fires and other emergencies.



Fire Chief, Ron Antalek, has two assistant chiefs that help him in the line

of duty. The first Assistant Chief is, Bill Porter. Bill is employed by Golden Spread Sales company. He and his wife, Terry Ann, have lived in Spearman for eleven years. They have two daughters, Mandi and Becky.

Bill has been a firefighter with the Spearman Fire Department for seven years. He joined the department because his father was a fireman. Being unable to serve his country made him more devoted to serving his community. He derives satisfaction by knowing that being on the fire department he may someday be a benefit to this community, his family, and his friends.

He is aware of the hazards of firefighting, but says that living day to day is a hazard also, and he likes the benefits and personal satisfaction that helping the community gives him. Bill, is a certified E.C.A. AND E.M.T.. He has attended schools at Canyon, A&M, and Spearman, including a radiological school.

As First Assistant Chief he is in charge of all business meeting. He is also in charge at the fire scene in the absence of the fire chief. He handles any departmental problem that for personal reasons the chief feels unable to handle. He believes that the department needs more dedicated people, more upgraded equipment to better handle emergency or crisis situations. Bill also would like to educate the people of the community as to what extent fire prevention could help them.

The meeting was called to order by Jack Oakes, President.

The Minutes of the Special Call Meetings of August 25, and Sept. 5th were read and approved on a motion by Jerry Hunt, seconded by Dwight Hutchison, and approved by a vote of 4 for, 0 against. The minutes of the Regular Board Meeting of August 14, 1986 were read and are to be corrected as follows:

After a return to order, a motion

was made by Alton Ellsworth, seconded by Dwight Hutchison, to award the contract to the lower bidder, Reid & Gary Strickland Co. It was discussed among the board members that taking the lesser number of construction days into consideration would actually result in the bid of Strickland being in the lesser amount than the bid of Reynosa Co. The awarding of the bid to Reid & Gary Strickland Co. was approved by a vote of 6-0.

The monthly bills were presented to the Board for their consideration. Motion was made by Jerry Hunt and seconded by Alton Ellsworth, to approve payment of these bills. Approved by all present.

Mr. Robertson requested an extension of the line of credit in the amount of \$75,000 to complete the physical year. Alton Ellsworth made a motion that the Administrator be authorized to negotiate an additional line of credit in the amount \$75,000 to finish the physical year, Jerry Hunt seconded the motion. Approved by all present.

Mr. Robertson advised the Board that George Odom had made a bid of \$4,000 for the 3 lots next to the Gruver Clinic. After considerable discussion, the motion was made by Alton Ellsworth, seconded by Dwight Hutch-

ison, to table the sale at this time. Motion was approved by a vote of 4-0.

Mr. Robertson advised the Board that the termination notice on West Texas Auxiliary Service would be final September 14. The physicians had requested that the Board reconsider terminating this service. Therefore, Dwight Hutchison made a motion to withdraw the termination notice, seconded by Alton Ellsworth, and approved by a vote of 4-0.

The Board heard from Ed Geurin and W.R. Spencer, of Geurin Construction & Spencer Paint Co., on the remodeling of the clinic at 720 S. Roland for Dr. Taylor. They said it would take 4 weeks to do the remodeling. The Board along with Mr. Geurin and Mr. Spencer went to the clinic to review all that was necessary to get the clinic ready for occupancy. After considerable discussion, the Board authorized Mr. Robertson to proceed on the remodeling of the clinic, on a motion made by Jerry Hunt, seconded by Alton Ellsworth, and approved by all present.

There being no further business, motion was made by Jerry Hunt, seconded by Alton Ellsworth, to adjourn the meeting. Approved by all present.

Sheriff's Dept. Is Busy

The Hansford County Sheriff's Dept has been busy this month. The Joe T. Venneman Farms and Bill Logsdon Farms reported to the Sheriff that \$2500 worth of farm equipment had been stolen. The Sheriff's Dept. arrest three subjects who apparently had taken the following equipment from the farms. Aluminum pipe, and aluminum hydrants. Two of the subjects, Charles Brooks and Earnest Brooks were both arrested in Perryton and returned to Spearman. A third subject, Thomas Fletcher was arrested in Abilene, Kansas and returned to Spearman. All three men are in jail and their case will be presented to the Grand Jury October 2nd.

Bill Wilbert Leat has been arrested for un-authorized use of a motor vehicle. He allegedly stole a 1976 model car from Rosetta Tindell. He is being held in Huntsville awaiting transfer to the Spearman jail. Billy Ray Lightcap was arrested in McAlister, Oklahoma for allegedly burning a car in Bernstein. The car was a New Camero.

Probation revocation warrants were issued on four men Neal Rosecrans allegedly stole some drill bits from Baker Taylor. Don Edgett is being

held for credit card theft. Steve Howell is being held for alleged burglary. Steven Crisp is being held for alleged forgery. All four of these have violated their parole.

Karl Hertenrater is being held in Pecos County Florida for forgery, allegedly committed in Hansford County.

Two Juvenile girls were arrested and detained for vandalism. The Sheriff Department turned them over to their parents. Also two run-away girls, one from Spearman, and one from Gruver, were arrested and turned over to their parents.

Sheriff R.L. McFarlin reminds local business men that they are now working seven theft by check charges in Hansford County. The local Sheriff Department is also pursuing seventeen active warrants at this time. Henry Persche is being charged on a felony DWI. This will go to the Grand Jury Oct. 2nd. Persche is from Perryton.

Terry Figures of Dalhart, Texas has been charged with a misdemeanor DWI. This will go to County Court.

The Sheriff's Department is still investigating 18 head of cattle that apparently was dumped in the County.

The cattle were found at the Robert Novak Farm east of Spearman. They have a backward C on the right hip.

Keith Lamb, who lives 7 miles north of Gruver reports a bronze colored three HP Briggs Stratton motor attached to a yellow 2' pump was stolen. Theft of tools from 719 Collier has been reported. The tools were taken from the cab of a locked pick-up. Sheriff McFarlin will be presenting 5 cases to the new Grand Jury Oct. 2nd.

Since September 1st through Sept. 19 the Sheriff Department has made 11 arrests. They also cleared the theft of some tools from Speartex Grain. A portion of the tools has been recovered.

The Department reports that a lo-boy trailer has been left at the Harold Crooks place East of Spearman.

This Newspaper joins in congratulating the entire Sheriff Department for voluntarily taking the drug test that President Reagan had requested our officials to take. Also the Sheriff's Department cut 27,000 Dollars from their budget this year. Each member took a 5% pay cut.

Fall rains cause 3-foot lake rise

Heavy rains in early September have resulted in a rise of almost three feet on Lake Meredith which has a depth of 76.5 feet at its dam near Sanford.

The lake has continued to rise from runoff flowing down the Canadian River, following a series of heavy rainstorms which began over the Labor Day weekend two weeks ago.

On Aug. 31, the depth reading at the dam was down to 73.65 feet and falling.

"This has been a good rise on the lake," observes Red Marable of Stinnett, an employee of the Canadian River Municipal Water Authority. "It takes a lot of water to bring the lake up almost three feet."

The early September rains soaked a wide area of the Canadian River watershed in Moore, Hartley, Dallam and

Oldham counties of the Texas Panhandle and sections of eastern New Mexico.

From four to six inches of rain fell in the area, saturating farm and ranchlands.

Lake Meredith has a surface area at the 76.5-foot depth of 8,196 acres, according to CRMWA officials.

Preparing for the ACT Assessment

As the new school year begins, more than one million high school juniors and seniors across the nation are preparing to take the ACT Assessment.

The ACT Assessment, which consists of four academic tests that measure educational development and a detailed questionnaire that collects information relevant to educational and career planning, is recommended or required by more than 2,700 postsecondary institutions and scholarship programs.

Most students take the ACT Assessment during junior year or early in senior year, so their results will be available in time for use in planning for postsecondary education and careers.

High School guidance offices have the information and forms students need to register for the ACT Assessment. ACT also provides free copies of the booklet, *Preparing for the ACT Assessment*, which contains information about getting ready for the examination, plus a complete practice test.

The basic registration fee for the Assessment is \$10.50. Late registration will be accepted for an additional \$10.00 late handling fee. For 1986-87, ACT has established this test date schedule:

It takes about three hours to complete the four ACT examinations in English, math, social studies, and natural sciences. The Assessment also includes a two-part questionnaire that students complete at home when they register. It focuses on interests, academic and nonacademic accomplishments, and vocational and educational plans and needs.

Colleges use information from the ACT Assessment for academic advising, admissions counseling, course sectioning and placement, student services, and institutional research. ACT Assessment reports are sent to students, their high school counselors, and the institutions and agencies the student specifies.

The ACT Assessment is a major service of The American College Testing Program, which has national headquarters in Iowa City, Iowa.

PUBLIC NOTICE BRIEF EXPLANATORY STATEMENTS OF PROPOSED CONSTITUTIONAL AMENDMENTS GENERAL ELECTION NOVEMBER 4, 1986

PROPOSITION NO. 1 ON THE BALLOT

Senate Joint Resolution 15 proposes a constitutional amendment that would permit the legislature to provide by general law for the apportionment of the value of railroad rolling stock among the counties in which the property of the railroad is located for purposes of property taxation, and would delete the requirement that the Comptroller participate in making the allocation. To comply with both statutory and constitutional law, the apportionment currently is being made by the State Property Tax Board in conjunction with the Comptroller.

The proposed amendment will appear on the ballot as follows:
"The constitutional amendment to allow the legislature to provide by general law for the apportionment of the value of railroad rolling stock among counties for purposes of property taxation."

PROPOSITION NO. 2 ON THE BALLOT

Senate Joint Resolution 33 proposes a constitutional amendment that would replace the constitutional requirement that the subject of a bill be expressed in its title with a mandate that each house of the legislature adopt rules of procedure that would require the subject of each bill to be expressed in its title in a manner that gives the legislature and the public reasonable notice of that subject. Determining compliance with the rule would be the responsibility of the legislature. Currently, a law is invalidated if a court finds its caption is defective. The amendment would provide that past and future enactments may not be held void on the basis of an insufficient title.

The amendment would also eliminate the suggestion that the state's laws be revised every ten years, and instead would provide for continuing revision of state laws.

The proposed amendment will appear on the ballot as follows:
"The constitutional amendment requiring each house to include in its rules of procedure a rule that each bill contain a title expressing the bill's subject, and providing for the continuing revision of state laws."

PROPOSITION NO. 3 ON THE BALLOT

House Joint Resolution 73 proposes a constitutional amendment that would permit the Legislature to authorize any county, city, town, or other political subdivision to use public funds or credit to pay insurance premiums on nonassessable life, health, or accident policies. Due to the prohibition in the constitution against the lending of credit and granting of public money, political subdivisions currently are prohibited from becoming shareholders in associations such as mutual-insurance companies, in which policyholders are shareholders. A nonassessable mutual insurance policy does not allow a company to raise capital by assessing the policyholder an extra amount on a pre-

mium. This amendment will allow mutual insurance companies and stock companies to bid for life and health group policies of political subdivisions. Public liability will be limited to the payment of premiums specified in the contract.

The proposed amendment will appear on the ballot as follows:
"The constitutional amendment allowing political subdivisions the opportunity to engage in and transact business with authorized mutual insurance companies in the same manner as with other insurance companies."

PROPOSITION NO. 4 ON THE BALLOT

Senate Joint Resolution 4 proposes a constitutional amendment that would repeal the prohibition against branch banking by state banks and would allow state banks and national banks domiciled in this state to establish and operate banking facilities at locations within the county or city where they are domiciled. The amendment would also authorize the Legislature to permit a state bank or a national bank domiciled in this state to engage in business at more than one place if it acquires a failed state bank or national bank domiciled in this state.

The proposed amendment will appear on the ballot as follows:
"The constitutional amendment to provide that a bank may offer full service banking at more than one location within the city or county where its principal facility is located, subject to limitations and restrictions provided by law."

National Merit Scholarship

Mark G. Allen Commended Student

Spearman High School has been notified by National Merit Scholarship Corporation (NMSC) of Evanston, Illinois, that Mark G. Allen has been designated a Commended Student in the 1987 National Merit Scholarship Program and will receive a Letter of Commendation in recognition of outstanding academic promise. The principal, Kenneth L. Friemel, announced today that on the basis of performance on the qualifying test for the 32nd annual Merit Program this senior placed in the top 50,000 of more than one million participants.

An officer of NMSC, which conducts the program, stated, "The very high test performance of the young men and women who are honored as Commended Students in the Merit Program is indicative of exceptional scholastic ability. We hope that NMSC's recognition of these high school students will increase their motivation to make the best use of their talents and to develop the skills that will be needed by the future leaders of our nation. Being named a Commended Student in this keen competition is a credit to these young citizens as well as to their schools, which play a key role in their development."

Participants entered the current Merit Program by taking the PSAT/NMSQT in October 1985, when most of them were juniors. Although their qualifying test scores are high, the 35,000 young people throughout the nation who are Commended Students scored slightly below the level required for Semifinalist standing in the Merit Program. Only the 15,000 Semifinalists, whose names were announced on September 11, will continue in the competition for some 6,000 Merit Scholarships to be awarded in the spring of 1987.

USDA Extends Comment Period

The closing date for comments on the proposed highly erodible land and wetland conservation provisions—commonly referred to as cross-compliance, sodbuster and swampbuster—of the Food Security Act of 1985 has been extended from August 26 to October 25, the U.S. Department of Agriculture has announced.

These provisions are designed to reduce soil loss due to wind and water erosion; protect the nation's long-term capability to produce food and fiber; reduce sedimentation and improve water quality; assist in preserving the

nation's wetlands; and lessen the incentives to produce agricultural commodities on highly erodible farmland.

The comment period was extended because of the complex issues involved in implementation of the new provisions.

Comments should be sent to: Director, Cotton, Grains, and Rice Division, USDA/ASCS, P.O. Box 2415, Washington, D.C. 20013, and must be received on or before October 27 to be assured of consideration.

The ACT Assessment

State Comptroller Bob Bullock Tuesday said he's preparing to take steps to keep the state's doors open if the legislature fails to solve Texas' cash flow problems.

"I'm gearing up some bookkeeping maneuvers to get around the cash shortage this December. I'm not talking about 'no pay', but I am talking about 'slow pay' to make sure the state has enough money to pay its bills," Bullock said.

He said a key element could include extensive use or borrowing the state's special funds which frequently earn from fees and taxes literally millions more than is needed to pay appropriations and expenses approved by the legislature.

Bullock said such a slow pay policy might delay city and MTA tax rebates, payments to the retirement funds and local school districts.

Bullock said the extraordinary bookkeeping measures would only put off the inevitable for a month or two at most by buying a little time to let tax collections catch up with expenses. It will give us a little breathing room until January.

The timing of General Revenue Fund money to the state's highway fund is another issue that is being studied.

"I haven't ruled out any option, but I'm going to see that the state meets its payroll and pays its bills—a bit late, perhaps—despite the cash flow problems we expect."

Now, Apples

Each year the nation learns of new dangers from food we eat—usually because of chemicals growers or processors use to increase profitability. The latest involves apples.

The danger apparently stems from a chemical called daminozide. It's contained in the spray Alar, used on about 33 percent of the apples grown in this country and also on some peanuts, peaches, cherries, concord grapes, tomatoes and a few other crops.

Daminozide is absorbed in the fruit or vegetable. You can't wash it away. Alar also contains another contaminant, according to "Consumer Report"—UDMH.

Both these contaminants cause cancerous tumors when fed to animals in large doses.

The Environmental Protection Agency proposed a ban on daminozide a year ago but such a howl came from growers and producers it backed off. Uniroyal, which manufactures daminozide, was asked to conduct more studies.

The danger is not immediate. It would take many years of eating apples and apple products to cause cancer, if fears are justified. But babies have that many years ahead of them. That's why the three big baby food makers have stopped using apples sprayed with solutions containing daminozide or UDMH.

DES MOINES, IOWA -- The Farm Credit System, the nation's largest farm lender, will lose up to \$1.8 billion this year and post significant losses next year because of the failing agricultural economy, officials said recently.



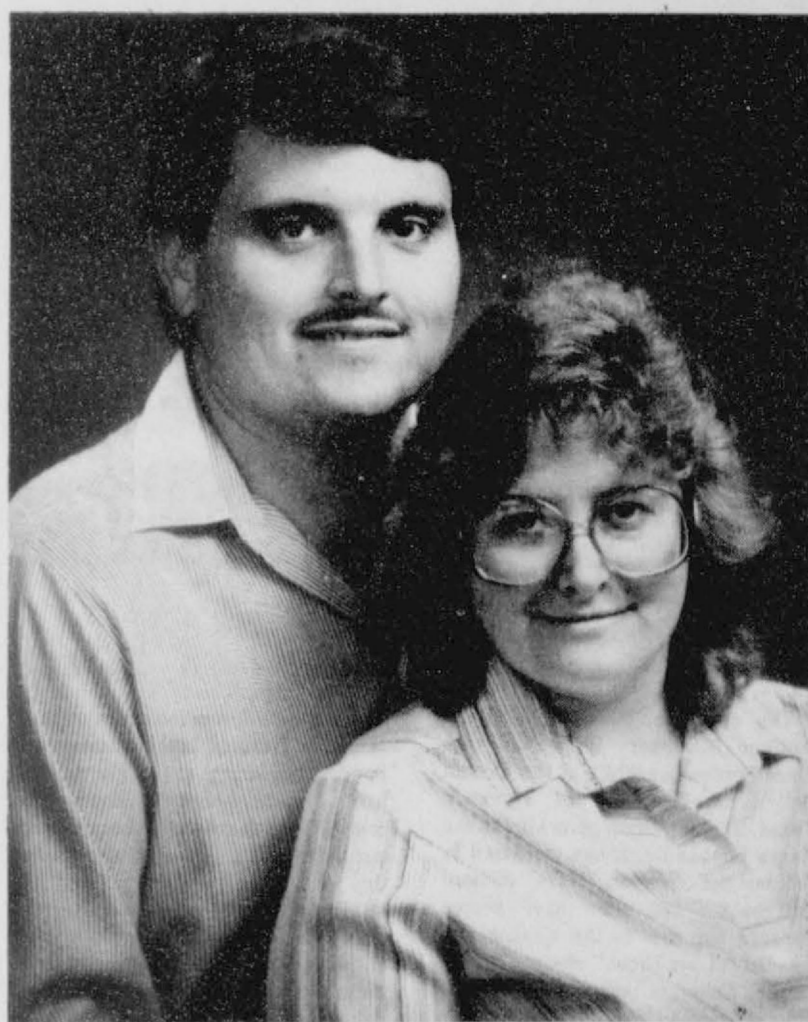
