

Taxpayers pamphlet available

Alice Peddy, chief appraiser for the Hansford County Appraisal District, offers district residents a tip to help them save on their property taxes.

According to Mrs. Peddy, a pamphlet available from the district office explains how the property tax system operates in Texas and highlights possible tax savings for property owners.

The State Property Tax Board in Austin publishes "Taxpayers" Rights, Remedies, Responsibilities!" under provisions of the Texas Property Tax Code, Mrs. Peddy said. She noted that the information in "Remedies" applies to property taxes collected by all types of local government - counties, cities, school districts and special districts such as hospitals and municipal utility districts.

Homeowners may qualify for a variety of property tax exemptions offered by taxing units on residence homesteads, Mrs. Peddy said. In Texas, a residence homesstead is essentially the house and yard used as the owner's principal residence. The taxpavers' pamphlet explains the exemptions and tells how to qualify and apply for them.

For example, all home owners in a school district are eligible for a \$5,000 general residence homestead exemption. Also, certain disabled taxpayers and those aged 65 or over may qualify for an additional \$10,000 exemption from the value of their homesteads.

"A taxpayer who was 65 or older on January 1 of this year is also entitled to a tax freeze, or ceiling, on the tax bill from the school district on his house and yard," Mrs. Peddy added. "This ceiling is based on the taxes assessed when a taxpayer receives the over-65 school homestead exemption for the first time. The ceiling remains the same as long as the elderly taxpayer, owns the homestead, or unless he makes an improvement like a swimming pool or an addition to the house.'

The chief appraiser pointed out, though, that elderly homeowners need not apply again this year if they obtained the exemption and tax freeze from the school district last year. Only those who became 65 during 1984 and those who have never had the exemption and freeze must apply for 1985.

Homeowners may also be eligible for a \$3,000 general homestead exemption from the county if the county levies a tax for farm-to-

market roads and/or flood control. Mrs. Peddy said that any taxing unit may also decide to offer a general "percentage" homestead exemption which can be granted this year for any percentage up to

of residence homesteads. The taxpayers' pamphlet also describes other exemptions which are available in this district, upon application, to disabled veterans and to other disabled citizens or those aged 65 and older.

30 percent off the appraised value

Another type of tax relief explained in the pamphlet is the special productivity valuation available to landowners. If the owner and the land qualify, agricultural "1-d" and open-space "1-d-1" acreage may be taxed on its value based on what the land produces rather than on what it would sell for in the open market.

Owners of land taxed last year on its productivity value under 1-d-1 open-space provisions do not have to reapply, unless requested in writing by the appraisal office to do so. However, landowners must apply before May 1 this year for 1-d agricultural-use valuation, or if they have not previously received either kind of productivity valua-

"More complete information on special land valuation, tax renditions and exemptions is available from appraisal district personnel as well as in the pamphlet," Mrs. Peddy said.

She said that the "Remedies" pamphlet also contains information about the appraisal review board (ARB) which examines appraisal records and hears appeals to be sure property values in the district are equal and uniform. This section of the pamphlet outlines the steps for making an appeal to the ARB and ways to prepare and present the protest.

"We urge our residents to read the pamphlet and make any applications they need to get all the tax relief to which they are entitled," the chief appraiser said. "Remember, applications must be filed with the appraisal office before May 1."

Mrs. Peddy encourages the taxpayers to obtain any of the above mentioned information from the appraisal district. The office is located at 709 West 7th Street in Spearman, Texas. The office is open Monday through Friday from 8:30 to 5:00 or you may call 659-5576 or 733-5139 and request the information to be mailed.

Homestead Exemptions can reduce the amount of your tax bill

Taxpayers can reduce the burden of property taxes for 1985 in Hansford County Appraisal District if they take advantage of various partial exemptions available on Texas homes.

According to Alice Peddy, chief appraiser for the district, Texas property tax laws now allow a homeowner to apply only once, instead of annually, for residence homestead exemptions.

However, taxpayers who have never received a residence homestead exemption on the homes they were living in on January 1, and those who became 65 years old or disabled during 1984, must apply this year in order to receive exemptions for 1985.

A residence homestead is the structure, together with land up to 20 acres and any improvements like a swimming pool or greenhouse, used as the owner's principal residence. Mrs. Peddy said that, to qualify as a homestead, a property must meet four tests.

It must be owned by the person or persons claiming the exemption; it must be designed or adapted for human residence; it must actually

be used as a residence, and it must be occupied as the principal residence of an owner who qualifies for the exemption.

A mobile home, if it meets the tests, can be claimed as a homestead, even if it is on leased land, Mrs. Peddy noted. She added, "A taxpayer can still qualify for the homestead exemptions if part of his residence is used for other purposes, such as a business in the home. And the home will not lose the exemption if the owner moves away temporarily, provided he intends to return and doesn't claim a homestead anywhere else."

Among the various types of homestead exemptions provided by Texas tax law are two which a school district must give to taxpayers who apply and qualify. School districts offer a \$5,000 general homestead exemption to all homeowners and an additional \$10,000 exemption to those who are 65 years of age or older who are

An advantage of the over-65 school exemption is that, along with it, elderly homeowners obtain a "ceiling" on their school taxes.

Although the appraised value of these homesteads may fluctuate with the market, taxes due the school district will not increase. The ceiling would be raised, however, in the instance of adding an improvement other than repairs and general maintenance. In that case, the value of the new improvement is taxed at current market value and tax rate, and the taxes due are added to the previous tax ceiling to create a new ceiling.

Mrs. Peddy stressed, though, that the elderly homeowner has to apply for the over-65 school tax exemption in order to get the ceiling. The homeowner must be 65 years old or more on January 1, 1985, to qualify for the elderly exemption and tax ceiling.

Counties must offer a \$3,000 general homestead exemption to all taxpayers, given only on the portion of the county tax levied for farm-to-market roads and/or flood

Any taxing unit's governing body may vote to offer an exemption for a mimimum of \$3,000 on the homesteads of disabled and/or elderly residents. Only in school

districts, however, is the ceiling established for taxes on over-65 homesteads.

In addition, taxing units may decide to offer a local-option homestead exemption based on a percentage of a home's appraised value. This year, any taxing unit may exempt up to 30 percent of the value of all homesteads in the unit. No matter what the percentage, the dollar amount exempted on any homestead must be at least \$5,000. The taxing unit's governing body has to take official action to offer this exemption.

Percentage exemptions are granted by City of Spearman at 30 percent; Gruver I.S.D., 30 percent; Spearman I.S.D., 30 percent, Hansford County, 30 percent, North Plains Water District 30 percent, and Palo Duro River Authority 30 percent.

Elderly may file affidavit on delinquent taxes

A taxpayer aged 65 or older may take advantage of a special type of property tax relief--deferred payment of delinquent taxes on his homestead-by filing a sworn affidavit at the Hansford County Appraisal District office.

According to Alice Peddy, chief appraiser of the district, after the 'over-65 tax deferral' affidavit has been properly filed, taxing units may not press or initiate delinquent tax suits on the homestead involved as long as the elderly taxpayer owns and resides at that property.

If a lawsuit has already been initiated to collect delinquent taxes on the homestead, an affidavit asserting age and ownership of the property must be filed with the court in which the suit is pending, Mrs. Peddy said.

Mrs. Peddy said that forms for the deferral are available from the Hansford Appraisal District office. The form should completed and signed by the applicant and his signature witnessed by a notary public or other official authorized to take oaths, she added. The applicant will be required to present proof of age before completing the

For the elderly homeowner considering application for tax deferral, Mrs. Peddy stressed that it allows postponing payment, but that a lien remains on the property for delinquent taxes, penalties and interest. "Those amounts continue to accrue during the deferral period," she said. "Once the applicant no longer qualifies for deferral-that is, if he no longer owns or resides at the homesteadall those accrued amounts become due and payable. Taxing units at that time may sue and foreclose on the accrued delinquencies, penalties and interest."

The over-65 taxpayer may pay, or fail to pay, any taxes due on the homestead without altering the protection of the deferral, Mrs. Peddy said.

Property owners need to be familiar with tax process

AUSTIN -- A statewide effort is underway to inform Texas property owners of their rights, remedies and responsibilities as taxpayers, according to Ron Patterson, executive director of the State Property Tax Board (SPTB).

Patterson says SPTB is working with appraisal districts and local news media to help make taxpayers aware of rendition and exemption filing deadlines and methods to obtain exemptions or other forms of tax relief.

"The first priority for property owners is to file renditions and apply for tax relief before May 1 this year," Patterson said. Taxpayers should file all exemption applications and property rendition forms with the central appraisal district office.

A rendition is a report a property owner makes which lists the taxable property he owned or managed on January 1, 1985. A rendition also gives a taxpayer the opportunity to record his own opinion of his property's value. "By rendering a value for his property, the owner makes the appraisal district responsible for notifying him if the district places a higher value on the property," Patterson pointed out.

Certain property owners must render their property. "Anyone who owns or manages income-producing personal property on January 1 is required by state law to file a rendition statement with the appropriate appraisal district," Patterson said.

Special rendition procedures exist for property on which an exemption applicable on January 1 ends during the tax year. In such a case, the person who owns or acquires the property when the exemption ends must render the property for taxation within 30 days.

The chief appraiser may also require rendition of other taxable property upon notice to the property owner or manager. Rendition forms are available from appraisal district offices.

For homeowners, tax relief is usually in the form of exemptions. "An exemption lowers tax payments by deducting part of a property's value from taxation," Patterson explained. Homestead exemptions are available for all qualified homeowners, and additional exemptions are available for disabled veterans and for those aged 65 or over. Elderly homeowners who apply for the over-65 homestead exemption also get a cap, or ceiling, on taxes they pay to the school district. "Likewise," Patterson con-

tinued, "farmers and ranchers who qualify may have their land taxed on its productive value instead of its market value, which also results in a lower tax bill." Productivity valuation comes in two forms, often referred to by the section of the Texas Constitution that provides them: open-space or "1-d-1" valuation and agricultural or "1-d" valuation.

Property owners who last year received homestead exemptions, disabled veterans' exemptions and open-space land (1-d-1) valuation need not reapply in 1985, unless the chief appraiser requests a new application to confirm the owner's current qualification.

Applications must be filed in 1985, Patterson said, by property owners who have not previously received tax relief on their present homesteads or land.

State law also requires farmers and ranchers to apply each year in all appraisal districts for agricultural use (1-d) valuation.

Patterson noted that people whose property is in more than one county appraisal district have an additional responsibility. These property owners may have to file for exemptions and productivity valuation in each appraisal district in which their property is located. Failure to do so could result in one or more taxing units taxing the property on its full market value.

An example is where a city or school district in two counties has joined only one appraisal district. Complete information on tax

exemptions and rendition requirements is in a pamphlet produced by SPTB. "Taxpayers' Rights, Remedies, Responsibilities!" also tells how a taxpayer can challenge the value placed on his property by making an appeal to the appraisal review board. The pamphlet is available free from appraisal district offices or from SPTB in Austin.

"The property tax is the primary source of local government revenue in Texas," Patterson said. "It will generate about \$9 billion this year to help fund public schools, cities. counties and special districts like hospitals, local colleges, fire protection, water and utilities."

"We urge all property owners to become familiar with the tax process, to file renditions and to apply for all exemptions or other tax relief to which they are entitled," Patterson concluded.




