

## All with wry sense of humor . . . **Dunaway -- he builds from scratch**

The only things that George Burns has over Spearman's Ronald Dunaway is age, personality, good looks and a bank account, but what the Spearman resident lacks in the above he more than atones for with a God-given talent for southern engineering and an off-the-wall sense of humor which keeps any company he might have constantly on their guard.

His humor comes naturally and Dunaway possesses a wit which is capable of jabbing one-liners at a more than proficient pace.

His capabilities in southern engineering are borne more out of a desire to build things so he can test his talents and enjoy the finished product rather than out of necessity.

He builds his own power tools, both for his woodworking hobby and his business -- has built the home he lives in from scratch, his business shop from scratch and

claims, when he isn't doing something else, that he just scratches.

The 47-year old mechanic and Spearman businessman can be found doing a variety of chores almost any time of the day, but a good deal of what he accomplishes, he does for family and friends -simply because he wants to.

"I've got a bunch of junk I use to make things for me and my friends," he quips. "But what I really like to do is cook."

Born and raised at Alvord near Dallas, Dunaway came to Spearman in 1960. During that time here he has built a steady business, married a pretty gal named Betty and raised five children, the two youngest still in the home.

The witty jack-of-all-trades notes that his desire to build everything for himself comes mostly from intrigue.

"I just love to work on things," he explains. "I guess I'm always

trying to build a better mousetrap.

That desire has resulted in a number of things -- both large and small -- for his family, friends and business.

His father is a retired carpenter and cabinet maker and Dunaway reports that he really didn't learn near as much as he should have when he was at home.

"When I was building my house, every so often I'd have to stop what I was doing and call Dad to see how to proceed from where I was," he remembers with a laugh. "It got to the point that the cost of the house and the long distance calls pretty well evened out."

He went on to say that his father's favorite expressions were . . . according to Hoyle' and "Rule of thumb"

"What Dad didn't understand was that Hoyle never had anything at all to do with this house," he declares. "And I beat both thumbs off the first day."

The 2,000 square foot house was built over a 21/2 year period of evenings, holidays and weekends.

And, the home is built to Ron Dunaway standards such as ceiling joists made of one by 12's, lumber which is bolted, not nailed, together, hand made moulding throughout the 2-story structure and various other items which carry his special touch.

The home has five bedrooms, three full baths, a country kitchen, a 6x6 walkin pantry and an upstairs master bedroom which features French doors which open onto a balcony.

"I made it for Moma Pud," he says, using his affectionate term for his wife, Betty. "Actually, the only thing that was important to her was the kitchen. And she wanted the stove right in the middle of the floor."

## **Through first 6-months operation... Financial picture strong at HCHD**

The month of March showed a decline over previous months, but Hansford Hospital District board members were informed at their regular meeting that the district is still in better shape than anticipated through the first six months of the 1987-88 fiscal year.

The meeting was held Thursday in the board room of the hospital. Administrator Al La Rochelle informed the board that the district has \$160,000 less in losses than during the same period a year ago.

Most of the savings has come from better utilitzation at both the hospital and the manor nursing

home, along with higher census in both, La Rochelle told the board. The savings translates from \$68,000 in the hospital, \$77,000 in the manor and \$15,000 at clinics owned and operated by the district. "My goal at this point is to have money left over at the end of the year," notes the administrator. "Our losses would have to exceed budget by over \$107,000 a month

each of the remaining six months for that not to happen.' The district had budgeted losses of \$282,946 in the hospital, \$70,075 in the manor and \$1,872 in the clinics.

Currently, the Hansford hospital district has an operating fund balance of \$647,797.

The hospital and manor continue to show a steady improvement on gains before contractuals such as medicare and medicaid, along with depreciation, are subtracted from the totals.

The hospital shows that it has made \$84,154.66 through the first six months, compared to a loss of \$29,267.29 for the same period a year ago.

Once the contractuals and depreciation are taken out, however, the figures show an operation loss of \$200,609.93 for the year to date as compared to a loss of \$268,745.

the Manor may seem meager at \$306.31 for the first six months. But that compares to a loss of \$74,083.15 for the same period last year, translating into significant savings, points out La Rochelle.

"Financially, we are in a fairly sound condition," he told the board. "If our census continues to remain up, we'll be in good shape at the end of the year.'

La Rochelle pointed out that part of the reason for the decrease in the March census was due to the fact that doctors took vacation trips during the month.

In other action at the Thursday meetng, Jack Oakes was re-elected as president of the board with

Gruver Greyhound basketball mentor Royce Blackshear has been hired to the head boys cager job at Perryton high school for the 1988-89 school year.

Blackshear, who also teaches drafting, has been coaching at Gruver five years, and tallied a 63-62 record during that time for the varsity boys' team. As coach of the girls team in 1986-88, his record was 27-24.


The board also adopted a smoking area policey for the hospital which designates certain areas as smoking and non-smoking areas.
