WIFE Sends Empty Bread Sacks To President Carter

WIFE had their regular meeting Tuesday, and came up with some interesting discussions. The women were concerned mainly about farm prices, such as, support prices, parity figures, target prices, and loan prices. They discovered that their major concern should be for loan prices, instead of target prices.

One of the ladies stated that she and her husband had sat down and figured their returns from 76 crops and their projected profits for the year to come. They lost, on the average, of \$40.52 per acre of farming wheat. Corn fared a little better by producing a profit of \$7.84 per acre and they showed a better profit in milo with \$15.86 per acre. If they had raised mostly milo and corn they would have done alright but about 63% of their crops were wheat. Their losses were heavy. The farmer's wife asked that their name not be printed, but these are actual figures. Figures such as these may vary from one farm to the next, but they are all showing bad projections on their returns from growing wheat. It was stated that it takes one bushel of wheat to produce six loaves of bread. There is not quite 4 cents worth of wheat in a loaf of bread, and also, the price of wheat is less than half of what it was three years ago. The price of bread has not gone down any.

The ladies decided to do something to draw President Carter's attention to this. They have gathered a small mountain of empty bread sacks, which will be sent to the President. A note accompanying the bread sacks will state that if something isn't done to improve farm

price returns, no guarantee can be made that wheat will be furnished for the bread to fill future sacks. In one of the reports from other ladies, it was said that farm prices had already gone up, but some concern was shown for the fact that the farmer couldn't see any rise in his return. After several long distance telephone calls, it was found out that the prices of coffee, tea, and cocoa were figured in with the farm prices. It doesn't take a man with a college degree in agriculture, to figure out how much coffee, tea, and cocoa are grown in this country. The ladies felt that it might be a little bit unfair to count these items in when figuring domestic farm prices.

The ladies of WIFE discussed the possibility of making a trip to Washington D.C. in the near future, hopefully before May 15th. They would like to see some of the Congressmen before they vote on the over-all Farm Bill. It was announced that they will have a special called meeting on May 5th. A special guest speaker will be there, Bill Nelson who is an Executive Vice-President of the Texas Wheat Producer's Association. The time and place of that meeting have not been announced, but the ladies urge all the men to watch for it, and attend. Mr. Nelson will be speaking on the Wheat producing situation in Texas. WIFE will still hold their regular meeting, Tuesday night, May 3, at 8:00 p.m.

Meeting Set For Beef Producers

A county wide meeting about the proposed Beef Research and Information Act has been called for 1:00 p.m. April 25, 1977 in the Spearman County Show Barn in Spearman by Mike Garnett, chairman of the Hansford County Beef Development Task Force. Details about the upcoming beef referendum will be explained. The educational program, which is designed for all beef and dairy cattle owners of the county, will include two slide presentations about the Beef Research and Information Act—one prepared by the Texas Agriculture Extension

Service—and the second by the Beef Development Task Force. There will be a period for questions and comments from producers. Additionally, the BDT chairman, County Extension Agent and Extension Area Economist—Management specialist Dr. Ramon W. Sammons, will provide more detailed information about the forthcoming beef referendum. Win First District Meet

The Lynx varsity track team won the first District Track Meet that anyone can remember. Tuesday and Wednesday, The Hansford Plainsman would like to express its gratitude to School System Superintendent, James Cunningham, for his assistance in furnishing information for this report. Coach Sherwood was not available, but Cunningham commented that the Spearman Track Teams did a tremendous job and that he was very proud of each boy. Spearman emerged from the Field Events, Tuesday afternoon, the leader in a field of six District Participants, with 43 points over Boys Ranch's 40, Dalhart's 38, Panhandle's 16, River Road's 13, and Canadian's 4½. John Holman set a new Pole Vault record, 14 feet, 2¼ inches, vaulting over his old record of 13 feet, six inches. John Holman, Jim Jones, and Chris Trout finished one-two-three in the Pole Vault Event, with Jim Jones besting his personal record (13 feet even) with a 13 feet, one inch vault. Scot Martin, Jim Jones, and Zane Newton finished one-two-three in the 330 Yard Intermediate Hurdles. The 440 Relay Team, Sellers, Reneau, Morris, and Sherwood took a first in that event. Morris had a second in the 100 Yard Dash and Snider earned a third place finish in 440 Yard Dash. Friemel captured two thirds, one in the High Jump and one in the Long Jump. Bo DeArmand tied for third in the Shot put, and also took third in the Discus Throw. Honorable mention should also go to Varsity Trackers, McCallum, Sherwood, and the Varsity Mile Relay Team. Total Team Points placed Spearman first with 124. Boys Ranch second with 123½. Dalhart third with 113. Panhandle fourth with 62. Canadian fifth with 40½, and River Road sixth with 25.

In the Freshmen Division, special mention goes to the relay teams, the 440 and the mile, and to Freshmen Reid, Bodey, Francis, and Comegys. The 8th Graders finished fourth in their division. David West won the 880 Yard Run. The Spearman Relay teams took fourth in the 440 Relay and the 880 Relay. Swann was fourth in the Lone Jump, Lozano was fourth in a new event, the 1320 Yard Run, and Pierce took fifth in the Long Jump. The Spearman 7th Graders were not going to be outdone by their Varsity Peers and, indeed, they were not. The 7th Graders took 8th place finishes out of 14 events. Sherwood, George, Tindell, and Rigdon won the 440

Relay, and the 880 Relay team earned 2 second place finish. Stan Sherwood earned three other firsts, in the High Jump, in the 60 Yard Intermediate Hurdles, and in the 100 Yard Low Hurdles. Stan surpassed the 11 feet 1 inch District record in the High Jump, and set a new record of 5 feet, 2 inches in the preliminaries of the 60 Yard Intermediate Hurdles, 8.6 seconds. Chuck Rigdon, the younger, took other firsts in the 100 Yard Dash, and the 220 Yard Dash, setting a new record in the preliminaries of the latter, 25.8 seconds. Stan Sherwood also had a second place finish in the Long Jump, with the ever present Chuck Rigdon, right behind him with a third in the Long Jump. Seventh Grader George earned two more spots, with seconds in the 60 Yard Intermediate Hurdles. Brack and Sheppard had thirds in the 60 Yard Intermediate Hurdles and the 100 Yard Dash respectively. Espinosa, Scrogens, Brack, and Alford turned in respective fourth place efforts in the Discus, 7th Graders, 100 Yard Dash, and the 1320 Yard Run. Recognition should also go to 7th Graders, Sellers, Reneau, Morris, and Sherwood.

The Hansford Plainsman would like to congratulate each and every individual that took place in the District Meet, and especially congratulate the Spearman participants; those that won and those that lost. As everyone should know, participation is the major importance in competition. The boy that tried his best and as good as lost, should feel just as satisfied as the one that finished first. Air and ground searchers worked through Thursday night until daylight Friday morning enabled them to spot the wreckage, about three-quarters of a mile north of FM 2018. Hansford County Sheriff R. L. McFarlin said Friday he wanted to thank all who helped in the air and ground search effort in the cold and wet weather.

The body of a Woodward, Oklahoma, resident and the wreckage of his private plane were located at 7:27 a.m. Friday, April 22, on the E. T. Rafferty farm southwest of Gruver by Hansford County Sheriff R. L. McFarlin and other members of the air and ground search party which had participated in the all-night search which had been hampered by the rainy and cold weather in the area. He was the only one aboard the craft. The crash victim was Carl Stricker, 49, of Woodward. His mangled body was found in the wreckage of his white and red trimmed, single-engine Piper Arrow which hit the ground approximately four miles south and three miles west of Gruver. There was no fire. It was surmised that Stricker was attempting to reach the airport at Gruver when he crashed between 8 and 9 p.m. Friday. The impact dug a large hole in the cultivated field, a very muddy field of milo.

According to preliminary information, Stricker was on a flight from Lamar, Colorado, at the time. His destination was not known Friday. Sheriff McFarlin reported that Stricker apparently was a cattle buyer, based on identification and other items found in the plane wreckage. The ground and air search was mounted between 8:30 and 9 P.M. Thursday after the Sheriff's Department had been alerted to the possibility of a plane having crashed in the county. From indications at the scene, Stricker fell into the ground while on a northeast-easterly course. Some 75 to 100 members of the sheriff's Departments, the Gruver and Spearman Police and Fire Departments, the Sherman and Hutchinson Counties Sheriff's Departments and other volunteers took part in the search, joined by a Civil Air Patrol member from Canyon. During the night the Rev. O. Abbott of Spearman and Paul Westerfield flew short mis-

sions but had to terminate their efforts because of the bad weather. Early Friday morning, based on information from CAP equipment in Amarillo which pinpointed the locale of the crash, Bobby Thompson of Gruver and Major Pete Minden of Canyon took to the air, and, with daylight, the wreckage and its victim were located. About 4:30 a.m., the CAP had pinpointed the crash location. McFarlin noted that Alton Ellsworth took a gasoline truck to the area for refueling the ground vehicles used in the search. Federal investigators Friday were expected to begin an investigation of circumstances of the fatal crash. Stricker's survivors include his widow of Woodward. Funeral arrangements are under direction of Bowtell Brother Funeral Directors in Spearman. Services are pending at his home in Woodward.

Medicare Coverage Information

Confusion at times exists for a beneficiary-patient concerning benefits provideable through Medicare hospital and medical insurance coverage when, all of a sudden, the beneficiary with only full Medicare coverage receives notification that services then payable under Medicare A and B coverages are disallowed after a determination by a utilization review of \$104 under the 1976 rate schedule representing the balance with the rest of the covered and the provider.
A basic explanation is to note that Medicare A and B benefits are payable depending on the number of patient-days authorized the beneficiary-patient, Hansford Hospital Administrator Jerry Taylor points out, and if the patient-beneficiary has complied with requirements for participation and a waiver of liability is in force that applies to the hospital.
Authorization or certification of patient-days for a beneficiary-patient is based on information supplied by the authorized providers of such services in accordance with Medicare criteria.
Taylor provided information about Medicare procedures required of providers and accredited facilities - and beneficiary-patients from admission to a hospital or as an outpatient to that point in time where a decision is reached by authorization review committee that services to a beneficiary-patient are non-payable under Medicare.
There is some confusion over benefit period and free days during which Medicare hospitalization insurance assists in paying for up to 150 authorized days of in-patient care or of authorized coverage under the Part B medical insurance coverage.
According to Medicare information, a benefit period

admission that care will not be covered or the review committee notifies the patient in writing some time during his or her inpatient stay that covered care has ceased or will cease at some point in time and the patient stays beyond a 72-hour grace period.
Timeliness in providing the hospital service with patient reviews is a necessity in maintaining a waiver of liability status.
In the denial of a claim, both the provider and the beneficiary-patient have the right to request a reconsideration of the intermediary decision - the intermediary being the insurance carrier - through a formal appeals process.
Requests must be made within six months from date of denial letter.

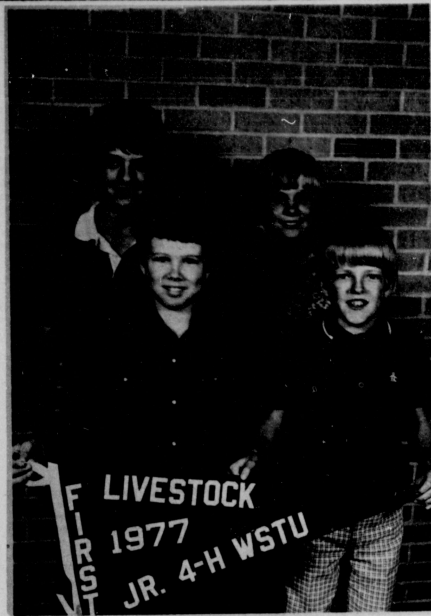

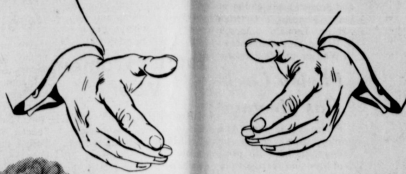

Installment Debt Locally \$4,830,000

How much does the average family in Hansford County owe at the present time in the form of installment debt? How much of its spending for big-ticket goods and services is on the buy-now, pay-later plan?

Locally and in other parts of the country there has been a steady increase in recent months in the use of installment credit. And, paradoxically, the increase was food news for the economy.

What it means is that consumers are finally loosening up somewhat on their pur strings, after a long period of restrained buying. They are purchasing the cars, dish washers, furniture, hi-fi equipment and other costly items that they have long been wanting.

The net result, nationally, is that installment debt came to nearly \$179 billion at the beginning of the year, up a record 10.2 per cent from a year earlier. Automobiles were the major booster.

In Hansford County, based upon the latest local income and spending figures and upon national studies by the Federal Reserve Board, the amount of installment debt outstanding is estimated at \$2,300 per family.

That is the average in the area. Some families owe much more than that and some owe little or nothing.

For the local population as a whole, the debt load amounts to approximately \$4,830,000, the figures indicate.

The largest part of it consists of loans for automobile purchases. The remainder is for other installment buying, for personal loans and loans for home repair and modernization. Not included in this category are mortgage debt, charge accounts and single payment loans.

To meet their regular repayments on their installment debt, including interest charges, takes close to 15 per cent of the net income of Hansford County residents, or about \$190 per month per family.

As for the ability of the average family to meet its obligations, credit experts have no misgivings. They believe that most people have been careful and have not over-extended themselves.

The hearing will be held in the Stephen F. Austin Building (17th and North Congress) at 10:30 A.M. in Room 1046. The purpose of the meeting is to determine if the Texas Corn Producers Association is representative of the growers in 18 counties and will be capable of holding a referendum. Any person wishing to testify may do so at the hearing, Commissioner Brown stated.

Included among the 18 counties in the proposed referendum are Bailey, Briscoe, Castro, Deaf Smith, Floyd, Hale, Lamb, Parmer, Randall, Swisher, Dallam, Hansford, Hartley, Morse, Ochiltree, Sherman, Carson, and Hutchinson.

The Texas Department of Agriculture administers the Texas Commodity Referendum Act, under which farmers can organize and assess themselves for funds used for education, research, market development, and promotion of an agriculture commodity. Currently there are eight organizations functioning under the referendum regulations.

referendum among beef producers to determine whether they want a beef development plan, developed by an industry-wide committee.

The beef development plan is proposed national checkoff program that would be financed by assessment as spelled out in the beef marketing order. If approved, the plan would provide some \$30 to \$40 million per year for beef research, consumer and producer information, promotion and market development.

Expenditures, he added, would be directed by a 68-member board of cattle-men and representatives of livestock organizations.

To be eligible to participate in the beef referendum, beef and dairy cattle owners need to make two trips to their county Agricultural Stabilization and Conservation offices: the first trip to register, and the second to vote.

Mental Retardation is the largest permanent handicapping condition that affects children? Mental Retardation affects 1 out of every 10 persons. Soil Survey Is Available

How builders can avoid the problems of flooding homes is one of the principles covered in a slide talk available from the Soil Conservation Service, according to Warren Proctor, local district conservationist.

"This presentation, Soil Basics for Builders, informs people of some of the hazards of construction caused by soil conditions," Proctor said. "In addition to flooding soils, the 12-minute presentation covers septic tank soil selection, shrinking and swelling soils, corrosive soils, and sliding soils.

Most of these problems are present in the Spearman and Gruver area. "According to our Soil Conservation Service soil scientists, the location of these conditions can be identified and mapped. Building plans can be adjusted to avoid flooding, cracking houses, underground damage by corrosion, and other soil related difficulties."

"The use of soil survey information to avoid building problems is not experimental," Proctor said. "In some areas, millions of dollars in public and private money have been saved by simply avoiding known problems or by making the adjustments necessary in construction details."

A comprehensive soil survey is available for (Hansford County), according to Proctor local D.C. "Where further field work is needed, we can give basic information on soil conditions on request," Proctor said.

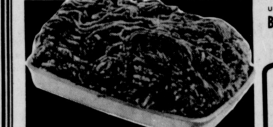
