Negro Kills White Man In Big Springs.

Just after midnight on Wednesday a week ago, while helping the Marshall of Big Springs in raiding a negro dive, Jim Burk was shot and instantly killed. Three negroes have been arrested, whose names are as follow: Ed Hardgraves, Will Manning and Albert Smith.

Jim Burk, the white man who was killed, was 36 years old, unmarried, had been living in Big Springs several months and was employed as time keeper for the railroad grading outfit there. He had an uncle living in Big Springs and a brother at Dennison, where he was buried.

Some talked of lynching the negroes, but as a speedy trial was promised it was decided to let the law take its course.

As a result of this tragedy a mass meeting of the citizens was held Thursday and all negroes were ordered to leave Big Springs at once.

Capt. Johnson and four Rangers were sent from Colorado City to Big Springs Thursday afternoon, but finding every thing quiet they returned to Colorado again.

In the prohibition election held in Tarrant county April 27 the vote stood in the county 6,107 anti 3,214 pro. In the city of Fort Worth the vote stood 3,754 anti 798 pro. Majority against prohibition 2,993.

C. F. Ramsey has bought a 35 horse power traction engine and a 4 disc 7 gang plow, and will at once proceed to break a section of land on his farm east of Lockney on which he will plant Kaffir and June corn.

Charley says they are getting from 7 to 14 pigs a day and that they have to "make a noise like" a big feed crop.

This is a great thing for our community and will greatly assist in farm development. In a good day's run they can break 30 or 40 acres, and they expect to break as cheap as they can, so our farmers may depend on good results.—Lockney Beacon.

Changes Made In Quarantine.

Owing to the spread of Texas fever among Southern and Western cattle the Agricultural Department at Washington has adopted new regulations governing the shipment of cattle. The statement of the department made public last Tuesday with the regulations set forth that the Texas fever prevails among the cattle of California, Oklahoma, Indian Territory, Texas, Arkansas, Louisiana, Mississippi, Tennessee, Alabama, Virginia, North Carolina, South Carolina, Georgia and Florida, which states are quarantined with certain excepted areas. Under the new regulations the general area is to be limited by a new line. The exceptions for Texas shipments are stated as follows:

During the continuance of the quarantine no cattle of the modified quarantine area of any state or territory other than Texas shall be moved or allowed to move into the counties of Baylor and Throckmorton.

No cattle of the counties of Childress, Cottle, Hardeman, Ford, Wilbarger, King, Knox, Haskell, Stonewall, Jones, Fisher, Scurry, Borden, Howard, Mitchell, Glasscock, Sterling, Iron, Reagan, Upton, Crane, Throckmorton, Baylor and those portion of Pecos, Tarrant and Tom Green counties lying north and west of the quarantine line, shall be moved or allowed to move except as provided for immediate slaughter to any point in the United States, not in the state of Texas, which is located outside of the modified quarantine area, until they have been inspected and a written permit for the shipment issued by an inspector of the Bureau of Animal Industry.—Western Light.

The Negroes Leave Town

With the exception of one or two negroes who remained to sell their property, and the three in jail, the negro population boarded the east bound passenger train yesterday evening bound for other parts of the state. It is now a settled fact that from now on no negroes will be welcomed in Big Springs and their room is more desired than their company. While it is regretted that a few good negroes were compelled to be treated in this harsh manner the majority of the citizen are glad that this city is free from the dark peril.—Big Springs Herald.

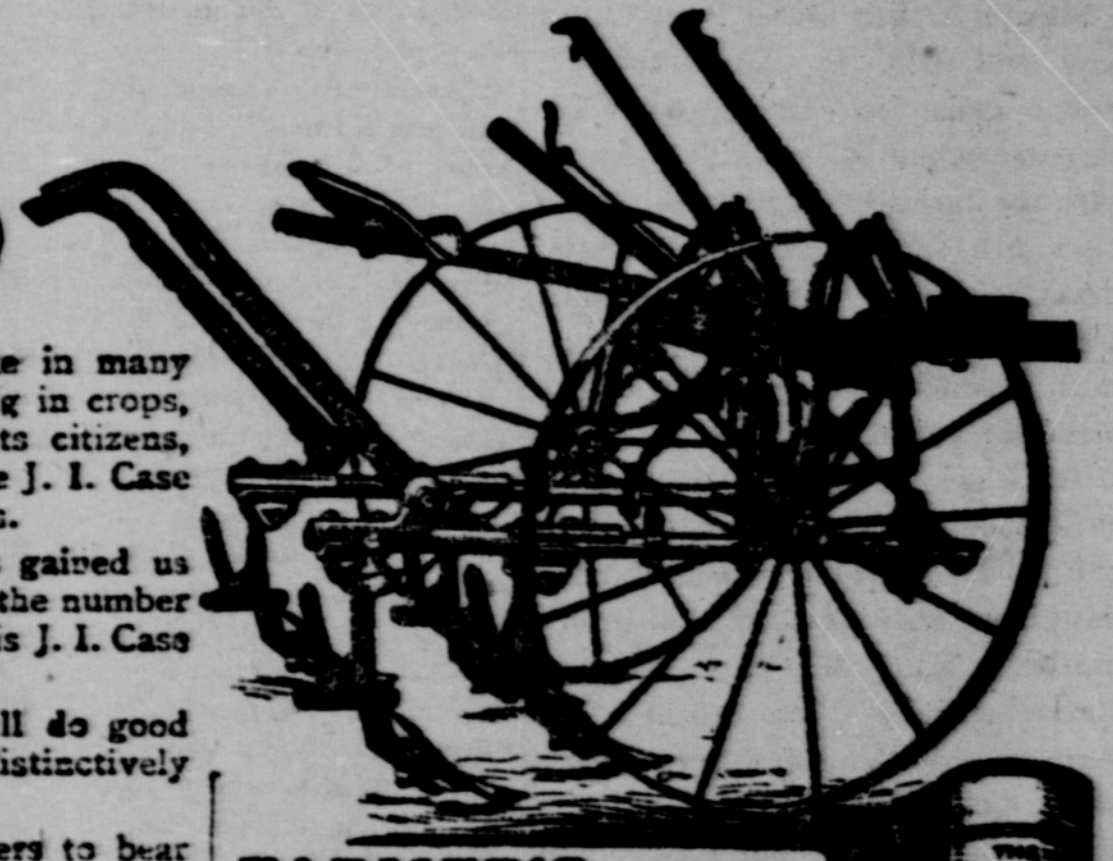
