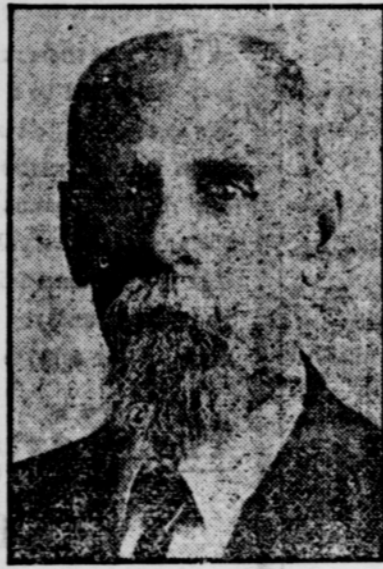

CO-OPERATE IN EFFORT TO IMPROVE METHODS OF MARKETING THE TEXAS FARM PRODUCTS

Mr. Peter Radford, President of the Farmers' Union, and Mr. B. B. Cain, President of the Texas Commercial Secretaries and Business Men's Association, the Official Heads of two Organizations That Are Co-operating in an Effort to Improve Methods of Marketing Farm Products.

The Texas Welfare Commission, at its last session in San Antonio, adopted a resolution approving the Farmer's Union plan of marketing cotton and calling upon the financial interests of the state to supplement the work of the Union in obtaining six per cent money to finance distress cotton, and asked President Cain, representing the business interests, to lend assistance to Mr. Radford, representing the agricultural interests, in giving more complete effect to the plan.

It is reliably estimated that with sufficient revenue behind it, the plan to loan money to farmers who are financially unable to hold their cotton, will result in a more stable market and will add at least ten dollars a bale to the price of cotton.

BACK IN INDIAN DAYS

S. F. Singleton Recalls Braid of Almost Forty Years Ago

Speaking of the country around Tahok, Texas, now, as compared with 40 years ago, reminds S. F. Singleton of that place that he had been there a good while. When he located in that country it was 150 miles to the railroad, and the Indians were pretty numerous.

"I it was in 1873," said Mr.ingleton, "that General McKenzie made a killing among the red skins there, and cleaned them up in such a way that they never came back again. As I recall it he drove them clear out and not only killed a good many of them, but took from them about 600 horses.

"Today we have a country under fence and have railroads, and farms, instead of corrals for the cattle and the big open range with no settlers. For a good many years we had to drive our cattle 150 miles to a shipping point. Then we had a road nearer, perhaps half that distance away, and still more recently we have had a road built close so that we have every convenience now in handling stock."—Kansas City Drovers Telegram.

FAVORS HOLDING OF COTTON ON FARMERS' UNION PLAN

San Antonio, June 17—Mr. W. T. Loudermilk, chairman of the sub-committee on cotton marketing of the Texas Welfare Commission, made his report to the Commission in session in this city last week, favoring the holding plan adopted by the Farmers' Union, and suggested that funds be provided for lending money at six per cent on distress cotton, and recommended that the business interest cooperate with the farmer in securing better prices for their products. The plan has been tried out by the Farmers' Union, and its efficiency in regulating prices demonstrated, and with more complete co-operation on the part of the business interests can be made a powerful factor in price making.

Mr. Loudermilk is a practical farmer, ex-president of the Farmers' Union and one of the closest students of agricultural conditions in the South.

HOWARD COUNTY.

BIG SPRINGS HERALD.

H. S. Miller this week received a machine for heading wheat and oats and will start cutting his wheat crop today. He has about 60 or 70 acres of wheat he will harvest with his new machine.

A carload of machinery consisting of road roller, drag and wheel scrapers, water wagons, etc., arrived in the city Thursday. This is a part of the machinery which will be used when the good road work, for which \$100,000 in bonds was issued, begins about August 1.

POTTER COUNTY.

AMARILLO DAILY NEWS:

D. R. Campbell versus W. M. Burwell et al, is a suit filed in the district court in Amarillo, which is destined to create more than passing notoriety. This petitioner alleges that Sheriff Burwell has seized a large amount of intoxicating liquors from plaintiff's premises, the said liquors being worth in the aggregate \$1,490. It is further alleged by the plaintiff that his reputation and good name have been injured by the seizure of the liquors, in the sum of \$5,000.

The petitioner says that after the seizure, Sheriff Burwell displayed the liquors so seized in the county court house in such a prominent way that attention of the citizens has been called to it, and it has thus been coupled with the name of the plaintiff so that he has been injured irreparably and in the amount mentioned in the petition aforesaid.

Not only the sheriff of Potter county is sued in connection with this seizure, but his bondsmen: J. W. Crudginton, B. T. Ware, J. W. Hill, F. S. Franklin and Charles Dammier, as well.

The petition sets up the list of liquors seized, as to kinds and grades, together with value in piece and as a whole. It is probable that this case will come up for hearing at the incoming term of the district court.
