

# Proposed Amendment to the State Constitution Authorizing the Levy of a Tax to Pay Jurors.

IOINT RESOLUTION amending Section 9, of Article 8, of the Constituton of the JOINT RESOLUTION to amend Section State of Texas, providing for the levying of a tax of not exceeding fifteen cents 2 of Article VIII of the Constitution of on the one hundred dollars valuation, to pay jurors.

SECTION 1. Be it resolved by the Legislature of the State of Texas: That Section 9, of Article 8, of the Constitution of the State of Texas, be so amended as to hereafter read as follows:

SECTION 9. The State tax on property, exclusive of the tax necessary to pay the public debt, and of the taxes provided for the benefit of the public free schools, shall never exceed thirty-five cents on the one hundred dollars valuation; and no county, city of town shall levy more than twenty-five cents for city or county purposes, and not exceeding fifteen cents for road and bridges, and not exceeding fifteen cents to pay jurors, on the one hundred dollars valuation, except for the payment of debts incurred prior to the adoption of the amendment September 25th, 1883, and for the erection of public buildings, streets, sewers, water works and other permanent improvements, not to exceed twenty-five cents on the one hundred dollars valuation, in any one year, and except as in this Constitution otherwise provided; and the Legislature may also authorize an additional annual ad valorem tax to be levied and collected for the further maintenance of the public roads; provided that a majority of the qualified property tax-paying voters of the county

voting at an election to be held for that purpose shall vote such tax, not

to exceed fifteen cents on the one hundred dollars valuation of the prop-

erty subject to taxation in such county. And the Legislature may pass

local laws for the maintenence of the public roads and highways, with-

out the local notice required for special or local laws, SEC. 2. The Governor is hereby directed to issue the necessary proclamation for submitting this amendment to the Constitution to the qualified voters of the State of Texas, on the first Tuesday after the first Monday in November, 1906, at which election all voters favoring this amendment shall have written or printed on their ballots, "For the amendment to authorize the levy of a tax to pay jurors." The voters opposed to this amendment shall have written or printed on their ballots, "Against the amendment to authorize the levy of a tax to pay jurors."

HOUSE JOINT RESOLUTION authorizing the submission to a vote of the people of the State of Texas of a proposed amendment of Section 24. Article 3, of the Constitution of the State of Texas, fixing the salaries and mileage of members of the Legislature, and preventing the acceptance, for themselves or for others, by members of the Legislature of free passes, franks, rebates, privileges or ad- void. vantages from certain persons and corporations.

SECTION 1. Be it resolved by the Legislature of the State of Texas: That at the next general election of the State of Texas, or at any previous election, in case an election for the State shall be had or ordered clamation for the submission of by the Governor for other purposes, there shall be submitted to the elec- this amendment to the qualified votors of the State of Texas, for their approval or disapproval, the follow- ters of the State of Texas at the ing amendment to the Constitution of the State of Texas, as provided next general election for State and for in Section 1. Article 17 of said Constitution, relating to proposed County officers. amendments thereto, it being intended to amend Section 24. Article 3, of said Constitution, relating to the pay of members of the Legislature,

so that the said Section shall read as follows: SEC. 24. The members of the Legislature shall receive from the public treasury such compensation for their services as may from time to time be provided by law, not exceeding one thousand dollars for the year succeeding their election, payable in equal installments, on the first days of January, February, March and April of the year succeeding their election, and five dollars per day for each day of every special session held during the second year of the term for which said members shall be elected. In addition to said compensation the members of each house shall be entitled to mileage going to and returning from the seat of government, which mileage shall not exceed three cents per mile, the distance to be computed by the nearest and most direct route of travel by land, regardless of railways or water routes; and the Comptroller of the State shall prepare and preserve a table of distances to each county seat, now or hereafter to be established, and by said table the mileage of each member shall be paid; but no member shall be entitled to for any extra session that may be called within one day after the adjournment of any regular or called session. It shall be unlawful for any member of the Legislature during his term of office to accept any free transportation over any railway line or lines in this State, and any member of the Legislature violating the provisions of this Act prohibiting the acceptance of free transportation shall forfeit the office to which he has been elected. And it shall be unlawful for any of such members to accept, recieve, have, use or enjoy, directly or indirectly, for themselves or any other person, any free pass, frank, rebate, privilege or ad vantage not accorded the general public from any railroad company, telegraph company, telephone company, sleeping car company, or other corporation, or any persons firm or corporation acting as a common carrier in this State. Any member of the Legislature violating this provision shall forfeit his office. And the necessary laws shall be enacted to carry out the provisions of this Article.

# Proposed Amendment to the THELYNNCOUNTYBANK State Constitution Relating to Certain Exemptions from Taxation.

the State of Texas, relating to certain exemptions from taxation.

Be it resolved by the Legislature of the State of Texas:

SECTION 1, That Section 2 of Article VIII, of the Constitution of the State of Texas, be so amended that the same shall read as follows, to wit:

"All occupation taxes shall be equal and uniform upon the same class of subjects within the limits of the authority levying the tax; but the Legislature may, by general laws, exempt from taxation public property used for public purposes; actual places of religious worship; places of burial not held for private or corporate profit; all buildings used exclusively and owned by persons or associations of persons for school purposes and the necessary furniture of all schools, also the endowment funds of such institutions of learning and religion not used with a view to profit and when the same are invested in bonds or mortgages, or in land or other property which has been and shall hereafter be bought in by such institutions under foreclosure sales made to satisfy or protect such bonds or mortgages; that such exemption of such land and propyears after the purchase of the same at such sale by such institutions and no longer, and institutions of purely public charity; and all laws exempting property from taxation other than the property above mentioned shall be null and

SECTION 2. The Governor of the State shall and he is hereby directed to issue the necessary pro-

SECTION 3. The qualified electors for members of the Legislature of the State of Texas shall vote upon this amendment on the - day of ----, at which election all persons favoring said amendment shall have written or printed on the ballot as follows: "For amendment to section 2, Article 8 of the Constitution exempting from taxation endowment funds used exclusively for school purposes." And those opposed to said amendment shall have written or printed on the ballot as follows: "Against amendment to Section 2, Article 8, of the Constitution exempting from taxation endowment funds used exclusively for school purposes."

SECTION 4. The sum of \$5,ooo or so much thereof as may be necessary is hereby appropriated out of any funds in the treasury of the State of Texas, not otherwise appropriated to pay the expenses of such publication, proclamation, and election.

# Cyclone and Hail Storm.

On Monday of last week a destructive hail and cyclone occurred in the north part of Howard county and destroyed the D. W. Christtian house located 11 miles from town and occupied by W. E. Hale, whose new wagon was so badly wrecked by the storm that only one hub could be found. The family took refuge in the stormhouse, but the door of it was blown away, in spite of three men holding it down with a rope. The family escaped unhurt but lost their household goods. All outhouses were destroyed.

The cyclone was followed by a hail and rainstorm, which broke through shingle roofs and destroyed crops over an area of about 30 square miles and lasted over an hour. The rain was general over the entire county and was of much benefit to growing crops.—Big Springs Herald report condensed.
