Dick Lee and family came thru last week on their way to New Mexico to take up land. Mrs. Roberts of this place went with them to see if New Mexico had anything to offer her.


Sunday September 2nd will be Missionary Day for the Methodist Sunday School. The Home Mission Society will have a varied program at eleven o'clock.
