Good Advice.

In a newly settled country, where towns spring up suddenly and take on a rapid growth, there is usually a marked disregard of sanitations and the various methods of protections of the public behalf. In this respect Tahoka is no exception to the rule. As it usually requires a wide spread and destructiv fire to cause a town to seek means of proper fire protection, so a deadly epidemic is often uecessary to make people realize that their town is not as ciean as it might be. Such a state of affairs should not be permitted to exist. This town could be put in a reasonable fair sanitary condition at less expense and trouble than that connected in the County of Lynn at the court house two protracted cases typhoid fever, a death.

It is often asked how typhoid fever comes about when there are no other cases in the neighborhood and the drinking water is apparently pure. Although it may be a very puzzling question, and impossible to answer in many cases, still there is nothing mysterious about it. Verily, it doth seem that Comanche is the only county in Texas with an unoccupied prison, - Comanche Chief. Comanche has no salcons, and the jail is the only empty house it has. The business of the jailer is the only business hurt by the closing of the saloon.-Bonham News.

We admire the spirit of the Commanche Chief in telling to the world what a moral town they nave. We arise to say that Lynn county is six years old and has no! iail. A small room in the court house was fitted with bars to the windows for the accomodation of an unfortunate man who was insane and had to be detained here for a few days. During the six years this strong room has been occupied by three prisoners, two of whom were detained about a week awaining trial. The other mizoner occupied the jail room two hours for the crime of swiping a quilt on a cold day. These prisogers were all non-residents, several counties removed from Lynn ccunty. We have no seloons 10 regular jail, no negros oi paupers, or any disorderly house of any kind. None of the houses in our town are vacant, and new ones are being erected all the time in spite of the dry times. We have pever had a murder or a suicide to mar our white escutcheon. Now we think we can trot in the front row without any question. If any organized county has a record to beat that


