LOOK OUT FOR THE CARS.

The Amarillo Herald says that the Santa Fe company has signed a contract to extend their line from Plainview to Lubbock; and the Fluvalia Herald says that the grade of the R. S & P. is nearly completed to that town and that steel for track-laying is already arriving at Snyder. We have no reason to believe that both of these reports are true and that sometime in the spring we will have a railroad station 28 miles to the north of us and another 45 miles to the east. This will make our shipping facilities at least 100 per cent better than at present. In the meantime, realty values in both towns are increasing by long jumps and the people of Lubbock have more money than they know what to do with.

But there is something else to tell. Neither of these roads will stay longer than two years at either of these two towns. Both will extend and will either build through Tahoka or several miles to one side or the other of the town. It will depend on the efforts put forth by our citizens which it will be. It is high time to get ready to handle a sure-enough railroad proposition.

ROCK ISLAND EXTENSION.

B. L. Winchell and party, of the Rock Island railroad, came in in their special car last Thursday night and after a brief conference with Mayor M. K. Graham, departed Friday morning for Throckmorton and from that place to Stamford. They gave out nothing definite in regard to the extension of the road from here, but from other sources we learn that it is the intention to start work in the near future, and that the road will be built from here to Throckmorton and from that place to Stamford or Haskell. This will run the road near Judge Arnold's coal and oil field in Sugar Hollow, crossing the river near the mouth of Whiskey creek, and is quite likely to make a good town there in case the oil field proves the success that many expect. In many ways the extension of the road will be a good thing for Graham. It will settle up the western part of the county; it will give our excellent flouring mill, our cotton mill,

ice-plant etc, more territory from which to draw trade and will induce many other industries to come here. Coal can be brought here at a very reasonable cost and in a matter of only a few more years Graham will be known as the leading manufacturing town of West Texas.—Graham Leader.

SANTA FE EXTENSION.

The announcement that the Santa Fe has entered into a contract with the citizens of Lubbock for the extension of that line from the present terminus at Plainview, construction of which is to begin at once, has revived belief that the time is near when the Santa Fe will begin the cut-off from a point on the line of the San Angelo branch to a connection at Plainview, this extension to Lubbock covering nearly fifty miles of the distance.

The public has been aware for a long time that the Santa Fe was looking favorably upon the plan to build this new line, which would give them a short line to California and other Pacific coast points, and decrease the haul from California to Gulf points many miles, and thus proportionately decrease the cost of hauling the tonnage on these long hauls.

President Rice, when he visited Texas some weeks ago, stated that it was the ultimate intention of the Santa Fe to make this extension, but that the condition of the money market following the money stringency of last year had operated to cause a postponement of all improvements contemplated, and a cessation of work on much that was under way.

The building of this line through the western part of the Panhandle country would open up a fertile country not now penetrated by any line of railroad, and would give to them an immense tonnage in freights without any competition.

Some discussion of the intention of the Santa Fe to begin work without delay on the line from Plainview to Lubbock was heard yesterday and many are inclined to believe that the work will not stop when the line reaches Lubbock, but that building will continue toward a connection with the San Angelo branch at some point not yet made known to the public.

This extension coupled with the several hundred thousand dollars of improvements to be made by the company in this city, including the enlarging of the yardage facilities, is taken to mean that the Santa Fe is to connect up the gap in the line to California without delay, and that Temple is to be largely benefitted by the increasing.—Temple Tribune.






